And whereas by Minute dated first day of December, 1932, the Minister of Commerce assigned certain powers and duties of the Ministry as in the Esquire, O.B.E., of the Ministry to be Registrar of Business Names for Northern Ireland for the purposes of the Registration of Business Names Act,

And whereas the said Walter Abbott is retiring from the service of the Ministry.

Now, therefore, I, the Right Honourable Sir Roland T. Nugent, D.L., Minister of Commerce for Northern Ireland, do by this Minute assign the powers and duties of the Ministry in connection with powers and duties of the Ministry in connection with the registration of Business Names under the said Act of 1916 to Joseph Edwards, Esquire, of the Ministry, with effect from the first day of August, 1945, and I appoint the said Joseph Edwards, to exercise and perform those powers and duties as from that date under the designation of Registrar of Business Names for Northern Ireland.
