Notice is hereby given that the Secretary of State in exercise of the powers conferred by Article 4(2)(a) of the Remand (Temporary Provisions) (Northern Ireland) Order 1980 has made an Order entitled The Remand (Temporary Provisions) (Northern Ireland) Order 1980 (Continuance) (No 2) Order 1980. (SR 1980 No 448).

This Order continues in force Article 3 of the Remand (Temporary Provisions) (Northern Ireland) Order 1980 for a period of one month beginning with 29th December 1980. That Article makes it unnecessary for an accused to be brought personally before a Magistrates' Court at the end of a period of remand in custody and enables a Magistrates' Court to extend a period of remand in the abscence of an Accused. Article 3 is currently in force by virtue of

the Remand (Temporary Provisions) (Northern Ireland) Order 1980 (Continuance) Order 1980.

NORTHERN IRELAND COURT SERVICE

Notice is hereby given that the Lord Chancellor, in pursuance of section 36(1)(b) of the Coroners Act (Northern Ireland) 1959, has made a Statutory Rule entitled the Coroners (Practice and Procedure) (Amendment) Rules (Northern Ireland) 1980. (SR 1980 No 444).

These rules which come into operation on 1st February 1980 amend the Coroners (Practice and Procedure) Rules (Northern Ireland) 1963. Rule 8 is amended to allow the coroner a wider discretion in deciding who shall give evidence at an inquest. Rule 9 extends the existing protection against self incrimination to the spouce of a witness. Rule 11 substitutes a new rule giving the coroner wider powers in relation to the adjournment and resumption of inquests and provides for the notices to be given in relation thereto. Rule 12 specifies additional circumstances in which the Superintendent may request an adjournment and extends the period of such adjournment. Rule 13 contains amendments consequential on the new rules 11 and 12(1). The proviso to rule 16 is revoked consequent on the new rule 23(2). Rule 17 gives the coroner power at his discretion to dispense with the attendance at an inquest of the maker of any document, or to adjourn the inquest to enable such maker to give oral evidence. The rules also contain further minor consequential amendments. The Third Schedule contains some minor amendments to Forms 2, 5, 14, 17 and 18, and for Form 20 substitutes Forms 20 and 20A in relation to the giving of the coroners' authority for cremation. Form 21 is amended to provide for the substitution of "Findings" on the "Coroners' Certificate" in place of "Verdict". A new Form 22 is substituted which is in line with Form 21 in relation to "Findings".

The Department of Finance has made an Order entitled Compulsory Acquisition (Interest) (No 4) Order (Northern Ireland) 1980 (SR 1980 No 461) which prescribes as from 26th January 1981 14½% per annum as the rate of interest on compensation monies payable in respect of land compulsorily acquired under certain enactments.

SOCIAL SECURITY (NORTHERN IRELAND) ACT 1975

Notice is hereby given that the Department of the Environment for Northern Ireland in exercise of the powers conferred on it by Section 19 of the Road Traffic Act (Northern Ireland) 1970 and of all other enabling powers made on 4th December 1980 an Order entitled Compulsory Right or Left-Hand Turn (Belfast) (Amendment) Order (Northern Ireland) 1980 (SR 1980 No 439) which will come into operation on 12th January 1981.

This Order amends the Compulsory Right or Left-Hand Turn (Belfast) Order (Northern Ireland) 1980 (SR 1980 No 114). It provides for a compulsory right hand turn from Little Patrick Street into York Street and for a compulsory left hand turn from Lancaster Street into York Street.

This Rule which comes into operation on 5th January 1981 amends the Motor Cycles (Protective Headgear) Regulations (Northern Ireland) 1980 (SR 1980 No 428) by correcting a printing error in regulation 4(2)(a) where the word "moving" should have read "moving".

extending from 31st December 1980 to 31st December 1981 the conditional exemption for certain operations for the transport of milk.

DEPARTMENT OF MANPOWER SERVICES

Notice is hereby given that in pursuance of powers conferred on it by Articles 70 and 80 (3) of the Industrial Relations (Northern Ireland) Order 1976 and Articles 5(5) and 63(4) of the Industrial Relations (No. 2) (Northern Ireland) Order 1976, the Department of Manpower Services has made an Order entitled the Industrial Relations (Variation of Limits) Order (Northern Ireland) 1981 (SR 1981 No 1).

This Order, which comes into operation on 1st February 1981 varies certain of the limits under the Contracts of Employment and Redundancy Payments 'Act (Northern Ireland) 1965 ("the Act of 1965"), the Industrial Relations (Northern Ireland) Order 1976 ("the No 1 Order), and the Industrial Relations (No 2) (Northern Ireland) Order 1976 ("the No 2 Order"). The limit on the amount of "a week's pay." for the purposes of calculating a redundancy payment under the Act of 1965 and the basic and additional awards of compensation for unfair dismissal under the No 1 Order is increased from £120 to £130. The limit on the amount for the purpose of calculating the sum payable by the Department under Article 42 of the No 1 Order in respect of debts due to an employee whose employer becomes insolvent is likewise increased from £120 to £130. The limit on the amount of a Guarantee Payment payable under Article 5(1) of the No 2 Order in respect of any day is increased from £8.00 to £8.75.

THE APPROPRIATION (No 3) (NI) ORDER 1980 No 1957 (NI 15) PRICE £1.10p

This Order authorised the issue of a further sum out of the Consolidated Fund of Northern Ireland for the service of the year ending on 31st March 1981 and appropriates that sum for specified services in Northern Ireland. It also authorises the application of certain further sums as appropriations in aid and reduces seven sums already authorised to be applied as appropriations in aid. In addition, the Order repeals certain spent enactments.

THE EDUCATION (NI) ORDER 1980 No 1958 (NI 16) PRICE £1.10p

This Order grants Education and Library Boards a discretion in the provision of education for children under the age of five years (Article 3) and removes certain supervisory powers of the Department of Education by

virtue of which the Department has to approve or authorise what the Education and Library Boards do (Articles 4 to 6).

It also makes a number of miscellaneous amendments including the repeal of certain enactments, enables students' awards to be paid to persons other than the student, requires Education and Library Boards to provide books, and materials free of charge to certain pupils at controlled grammar schools, amends the law on teachers' salaries, in particular permitting regulations to contain provision for the determination of matters by the Department and repeals certain nineteenth century enactments which are unnecessary.

THE FINANCIAL PROVISIONS (NI) ORDER 1980 No 1959 (NI 17) PRICE £1.10p

This Order:

- (a) increases the limits on sums which may be issued out of the Consolidated Fund of Northern Ireland for certain purposes;
- (b) increases the limits on grants and loans on capital works in relation to harbours;

- (c) increases the financial limits of the Northern Ireland Development Agency;
- (d) provides for remuneration for a whole-time president or chairman of Industrial Tribunals;
- (e) provides for pensions for whole-time chairmen of Industrial Tribunals;
- (f) provides for pensions, etc, for persons serving parttime in the Northern Ireland Electricity Service.

THE NORTHERN IRELAND (EMERGENCY PRO-VISIONS) ACT 1978 (CONTINUANCE) (No 2) ORDER 1980 No 1938 PRICE 30p

This Order continues in force the temporary provisions of the Northern Ireland (Emergency Provisions) Act 1978, except section 12 and Schedule 1 (which relate to the detention of terrorists), for a period of six months beginning with 25th Ianuary, 1981. These provisions are currently in force by virtue of the Northern Ireland (Emergency Provisions) Act 1978 (Continuance) Order 1980 (S.I. 1980/1049).
