MARKETING OF MILK PRODUCTS (AMENDMENT) REGULATIONS (NORTHERN IRELAND) 1981

Notice is hereby given that the Department of Agriculture for Northern Ireland, in exercise of the powers conferred on it by Sections 5(1), 7, 10 and 15 of the Marketing of Milk Products Act (Northern Ireland) 1958 and of every other power enabling it in that behalf, and with the concurrence of the Department of Health and Social Services insofar as they relate to the direct injection method of manufacturing ultra-heat treated cream, made on 10th July, 1981 the Marketing of Milk Products (Amendment) Regulations (Northern Ireland) 1981. (S.R. 1981 No. 233).

MILK REGULATIONS (NORTHERN IRELAND 1981

These Regulations consolidate the Milk Regulations (Northern Ireland) 1963 as amended. They control the methods of production of milk for sale and the heat treatment, packaging, storage, transport and distribution of milk for liquid consumption.

They also amend the existing Regulations by:

(a) permitting the sale in Northern Ireland of ultra-heat treated milk, ultra-heat treated semi-skimmed milk; ultra-heat treated skimmed milk, ultra-heat treated flavoured milk and pasteurised flavoured milk, provided such milk has been produced, heat-treated, packaged, flavoured, transported and stored in accordance with requirements specified in the Regulations;

- (b) requiring producers who store their milk in tanks to maintain their milk at a temperature of not more than 5°C;
- (c) revoking a low temperature method of pasteurising milk and introducing a maximum temperature for the higher temperature method;
- (d) setting standards and tests for the hygiene of milk cans and milk tankers;
- (e) prescribing the maximum temperatures at which milk may be stored.

- (b) awards by the Department for teacher training courses and for long-term residential courses of fulltime education for adults at specified colleges.

The Rule replaces, with amendments, the Students Awards Regulations (Northern Ireland) 1980 and the Students Awards (Amendment) Regulations (Northern Ireland) 1980. It sets out the amounts, terms and conditions of awards and comes into operation on 1st September 1981.

DEPARTMENT OF THE ENVIRONMENT

Notice is hereby given that the Department of the Environment by virtue of the powers conferred on it by the Roads (Northern Ireland) Order 1980 has made an Order dated 21st July 1981, entitled Roddens Court, Larne (Stopping-Up) Order (Northern Ireland) 1981 (S.R. No. 247) which will come into operation on 1st September, 1981.

The Department of the Environment has made a Statutory Rule under Article 3 of the Road Races (Northern Irelaud) Order 1977 entitled Road Races (Carrowdore) Order (Northern Ireland) 1981 (S.R. 1981 No. 235).

This Order permits the Belfast and District Motor Club Limited, as promoter of the Carrowdore Motor Cycle Race, to use for that race certain roads by suspending the right of way of other traffic on 5th September 1981, from 12.00 noon to 6.30 p.m. In effect this Order temporarily closes certain roads.

Notice is hereby given that the Department of the Environment for Northern Ireland in exercise of the powers conferred on it by Article 25 of the Road Traffic (Northern Ireland) Order 1981 and of all other enabling powers made on 21st July 1981 an Order entitled Restriction of Traffic (Duglen Road, Co. Down, Order (Northern Ireland) 1981 (S.R. 1981 No. 248) which will come into operation on 1st September, 1981.

The purpose of the Order is to prohibit vehicles from using that length of Duglen Road, Route DR130, Co. Down (known locally as Mountain Road) from its junction with Route C293 (known locally as Drumkeeragh Road) to its junction with Route C376 (known locally as Drumnaquoile Road) for a period of 6 months from 31st August 1981.

Copies of the Order may be obtained on request from the offices of the Department of the Environment, Roads Service Headquarters, Commonwealth House, 35 Castle Street, Belfast or of the Department's Roads Service Division, English Street, Downpatrick, Co. Down.

The Department of the Environment has made a Statutory Rule entitled the Motor Vehicles (Driving Licences) Regulations (N.I.) 1981 - S.R. 1981 No. 239.

These Regulations which come into operation on 17th August, 1981, consolidate with amendments, the Motor Vehicles (Driving Licences) Regulations (Northern Ireland) 1965 as variously amended. They deal with the grant of driving licences, driving tests and other associated matters.

The effect of the principal amendments is as follows:

The age at which a person may drive a small passenger vehicle or small goods vehicle is reduced from 17 to 16 in a case where that person is receiving a mobility allowance.

The age at which a person may drive a heavy goods vehicle is reduced from 21 to 18 in a case where that person is participating in, and conforming to the requirements of, the Training Scheme which has been established by the Training Committee with the approval of the Department. The definition of "qualified driver" is extended to enable the holder of a driving licence authorising him to drive motor cars as a driving licence holder with a disability affecting only his legs or feet to act as the supervisor of a provisional licence holder driving any motor car of the same group. Although the disabled driver's driving licence authorises him to drive motor cars of a particular construction or design only.

A liability to sudden attacks of disabling giddiness or fainting caused by a heart disorder, where the person concerned has implanted in his body a heart-regulating device designed to correct the disorder, is a disability which operates as a bar to holding a licence unless the person concerned satisfies certain conditions.

The weight limit for motor tricycles in group C is increased from 410 kilograms unladen weight.

Provision is made for a person who has recently become resident in Northern Ireland to drive for one year after becoming resident if he holds a valid foreign domestic driving licence, an international driving permit or a British Forces (Germany) driving licence without taking out a provisional licence.

The Department of the Environment has made a Statutory Rule entitled Heavy Goods Vehicles (Drivers' Licences) Regulations (Northern Ireland) 1981 - S.R. 1981 No. 240. This rule which comes into operation on 17th August, 1981 consolidates, with further amendments, the Heavy Goods Vehicles (Drivers' Licences) Regulations (Northern Ireland) 1970 as variously amended ("the 1970 Regulations"). The effect of the principal amendments is as follows:

1. Provision is made as required by Council Directive 76/914/EEC for the grant of heavy goods vehicle (hgv) trainee driver's licences to persons between the ages of 18 and 21 who are undergoing, or are to undergo, training in the driving of heavy goods vehicles of classes 1. 1A, 2, 2A, 3 or 3A in accordance with the terms of the Training Scheme established by the Northern Ireland Joint Training Committee for Young HGV Drivers in the Road Goods Transport Industry in Northern Ireland and set out in the Scheme for the Training of Persons Under 21 as Drivers of Heavy Goods Vehicles approved by the Department.

2. The provision in Regulation 4(c) of the 1970 Regulations as amended, for minimum ages for qualifying to apply for hgv drivers' licences, is omitted because that provision duplicated Article 4(1) of the Road Traffic (Northern Ireland) Order 1981 ("the Order") as modified by Regulation 4 of the Motor Vehicles (Driving Licences) Regulations (Northern Ireland) 1981 S.R. 1981 No. 239).

The requirements as to minimum ages of the said Article 4 or the corresponding Great Britain provision are applied to applicants for hgy drivers' licences in these Regulations by the requirement:

- (a) that the applicant must not be disqualified by reason of his age in respect of any vehicle in the class of heavy goods vehicles to which the licence is to relate, and
- (b) that the applicant must hold an ordinary driving licence or the equivalent Great Britain licence authorising him to drive a vehicle or vehicles in-the class of heavy goods vehicles to which the licence is to relate.

The fees payable for the grant of hgv drivers' licences and the fee payable by a person who applies for a heavy goods vehicle driving test are increased as follows:

- (i) for a full hgv driver's licence from £3 to £4.60 and for a provisional hgv driver's licence from £1.50 to £2.30.
- (ii) for a heavy goods vehicle driving test from £30 to £44.

4. New provision is made:

- (a) to take account of the issue of hgv drivers' licences which, in consequence of paragraph 3 of Schedule 6 to the Order, are restricted to vehicles not exceeding 10 metric tons permissible maximum weight (as defined in Article 19 of the Order) in class 3 or 3A, and
- (b) to apply a similar restriction to renewals of such licences and to hgv drivers' licences issued to holders of ordinary driving licences which are restricted to vehicles not exceeding 10 metric tons permissible maximum weight under paragraph 2 of Schedule 6 to the Order, while they are under 21 years of age.

5. New exemptions from heavy goods vehicle licensing are introduced as follows:

- The exemption in Regulation 23(1) (q) of the 1970 Regulations for any articulated vehicle combination the tractive unit of which does not exceed 15 cwt. (a) unladen weight, is preserved, together with:
- (i) any articulated vehicle combination which has a permissible weight not exceeding 7.5 metric tons, and
- (ii) any vehicle having a relevant maximum weight (as defined in Article 19 of the Order) not exceeding 3.5 metric tons to which a trailer is attached, which is not an articulated vehicle combination.
- (b) The exemption in Regulation 23(1) (u) of the 1970 Regulations for play-buses (as defined in paragraph 3(a) of that Regulation) is extended to passenger Statistics adapted to carry goods or burden of any description when used in similar circumstances in connection with the mounting of a display or exhib-ition. The requirement in the 1970 Regulations that the vehicle should be owned by a person or body of persons who carry on the activity and whose activities are are carried on otherwise than in the course of a trade or business conducted with a view to profit, and that any passengers carried should be of full age, is removed.
