THE SHEEP ANNUAL PREMIUM (AMENDMENT No. 2)
REGULATIONS (NORTHERN IRELAND) 1990

Notice is hereby given that the Department of Agriculture for Northern Ireland in exercise of the powers conferred on it by Section 2(2) of the European Communities Act 1972 and of all other powers enabling it in that behalf has made Regulations entitled The Sheep Annual (Amendment No. 2) Regulations (Northern Ireland) 1990 (SR 1990 No. 444). The Regulations come into operation on 15th January, 1991.

These regulations amend the Sheep Annual Premium Regulations (Northern Ireland) 1987 ("the principal Regulations"). The principal Regulations implement Commission Regulation (EEC) No. 3007/84 as amended by Commission Regulation (EEC) No. 3378/85 and Commission Regulation (EEC) No. 3984/89 which lays down detailed rules for the application for payment of a sheep annual premium to sheepmeat producers. The principal Regulations specify that application for premium in respect of a marketing year must reach the Department of Agriculture between the 15th of January in the calendar year in which the marketing year commences and the 14th of February of that calendar year. These regulations amend the principal Regulations to specify that applications for premium in respect of a marketing year must reach the Department of Agriculture between the 28th of January in the calendar year in which the marketing year commences and the 27th of February in that calendar year.

THE OMAGH-ENNISKILLEN TRUNK ROAD TIO

Mossfield Junction - Townland of Mossfield, Co. Fermanagh

The Department of the Environment for Northern Ireland hereby gives notice in accordance with the provisions of Schedule 6 to the Roads (Northern Ireland) Order 1980 that it proposes to make an Order under Articles 13 and 40 of the Order.

The general purpose of the Order will be:

- to provide that a new road extending approximately 200 metres from a point on the Trunk Road T10 approximately 130 metres north-east of the existing junction with the B46 Ballinamallard Road extending in a south-westerly direction to a point on the Trunk Road T10 approximately 90 metres south-west of the aforesaid junction in the townland of Mossfield, Co. Fermanagh shall become part of Trunk Road T10;
- to provide that approximately 165 metres of the present trunk road which will be superseded by the new road will cease to be part of the trunk road; and
- to provide for the stopping-up of parts of the undermentioned roads:
 - (a) Trunk Road T10 (A32 Enniskillen-Irvinestown Road)
 - (b) B46 Ballinamallard Road.

The Department also proposes to construct a road to connect B46 Ballinamallard Road to the new road.

THE PLANNING (NORTHERN IRELAND) ORDER 1972

Notice of Making an Order Extinguishing the Right to Use Vehicles on Berry Street / New Link Road in the City of Belfast

Notice is hereby given that the Department of the Environment on 10th December, 1990, made an order under Article 77 of the Planning (Northern Ireland) Order 1972, the effect of which is to extinguish the right to use vehicles on the roads specified below in the City of Belfast for the purpose of improving the amenity of the area and facilitating the movement of pedestrian traffic. The order is entitled the Extinguishment of Right to Use Vehicles on Roads (Berry Street / New Link Road, Belfast) Order (Northern Ireland) 1990 and comes into effect on 1st February, 1991.

The general effect of the proposed order is to exclude vehicular traffic (with certain exceptions listed below from Berry Street / New Link Road).

The exceptions referred to are vehicles being used as follows:

- (a) A vehicle the driver of which is acting upon the direction or with the permission of a constable in uniform or of a traffic warden.
- (b) Vehicles used for police, ambulance or fire brigade purposes or in an emergency by a medical practitioner.
- (c) Vehicles used on behalf of a Government Department, district council or statutory undertaken in pursuance of statutory powers and duties.
- (d) Vehicles used for the conveyance of goods to or from premises situated on or adjacent to the roads described between the hours of 18.00 and 11.00 where the goods by reason of their size or weight could not reasonably be conveyed to or from such premises otherwise than by means of a vehicle and provided always that such vehicles shall not be permitted to use such roads for any longer period than may be necessary for the conveyance of these goods.
- (e) Vehicles used in accordance with special authorisation given by an authorised officer of the Department of the Environment for Northern Ireland.
- (f) Vehicles used for access to church property in connection with a church function.

The roads affected are delineated on map number BEP/11 entitled "Extinguishment of Right to use Vehicles on Roads (Berry Street / New Link Road) Order (Northern Ireland) 1990 which together with copies of the Order may be inspected free of charge by any person at all reasonable hours at the offices of the Department, Room 406, Clarendon House, 9-21 Adelaide Street, Belfast BT2 8NR.
