1000 litres or thereabouts of hydrocarbon oil and one Ford Transit Van registration number DDZ 4607, at Ballyclare, Co. Antrim.

Pursuant to Section 139(6) of the Customs and Excise Management Act 1979 and paragraph (1) of the Schedule 3 thereto, the Commissioners of Customs and Excise hereby give you notice that, by virtue of the powers contained in the Customs and Excise Management Act 1979 and enactments amending that Act, the aforesaid goods have been seized as liable to forfeiture upon the grounds that:

[a] The quantity of hydrocarbon oil is goods chargeable on their importation with excise duty.

[b] The van being used in connection with goods liable to forfeiture. Whereby and by force of Section 49[1][a], Section 141[1][a] of the

Armagh Area Plan 2018 Notice of Intention to Prepare a Development Plan



The Planning Service, an Agency within the Department of the Environment, intends to prepare a development plan under the provision of Part III of the Planning (Northern Ireland) Order 1991 for the area comprising Armagh City and District Council area.

The Plan will be prepared within the context of the Regional Development Strategy. It will inform the general public, statutory authorities, developers and other interested bodies of the policy framework and land use proposals that will be used to guide development and the use of land within the Council area up to the year 2018.

The Plan will focus on a number of issues including: the zoning of land for particular forms of development such as housing, industry and recreation; designations relating to regional policies such as Green Belts; committed public sector proposals and designations of other site specific areas to which local policies will apply, such as local landscape policy areas.

The Department will consult the local council, Government Departments, statutory undertakers, other appropriate bodies and interested parties in the preparation of the Plan.

The Department wishes to ensure that members of the public have the opportunity to participate at this initial key stage in the Plan making process by contributing to the formulation of the key issues which the Plan should consider.

Environmental Protection *Department of the Environment*

The Department of the Environment has made a Statutory Rule entitled "The Genetically Modified Organisms (Deliberate Release) Regulations (Northern Ireland) 2003" (S.R. 2003) No. 167).

The Rule comes into operation on 15th April, 2003.

The rule, which is made under powers conferred by section 2(2) of the European Communities Act 1972, transposes into Northern Ireland legislation the requirements of EC Directive 2001/18/EC concerning the deliberate release of genetically modified organisms into the environment. The Rule tightens many of the core elements of the previous measures, and responds to public concerns about the protection of human health and the environment by strengthening the existing regime, particularly in respect of post marketing monitoring.

The Department of the Environment has made a Statutory Rule entitled The Environmental Protection (Controls on Ozone Depleting Substances) Regulations (Northern Ireland) 2003 (S.R. 2003 No. 97). The Rule comes into operation on 28th March, 2003.

The Rule makes provision in relation to Council Regulation (EC) No. 2037/2000 on substances that deplete the ozone layer, as amended by Council Regulations (EC) 2038/2000 and 2039/2000, (referred to in these Regulations and the following paragraphs of this Notice as "the principal Regulation").

The principal Regulation provides for a system that controls -

- (a) the production, placing on the market and use of,
- (b) trade in, and
- (c) emission of

certain substances ("controlled substances") that deplete the ozone layer. Member States are required to deal with a number of matters by means of their domestic legislation. With the exception of regulation 5, this Rule fulfils this requirement.

In particular, it -

 (i) designates the Department of the Environment as the competent authority for the purposes of the principal Regulation that refer to the competent authority of a Member State (regulation 3);

- (ii) requires persons having control of the controlled substances mentioned in Articles 16 and 17 of the principal Regulation to comply with those provisions (regulation 4),
- (iii) contains enforcement powers (regulation 6), and
- (iv) sets out offences and penalties in relation to failures to comply with the principal Regulation or the Rule (regulations 7 to 9 and the Schedule).

Parts I, II and III of the Schedule give effect to Article 21 of the principal Regulation in relation to breaches of Articles 3, 4 and 5, respectively. Part IV of the Schedule gives effect to Article 21 in relation to breaches of so much of Article 22 as relates to the production, placing on the market and use of new substances.

Contraventions of the prohibitions imposed by Article 11 (export of controlled substances or products containing controlled substances) are enforceable under section 68 of the Customs and Excise Management Act 1979.

Regulation 5 enables customs officers to require proof of lawful export, and to detain controlled substances, products and equipment until such proof has been furnished. In the absence of such proof, the substance, product or equipment is liable of forfeiture.

- (2) This Scheme shall be read as one with the Successor Postal Services Company Overseas Parcel Post Scheme 2001^(c) (hereinafter called "the Scheme"), as amended by the Consignia plc Overseas Parcel Post (Amendment No. 1) Scheme 2001^(d) the Consignia plc Overseas Parcel Post (Amendment No. 2) Scheme 2001,^(e) the Consignia plc Overseas Parcel Post (Amendment No. 3) Scheme 2002^(f), the Consignia plc Overseas Parcel Post (Amendment No. 4) Scheme 2002^(g) and the Royal Mail Group plc Overseas Parcel Post (Amendment No. 5) Scheme 2003^(h).

Working Time (Amendment) Regulations (Northern Ireland) 2003 (S.R. No. 119)

Notice is hereby given that the Department for Employment and Learning, being a Department designated for the purposes of section 2(2) of the European Communities Act 1972 in relation to the organisation of working time, in exercise of the powers conferred on it by the said section 2(2), and of every other power enabling it in that behalf, has made a statutory rule entitled the Working Time (Amendment) Regulations (Northern Ireland) 2003 (S.R. No. 119). These Regulations amend provisions of the Working Time Regulations (Northern Ireland) 1998, primarily in order to implement certain

These Regulations amend provisions of the Working Time Regulations (Northern Ireland) 1998, primarily in order to implement certain provisions of Council Directive 94/33/EC on the protection of young people at work (O.J. No. L216, 20.8.94 p.12). The provisions in question restrict the working time of adolescents – those aged between 15 and 18 who are over compulsory school age, referred to as 'young workers' – and the circumstances in which they may work during night-time.

Regulation 7 inserts a new regulation 5A into the 1998 Regulations, limiting the working time of young workers to 8 hours a day and 40 hours a week and requiring employers to ensure that these limits are complied with. Regulation 9 inserts a new regulation 6A, which requires employers to ensure that no young worker works during a restricted period. This is defined in an amendment provided for in regulation 4 as the period between 10.00 pm and 6.00 am, or, in a case where the worker is contracted to work after 10.00 pm, the period between 11.00 pm and 7.00 am. Regulations 5 and 10 make consequential changes.

The new working time and night working restrictions are subject to various exceptions, relating to particular occupations and particular circumstances, provided for in amendments to the 1998 Regulations set out in regulations 11-19; there is an entitlement to compensatory rest where the night work restrictions are excluded. Regulation 20 makes the obligations on employers 'relevant requirements' for the purposes of the 1998 Regulations; the effect of this is that the obligations are enforceable by the Health and Safety Executive and that failure to comply is an offence. Regulation 21 makes an employer's refusal to permit a young worker to exercise the entitlement to compensatory rest a matter that may be the subject of a complaint to an industrial tribunal. The Regulations also include two amendments to the 1998 Regulations that are unrelated to Council Directive 94/33/EC. Regulation 6 amends the definition of "excluded days", a term used in the formula for calculating a worker's average weekly working time, so as to include periods of paternity, adoption or parental leave. Regulation 8 revokes a provision excluding overtime from the calculation of a night worker's normal hours of work in certain cases.

The Regulations come into operation on 6th April, 2003.
