Prison and Young Offenders Centre (Amendment) Rules (Northern Ireland) 2005 – SR 2005 No.153

Rule 2, the remaining provisions of rule 3 and rules 4 to 7 of this instrument - which *inter alia* introduces a new prisoner complaints system in line with the operation of the Prison Ombudsman for Northern Ireland - will come into operation on 3 May 2005.
