- Notice of Intention to Prepare a Subject Plan

The Planning Service, an Agency within the Department of the Environment, intends to prepare a Subject Plan under the provisions of Part III of the Planning (Northern Ireland) Order 1991 relating to Houses in Multiple Occupation (HMOs) for Coleraine Borough Council Area. The Coleraine Borough HMOs Subject Plan 2016 is to be prepared in addition to the ongoing Northern Area Plan 2016, which was published in draft form in May 2005. It will be prepared within the context of the Regional Development Strategy and will inform the general public, statutory authorities, developers and other interested bodies of the policy framework and proposals that will be used to guide development decisions relating to HMOs in Coleraine Borough Council area. The Department will consult with Coleraine Borough Council, Government Departments, statutory undertakers, other appropriate

bodies and interested parties in the preparation of the Subject Plan. It also intends to publish an Issues Paper, in April 2006, which will help to guide and encourage debate and discussion focused on issues of relevance to the Plan. A further press notice in regard to the availability of the Issues Paper will follow.

The Department wishes to ensure that members of the public have the opportunity to participate in the plan making process by contributing to the consideration of the key issues in relation to the planning control of HMOs within the Coleraine Borough Council area.

Accordingly, following publication of the Issues Paper, there will be a 14 week period, starting with the date of publication, within which representations on key issues can be submitted in writing to the address below.

It should be noted that all representations received will be available for public inspection during the plan preparation process.

These Orders shall come into effect on 11th April 2006.

The areas designated as Air quality Management Areas (designated areas) are displayed in map form and can be viewed by visiting the Public Display at the Council Offices, Monaghan Row, Newry, from the 1st March 2006 to 11th April 2006.

The designated areas incorporate residential properties abutting the following roads:

- (i) Canal Street
- (ii) Water Street, Lower Water Street and North Street
- (iii) Bridge Street and Basin View Terrace
- (iv) St Mary Street
- (v) Kilmorey street and River Street

The areas are designated in relation to a likely breach of the Particulate Matter (PM 10) (daily mean) objective and nitrogen dioxide (annual mean) objective as specified in the Air Quality Regulations (Northern Ireland) 2003.

These Orders shall remain in force until they are varied or revoked by a subsequent order.

ANNUAL MAINTENANCE OF WATERCOURSES 2006/2007

The Department of Agriculture and Rural Development for Northern Ireland hereby gives Notice, in pursuance of regulation 6 (1) of the Drainage (Environmental Impact Assessment) Regulations (Northern Ireland) 2001 of proposed routine maintenance works on the main watercourses listed at A below, on minor watercourses in the catchments listed at B below and on urban watercourses in the catchments listed at C below.

Further details of the locations along the rivers concerned are available by contacting Rivers Agency HQ Office at the address below.

The Work may include the following: -

1. Necessary removal of channel silt and/or aquatic weed growth.
2. Removal of obstructions from the channel which restrict the free flow of water.

3. General maintenance (which may include upgrade or replacement if necessary) of grilles, culverts, manholes, flap-valves and quays.
4. Construction, repair or protection of flood defences, revetments and watercourse structures.
5. Measures for the protection or rehabilitation of fishery, conservation or other interests.

The Department will carry out the work using environmentally sensitive river engineering techniques.

The Department reserves the right to alter the maintenance programme if required.

Having determined that the proposed works are not, by reason amongst other things of their nature, size or location, likely to have significant environmental effects it is the Department's intention not to prepare an Environmental Statement.

In accordance with Regulation 6 (1) of the Regulations representations may be made in writing to the Department at the address given below, with regard to its intention not to prepare an Environmental Statement. The closing date for receipt of representations is **31 March 2006**.

The Department will consult with Conservation and Fisheries organisations on the works programme.
