Castlederg No. 1 Smoke Control Order 2006

Newtownstewart No. 1 Smoke Control Order 2006

Strabane No. 1 Smoke Control Order 2006

1. Notice is hereby given that the Strabane District Council in exercise of powers conferred on them by Article 17 of the Clean Air (NI) Order 1981 on the 14th February 2006 made Orders entitled the Castlederg No.1 Smoke Control Order 2006, the Newtownstewart No.1 Smoke Control Order 2006 and the Strabane No. 1 Smoke Control Order 2006, declaring the areas described in the schedule hereto to be smoke control areas, which Orders are about to be submitted to the Department of the Environment for confirmation.
2. Subject to the exemptions provided by virtue of Articles 17 and 25 of the Clean Air (Northern Ireland) Order 1981, if, on any date after the Orders have come into operation, smoke is emitted from a

chimney of any building within the smoke control areas the occupier of that building shall be guilty of an offence and liable to a fine not exceeding Level 3 on the Standard Scale (currently £1000) unless he proves that the emission of smoke was not caused by the use of any fuel other than an authorised fuel. The authorised fuels include, anthracite, coke and other carbonised fuels, gas and electricity.

3. Copies of the Smoke Control Orders and the maps referred to therein may be inspected free of charge at the Council Offices, 47 Derry Road, Strabane, during the period of six weeks from 9th March 2006.
4. Within the said period any person who will be affected by the Smoke Control Orders may by notice in writing to Air and Environmental Quality, Environment & Heritage Service, Commonwealth House, 35 Castle Street, Belfast BT1 1GU, object to the confirmation of the Orders.

Castlederg

The designated area incorporates the area beginning at Eden Park to the east, continuing west along Lower Strabane Road to Cavan Road, crossing Kilclean Road and north to Stoney Heights on Castlefin Road, south towards Hospital Road and Southeast to Strabane Road.

Newtownstewart

The designated area incorporates the area beginning at Deerpark to the west on Baronscourt Road to Castle Brae in the east, south towards Moyle Road, east to Oldcastle Road and north to Deerpark.

Bin Mountain Wind Farm (NI) Limited, which is 100% owned by Airtricity Holdings (UK) Limited has applied to the Office for the Regulation of Electricity and Gas Northern Ireland for a licence to generate under Article 10 (1) (a) of the Electricity (NI) Order 1992 as amended by the Energy (Northern Ireland) Order 2003. Bin Mountain Wind Farm (NI) Limited, with a registered number of NI 48448 and a registered address of 50 Bedford Street, Belfast, BT2 7FW has a principal place of business at 6a Dublin Road, Omagh, BT78 1ES. The generating station will be fuelled by wind and is expected to have a commissioning date of 31st December 2006. The wind farm is to consist of six GE Wind Turbines with a capacity of 1.5MW each resulting in a maximum power of 9.0MW. Planning permission, with a reference number of J/2004/0295/F was issued on 17th February 2006. An application to NIE for grid connection was submitted on 24th October 2003. An application to DETI Northern Ireland for the consent required for construction, extension and operation of generating stations under Article 39 of the Electricity (Northern Ireland) Order 1992 was submitted in March 2006. Employment Rights (Increase of Limits) Order (Northern Ireland) 2006 S.R. 2006 No. 75

This Order increases, from 26th March 2006, the limits applying to certain awards of industrial tribunals, and other amounts payable under employment legislation, as specified in the Schedule to the Order. A new limit for unlawful inducement by employers to forego certain trade union rights has been set in this Order. Orders under Article 33(1) to (4) are required to change the limits by the amount by which the Retail Prices Index for the September immediately preceding the making of the Order is higher (or lower) than the index for the previous September. The increases made by this Order therefore reflect the increase in the index from September 2004 to September 2005.

Article 4 of the Order contains transitional provisions determining the circumstances in which the increased limits will apply.

The Order comes into operation on 26th March 2006.

Pneumoconiosis, etc., (Workers' Compensation) (Payment of Claims) (Amendment) Regulations (Northern Ireland) 2006 – S.R. 2006 No. 87

The Statutory Rule is entitled the Pneumoconiosis, etc., (Workers' Compensation) (Payment of Claims) (Amendment) Regulations (Northern Ireland) 2006 – S.R. 2006 No. 87.

The Regulations make technical amendments to the Pneumoconiosis, etc., (Workers' Compensation) (Payment of Claims) Regulations (Northern Ireland) 1988 so as to increase the amount of compensation payable to certain persons disabled by a disease to which the Order applies, or to dependants of persons who were so disabled immediately before they died. The increase in each case is 2.7 per cent, rounded up or down to the nearest £1 as appropriate.

The diseases to which the Order applies are pneumoconiosis, byssinosis, diffuse mesothelioma, primary carcinoma of the lung (where accompanied by asbestosis or diffuse pleural thickening) and diffuse pleural thickening.

The Regulations are subject to negative resolution at Westminster and will not come into operation until 16th April 2006.
