### PROHIBITION OF TRAFFIC ORDER

#### AVONIEL, BELFAST

The Department for Regional Development has made a Statutory Rule entitled The Prohibition of Traffic (Avoniel, Belfast) Order (Northern Ireland) 2011 (S.R. 2011 No. 359) which will come into operation on 3rd November 2011.

The purpose of the Order is to restrict the use of certain back streets in the Avoniel area of Belfast by vehicles and pedestrians. (4)

## EXTINGUISHMENT OF RIGHT TO USE VEHICLES ON ROADS (STRABANE) ORDER (NORTHERN IRELAND) 2011

The Department for Regional Development has made a Statutory Rule entitled The Extinguishment of Right to Use Vehicles on Roads (Strabane) Order (Northern Ireland) 2011 (S.R. 2011 No. 358), which comes into operation on 3rd November 2011.

The Rule will revoke The Extinguishment of Right to Use Vehicles on Roads (Strabane) Order (Northern Ireland) 1993 and re-enact the provisions applying to Abercorn Square and Railway Street, Strabane. Castle Street, Strabane will cease to be part of the pedestrian zone. (5)

#### PARKING PLACES ON ROADS ORDER CASTLECAULFIELD

The Department for Regional Development has made a Statutory Rule entitled The Parking Places on Roads (Castlecaulfield) Order (Northern Ireland) 2011 (S.R. 2011 No. 362) which will come into operation on 8th November 2011.

The purpose of the Order is to authorise the use as parking places, and to prescribe the conditions under which they may be used, of the following lengths of Main Street, Castlecaulfield:— (south-east side), from a point 107 metres north-east of its junction with Caufield Glen, for a distance of 33 metres in a north-easterly direction; and (north-west side), from a point 15 metres north-east of its junction with Frenchman's Lane, for a distance of 21 metres in a north-easterly direction. Between the hours of 9.00a.m. to 6.30p.m. on Monday to Saturday inclusive. Vehicles may be left for a period of 1 hour with return to a parking place prohibited until a period of 1 hour has expired. Vehicles are excepted from the conditions in certain circumstances.

#### TRUNK ROAD ORDER

## THE M1/TRUNK ROAD T3 (MOTORWAY SERVICE AREA) ORDER (NORTHERN IRELAND) 2011

#### THE CRIMINAL JUSTICE (NORTHERN IRELAND) ORDER 2008 (COMMENCEMENT NO. 7) ORDER 2011

The Department of Justice has made a Statutory Rule entitled "Criminal Justice (Northern Ireland) Order 2008 (Commencement No. 7) Order 2011" (S.R. 2011 No. 371)(C.27), which was made on 21 October 2011.

The Rule commences provisions for the Criminal Justice (Northern Ireland) Order 2008. It brings into force on 1 January 2012 provisions creating an alternative to committal to custody for fine default whereby, rather than offenders going to prison for non-payment of a fine, courts will be able to impose a community-based alternative (a Supervised Activity Order). This will be available in petty session districts which have been informed, by way of a court notice signed by the Minister of Justice, of the availability of the scheme.

## THE JUSTICE (2011 ACT) (COMMENCEMENT NO. 2) ORDER (NORTHERN IRELAND) 2011

The Department of Justice has made a Statutory Rule entitled "The Justice (2011 Act) (Commencement No. 2) Order (Northern Ireland) 2011" (S.R. 2011 No. 370) (C.26), which was made on 21 October 2011.

The Rule commences provisions for the Justice Act (Northern Ireland) 2011. It brings into force on 1 December 2011 a provision to allow a firearms dealer to vary a firearms certificate where the certificate holder replaces one firearm with another of the same type and calibre. It brings into force on 1 January 2012 special measures provisions to assist vulnerable and intimidated witnesses to give their best possible evidence in criminal proceedings. It also brings in on 1 January football banning orders to help prevent violence and disorder providing a power to ban attendance at regulated football matches in Northern Ireland. Finally it beings into force on 1 January a provision to allow magistrates' courts to consider applications for third party disclosure in respect any evidence that may be of use to a party to the proceedings in presenting their case.

#### THE LOCAL GOVERNMENT (RATES SUPPORT GRANT) REGULATIONS (NORTHERN IRELAND) 2011

The Department of the Environment has made a Statutory Rule entitled "The Local Government (Rates Support Grant) Regulations (Northern Ireland) 2011" (S.R. 2011 No.375), which comes into operation on 1 November 2011. The Rule was laid in draft before the Assembly on 19 September 2011, and approved by a resolution of the Assembly on 24 October 2011.

The Rule makes provision for the Department of the Environment, under section 27 of the Local Government Finance Act (Northern Ireland) 2011, using data based on the latest information available to it regarding the previous financial year, to determine by way of a formula the amount of rates support grant payable to district councils.
