## A PROCLAMATION

For appointing Saturday, 25th October, a Bank Holiday in the County of London.

EDWARD R. & I.

WE, considering that it is desirable that Saturday the twenty-fifth day of this instant October, being the occasion of Our Royal Progress through London, should be observed as a Close Holiday in all Banks throughout the County of London, and in pursuance of the provisions of "The Bank Holidays Act, 1871," Do hereby, by and with the advice of Our Privy Council, and in exercise of the powers conferred by the Act aforesaid, appoint Saturday the twenty-fifth day of this instant October, being the occasion of the said Royal Progress, as a special day to be observed as a Close Holiday in all Banks throughout the County of London, under and in accordance with the said Act, and We do, by this Our Royal Proclamation, command the said day to be so observed, and all Our loving subjects concerned to order themselves accordingly.

Given at Our Court at Buckingham Palace, this twentieth day of October, in the year of our Lord one thousand nine hundred and two, and in the second year of Our Reign.

GOD SAVE THE KING.

WAR OFFICE, October 17, 1902.

The King has been graciously pleased to grant special authority to Captain and Lieutenant-Colonel Francis Lambton, late Scots Fusilier Guards, to wear the Insignia of the Order of the Medjidieh, conferred upon him in the year 1858, by His Imperial Majesty the Sultan of Turkey, as a mark of approbation of his distinguished service during the War in the Crimea.
