The KING's Most Excellent Majesty in Council.

WHEREAS the Secretary for Scotland has, under the provisions of the Burial Grounds (Scotland) Act, 1855, made a Representation stating that he has received a copy of an Interlocutor by the Sheriff-Substitute of Lanarkshire at Hamilton, finding that the Churchyard of the Parish of East Kilbride, in the County of Lanark, is in a condition which is offensive and contrary to decency:

And whereas in the said Representation it is recommended that the said Churchyard should be closed under the following reservations and conditions, viz.:-([.) In regard to the two portions of ground extending to about seven falls which are known as "the Common Ground," and are marked Nos. 453 and 454, and coloured pink on the plan, signed by the Secretary for Scotland, and deposited with the Sheriff-Clerk of the County of Lanark at his Office at Hamilton, a reservation to the right of interment in favour of surviving spouses in lairs where their predeceasing spouses have been buried and there is room for their interment; (II.) in regard to the remainder of the Burial Ground a reservation of the right of interment in favour of (1) surviving spouses and the unmarried members of families resident in the Parish in their family lairs; (2) Patrick Graham, of Killochside, for himself and such of his children as may die unmarried wherever they may be at the dates of their respective deaths, in lairs Nos.

265 and 169; (3) the present generation of the valued Rent Heritors of the Parish, conform to list No. 5 of the process, and their spouses and the numerical members of their families who may die in the Parish or within one year of leaving it in their family lairs.

Under the condition as regards all such interments that there is room in the lairs, and further that all such interments should not be injurious to public health or offensive or contrary to decency, and that notice be given to the Sanitary Inspector on the day preceding that on which a grave is to be opened, and that no interment shall be made unless the coffin can be laid at a depth of four feet from the surface of the ground to the upper side of the coffin, and that without the exposure of another coffin.

Now, therefore, His Majesty in Council is pleased to give notice of such Representation, and to order that the same be taken into consideration by a Committee of His Majesty's Most Honourable Privy Council on the 8th day of May next:

And His Majesty is further pleased to direct that this Order, or notice thereof, be published in the Edinburgh Gazette, and that copies of this Order, or notice thereof, be affixed, as required by the above-mentioned Act, on the doors of the Church of, or on some other conspicuous places within, the Parish affected by such Representation one month before such Representation is so considered.

SUBURBAN ELECTRIC EDINBURGH TRAMWAYS.

(Incorporation of Company; Construction of Tramways in the County of Midlothian; Street and Road widenings and works; Compulsory purchase of lands, &c.; Part purchase of Properties; Interference with streets, roads, &c.; Electrical or other motive power; Generating Stations; Gauge; Posts; Overhead Wires; Tolls; Powers to deviate Works, remove Trees, erect Waiting-rooms, and to apply for and take transfers of Electric Lighting Orders; To provide and run Omnibuses and Motor Cars; Agreements with Local Authorities, Bodies and Persons; Amendment or Repeal of all or some of the Provisions of the Tramways Act, 1870; Bye-Laws and Regulations; Incorporation, Amendment, Application or Repeal of Acts and Orders; Other Powers and Purposes.)

OTICE is hereby given that application is intended to be made by Petition to the Secretary for Scotland under and in pursuance of the Private Legislation Procedure (Scotland) Act, 1899, in the month of April 1905, for a Provisional Order (hereinafter called "the Order ") for the following, or some of the following amongst other purposes (that is to say)-

1. To incorporate a Company (hereinafter called "the Company") and to authorise the Company to make, form, lay down, maintain, work, and use all or some of the tramways and other works hereinafter described, with all necessary and proper rails, plates, foundations, sleepers, embankments, cuttings, platforms, channels, junctions, turntables, turnouts, crossings, passing-places, crossovers, triangles, pillars,

posts, poles, brackets, wires. cables, tubes, conduits, street boxes, engines, approaches, sidings, buildings, generating, transforming, and other stations, depots, waiting-rooms, stables, carriage-houses, engine-houses, sheds, buildings, apparatus, machinery, appliances, works, and conveniences connected therewith respectively.

(Where in the description of any of the tramways or street works any distance is given with reference to any street or road which intersects or joins the street or road in which the tramway or street work is to be laid or made, the distance is to be taken as measured from the point at which lines drawn along the centres of the two streets or roads would, if produced, intersect each other, and all distances and lengths given are to be read as if the words " or thereabouts " had been inserted after each such distance or length.)

The tramways proposed to be authorised will be wholly situate in the County of Mid-

lothian, and are as follows :-

TRAMWAY No. 1.—Commencing in the Parish of Liberton, in the Edinburgh and Dalkeith Road at Nether Liberton at a point 20 yards measured in a south-easterly direction from the centre of Craigmillar Park at its junction with the Edinburgh and Dalkeith Road, and passing thence in a south-easterly direction along that road through Northfield and Greenend to and along Drum Street (Gilmerton) to and in a south-easterly direction along, and terminating in the said Edinburgh and Dalkeith Road in the Parish and Burgh of Dalkeith at a point 140 yards measured in a south-easterly direction from the centre of the bridge carrying that road over the main line of the North British Railway Company between Edinburgh and Carlisle.

Tramway No. 2.—Commencing in the Parish and Burgh of Dalkeith by a junction with Tramway No. 1 at its termination, passing thence in a south-easterly direction along the Edinburgh and Dalkeith Road to and in a south-westerly direction along the road in the Parish of Lasswade leading from Eskbank to Bonnyrigg to and along Lothian Street in the Parishes of Lasswade and Cockpen in the Burgh of Bonnyrigg to and in a north-westerly direction along and terminating in High Street in the Parish of Cockpen, in the Burgh of Bonnyrigg, at the boundary between that Burgh and the Burgh of Lasswade.

TRAMWAY No. 2A.—Wholly in the Parish and Burgh of Dalkeith, commencing by a junction with Tramway No. 2 in Eskbank Road at a point 125 yards measured in a north-easterly direction from the centre of the entrance to the Union Poorhouse, passing thence in a northeasterly direction, and terminating by a junction with Tramway No. 3 hereinafter described, in Eskbank Road at a point 210 yards measured in a south-westerly direction from the junction of that road with Waverley Road.

TRAMWAY No. 3.—Wholly in the Parish and Burgh of Dalkeith, commencing by a junction with Tramway No. 2 in the Edinburgh and Dalkeith Road at a point 185 yards measured in a south-easterly direction from the centre of the bridge carrying that road over the main line of the North British Railway Company between Edinburgh and Carlisle, passing thence to and in a north-easterly direction along Eskbank Road to and along and terminating in

south-westerly direction from the entrance gates to Dalkeith Palace.

The said Tramways (hereinafter referred to as "the tramways") will be made or pass from in, through, or into the following Parishes or places, or some of them, that is to say:—The Parishes of Liberton, Lasswade, Dalkeith, and Cockpen, and the Burghs of Dalkeith and Bonnyrigg, all in the County of Midlothian.

The Tramways, or some parts thereof, will be laid in the following streets or roads or some of them, so that at several places, for a distance of 30 feet or upwards a less space than 9 feet 6 inches will intervene between the outside of the footpath and the nearest rail of the tramway at the points or places indicated by a thick dotted line on the plans to be deposited as hereinafter mentioned, that is to say:—

The Edinburgh and Dalkeith Road, Drum Street (Gilmerton), Bonnvrigg Road, High Street, Eskbank Road (Dalkeith), Lothian Street, High Street (Bonnvrigg).

The Tramways are intended to be constructed on a gauge of 4 feet 81 inches, or such other gauge as may be authorised with such grooves, plates, or tubes, as may be necessary to work the same.

It is not intended to run on the tramways, carriages or trucks adapted for use on railways.

2. To authorise the making of the following Street Works, or any of them, and empower the Company to enter upon, take, and use the lands, houses, and other property required for the purposes thereof, and of the works connected therewith, as shown in the deposited plans, and described in the deposited Books of Reference aftermentioned, or any part or parts thereof (that is to say):

WORK A.—A widening of Bonnyrigg Road (Eskbank), on the north-west side in the Parish and Burgh of Dalkeith, between points respectively 200 yards and 240 yards measured in a north-easterly direction from the centre of the Bridge carrying that road_over the North Railway between Edinburgh British Carlisle.

WORK B .- A widening of Lothian Street, Bonnyrigg, on the north-west side, in the Parish of Cockpen, in the Burgh of Bonnyrigg, between points respectively 90 yards and 165 yards measured in a north-easterly direction from the junction of High Street and Lothian Street.

WORK C.—A rounding off and improvement of the north-east corner of Lothian Street and High Street (Bonnyrigg), in the Parish of Cockpen in the Burgh of Bonnvrigg, commencing in Lothian Street at a point 20 yards measured in a north-easterly direction from the junction of the said streets, and terminating in High Street at a point 15 yards measured in a northwesterly direction from the said junction.

3. To empower the Company to deviate laterally and vertically from the lines and levels of the Tramways and Street Works shown on the deposited plans and sections aftermentioned, to the extent to be shown on the said plans and sections, or to be defined in the Order, and for the purposes of and in connection with the Street Works, with the consent of the local authority, to make junctions and communications with any existing streets or roads which may be interfered with or intercepted by or

High Street at a point 135 yards measured in a | diversions widenings or alterations of lines or levels of any existing streets or roads for the purpose of connecting the same with such works.

4. To empower the Company to work and use the tramways, or any of them, by means of engines, carriages, trucks, and vehicles propelled (in addition to or in substitution for animal power) by electrical power generated at and applied from stations or otherwise, or steam, pneumatic gas oil, or other mechanical power, or partly by one such power and partly by another such power, to exempt the Company from the provisions of the Tramways Act, 1870, in respect to the limit of the overhang of carriages, and for the said purposes or any purpose appurtenant or ancillary thereto, to confer on the Company such rights, powers, and privileges as may be necessary or expedient for carrying into effect the purposes of the Order, and in particular, power to enter upon and open the surface of, and to lay down on, in, under, or over the surface of any footway, footpath, street, road, place, railway, or bridge, such posts, wires, tubes, mains, plates, or apparatus, and to make and maintain such openings, posts, wires, tubes, or ways on, in, under, or over any such surface, and remove any lamp-post, pillar-box, and other erections, and to attach to any house, building, bridge, or existing lamp-post or standard such supports, brackets, and fittings as may be necessary or convenient either for the actual working of the tramways or for providing access to or in connection with any generating station, engines, machinery, or apparatus, and to empower the Company, for the purposes of working the tramways and of the Order, to erect engines and machinery, and to acquire and hold patent and other rights and licences, and to use patent and other rights and licences in relation to such electrical or other mechanical power.
