And whereas His Majesty, by Orders in Council dated respectively the 16th day of February 1906, the 28th day of July 1906, the 21st day of December 1906, the 1st day of June 1907, the 21st day of December 1907, and the 4th day of June 1908, continued the powers of the said Commission until the 1st day of July 1909:

And whereas it is expedient that the powers of the said Commission should be continued for a further period:

Now, therefore, His Majesty, by and with the advice of His Privy Council, is pleased to order, and it is hereby ordered, that the powers of the Commission established under the Act aforesaid shall be in force until the first day of January 1910.

<sup>\*</sup> Section 8 of the Corn Returns Act, 1882, provides that where returns of purchases of British Corn are made to the Local Inspector of Corn Returns in any other measure than the imperial bushel or by weight or by a weighed measure, that Officer shall convert such returns into the imperial bushel, and in the case of weight or weighed measure the conversion is to be made at the rate of sixty imperial pounds for every bushel of wheat, fifty imperial pounds for every bushel of barley, and thirty-nine imperial pounds for every bushel of oats.
