BY THE KING. A PROCLAMATION FOR A BANK HOLIDAY.

GEORGE R.I.

WE, considering that it is desirable that Saturday, the First day of January next, should be kept as a close holiday in all Banks in England and Wales, and Ireland, do hereby, by and with the advice of Our Privy Council, and in pursuance of Section four of the Bank Holidays Act, 1871, appoint the said Saturday, the First day of January next, to be observed as a Bank Holiday in England and Wales, and in Ireland, for the purposes of the said Act, and We do, by this Our Royal Proclamation, command the said day to be so observed, and all Our loving subjects to order themselves accordingly:

And whereas it is customary for the usual Bank Holidays to be kept as holidays by Our loving subjects generally and not only for the

purposes of the said Act, but it is not Our intention that the First day of January should be kept as a general holiday in England and Wales, and in Ireland:

Now, therefore, We do hereby enjoin that the said First day of January shall not be kept as or deemed by virtue of this Our Royal Proclamation to be a holiday in England and Wales, and in Ireland, for any purposes whatsoever other than the purposes of the said Act.

> Given at Our Court at Buckingham Palace, this twenty-first day of December, in the year of our Lord one thousand nine hundred and twenty, and in the Eleventh year of Our Reign.

THEREAS it is provided by the Ministry of Transport Act, 1919, that, as from such date or dates as His Majesty in Council may by Order determine, there shall be transferred to the Minister of Transport all powers and duties of any Government Department in relation

- (a) Railways;
- (b) Light Railways;
- (c) Tramways;

(d) Canals, Waterways, and Inland Navigations;

(e) Roads, Bridges, and Ferries, and Vehicles and Traffic thereon;

(f) Harbours, Docks, and Piers;

And whereas it is further provided by the said Act that His Majesty may by Order make such incidental, consequential, and supplemental provisions as may be necessary or expedient for the purpose of giving full effect to any transfer of powers or duties as aforesaid, including provisions for the transfer of any property, rights, and liabilities held, enjoyed, or incurred by any Government Department in connection with any powers or duties transferred:

Now, therefore, His Majesty is pleased, by and with the advice of His Privy Council, to order, and it is hereby ordered, as follows:-

1. This Order may be cited as "The Ministry of Transport (Menai Bridge Transfer of Powers and Property) Order, 1920."

2. The date as from which the powers and duties of the Commissioners of Works in relation to Menai Bridge are transferred to the Minister of Transport shall be the 1st day of January 1921.

3. As from that date, all the property, rights, and liabilities held, enjoyed, or incurred by the Commissioners of Works shall be transferred to and vested in the Minister of Transport, and such rights and liabilities shall be exerciseable by or enforceable against the Minister of Transport in like manner as they would have been by or against the Commissioners of Works if this Order had not been made.

LORD CHAMBERLAIN'S REGULATIONS.

- 1. Ladies who have been presented, and who wish to be summoned to one of Their Majesties' Courts during the coming year, are requested to make written application to the Comptroller, Ceremonial Department, St. James's Palace, S.W. 1, on the 1st January next, but not before that date.
- 2. A lady attending a Court may present one lady, for whom she must be responsible, in addition to her daughter or daughter-in-law. The names of ladies to be presented should be forwarded by the lady who wishes to make the presentation when she sends in her own name.

3. A lady presented for the first time can only present her daughter or daughter-in-law at the

Court at which she is presented.

4. No applications can be received from ladies who wish to be presented. Their names must be forwarded by the ladies who wish to make the presentations.

- 5. Ladies may be accompanied to Court by their husbands if the latter have been presented, but gentlemen do not pass before The King and Queen. Ladies who wish to be accompanied by their husbands should state the fact in their applications, and they should also state if the ladies they desire to present wish to be accompanied by their husbands. Once the summons has been issued, the amending of a summons card in order to include a lady's husband can only be permitted under the most exceptional circumstances.
- 6. Summonses are issued about three weeks before the date of each Court, and should it not be convenient for a lady to attend the particular Court to which she is summoned, it will be open to her to make her excuses to the Lord Chamberlain in writing, when her name can, if desired, and if possible, be transferred to another list.

7. The Dress Regulations are: — Ladies: Court Dress, without feathers and trains. Gentlemen: Full Court Dress.

WHOLESALE MANTLE AND COSTUME TRADE BOARD (GREAT BRITAIN).

PROPOSAL TO VARY MINIMUM RATES OF WAGES FOR MALE WORKERS.

In accordance with Regulations made under Section 18 of the Trade Boards Act, 1909, by the Minister of Labour, and dated 31st October 1918, the Trade Board established under the Trade Boards Act, 1918, and the Trade Boards (Women's Clothing) Order, 1919, as varied by the Trade Boards (Shirtmaking) Order, 1920, for the Wholesale Mantle and Costume Trade in Great Britain, as defined in the Regulations made by the Minister of Labour, and dated 20th November 1919, hereby give notice, as required by Section 3 (5) of the Trade Boards Act, 1918, that they Propose to Vary the General Minimum Time-Rates, Piece-Work Basis Time-Rates, and Overtime Rates for Male Workers at present fixed and set out in the Schedule to their Notice dated 19th April 1920, and effective under an Order of the Minister of Labour, dated 17th April 1920, the variations proposed being as shown in the Schedule set out below.

Provided that workers who commence employment in the trade at or over the age of 19 shall receive for a period of 12 months a General Minimum Time-Rate of 38s. per week of 38 hours, i.e., 9½d. per hour. Provided also that this General Minimum Time-Rate shall be increased by 6s. per week of 48 hours, i.e., 1½d. per hour, in the case of any such worker who is 22 years of age or over. Workers to whom this proviso applies shall, on the expiration of 12 months' employment in the trade, receive such General Minimum Time-Rates as they may be entitled to under the provisions of this Schedule.

SECTION II.

- (a) The weekly rates set out in Section I. above, are based on a week of 48 hours, and are subject to a proportionate decrease according as the number of hours of employment in any week is less than 48.
- (b) In cases where a worker is employed on piece-work, each piece-rate paid must be such as would yield, in the circumstances of the case, to an ordinary worker an amount not less than the Piece-Work Basis Time-Rate applicable as set out in Section I. above. Provided that in determining as to whether any piece-rate satisfies this condition, regard shall be had to the earnings of workers of 22 years of age and over only.

PART II.

Proposed Variation of Overtime Rates for Male Workers.

Overtime Rates, calculated on the Minimum Rates set out in Part I. of this Schedule, in the manner specified in Part III. of the Schedule to the above-mentioned Notice, dated 19th April 1920, shall apply, in substitution for the rates set out in Part I. of this Schedule, in respect of all hours worked in excess of the number of hours declared by the Trade Board in the Schedule to the said Notice, dated 19th April 1920, to be the normal number of hours of work in the trade.

Note.—The hours which young persons and children are allowed to work are subject to the provisions of the Factory and Workshop Acts.

PART III.

Section I.—For the purpose of this Notice the following definitions shall apply:—

- (a) A Measure Cutter is a person who is capable of taking a complete set of measures and of cutting any garment for a female person from model, patterns, and sketches.
- (b) A Cutter (other than a Measure Cutter or Knife Cutter or Knifeman) is a person who is employed in (i) Marking-in or marking-up cloth or linings or other materials; (ii) laying-up, hooking-up, or folding cloth or linings or other materials; (iii) cutting cloth or linings or other materials; and (iv) dividing, that is, the process ordinarily carried on by Cutters or their assistants of dividing, parting, or separating the parts of garments after being cut, and of assembling them into suitable bundles for making up.
- (c) A Knife Cutter or Knifeman is a person who is wholly or mainly employed on Band, Electric, or Handknife processes.
- (d) A Fitter-up is a person who is employed in Fitting-up; that is, a process between that of cutting and that of sewing, baisting or machining, which consists of preparing or fitting accurately the various parts of the garment before being baisted, sewn, or machined, such work of preparing or fitting being always done by shears or knives or other cutting appliances, sewing, baisting, or machining forming no part or process of fitting-up.
- (e) A Tailor is a person who is employed in sewing by hand in the process of making a garment or portion of garment.
- (f) A Presser is a person who is employed in Pressing off by hand or by machine.
- (g) A Machinist is a person who is employed in Machining other than as a Plain Machinist as defined in Sub-Section (j) of this Section, and is capable of machining any garment throughout.

- (h) A Passer is a person who is employed in examining garments, either in the processes of being made up or upon their completion.
- (i) An Under Presser is a person who is employed in pressing processes other than Pressing off.
- (j) A Plain Machinist is a person who is employed in the process of making-up Plain Sleeves, Facings, Linings, Inside Pockets, Quilting and Padding.
- (k) A Warehouseman is a person employed wholly or mainly upon one or more of the following operations, viz., the assembling, keeping, storing and distributing of stock, but excluding such operations included in the definitions of a Packer or Porter.
- (1) A Packer is a person employed wholly or mainly upon the operation of packing goods and materials, but excluding such operations included in the definitions of a Porter or Warehouseman.
- (m) A Porter is a person employed wholly or mainly upon one or more of the following operations, viz., unpacking, moving, loading or unloading of goods or materials, but excluding such operations included in the definitions of a Packer or Warehouseman.

PART IV.

The respective Minimum Rates of Wages set out in this Schedule shall apply, subject to the provisions of the Trade Boards Acts, to all Male Workers in respect of all time during which they are employed in Great Britain in a branch of the trade specified in the Regulations made by the Minister of Labour dated 20th November 1919, that is to say:—

Women's, Girls' and Children's Ready-made and Wholesale Bespoke Tailoring, and all women's, girls' and children's retail bespoke tailoring carried on in a factory where garments are made up for three or more retail establishments, and any other branch of women's, girls', and children's tailoring, which is not included within the scope of the Retail Bespoke Tailoring Trade Board;

including :—

- (1) All operations and processes of cutting, making, or finishing by hand or machine of coats, costumes, tailored skirts, coat-frocks, mantles, service clothing, or similar garments made by tailoring processes;
- (2) (a) The altering, repairing, renovating, or re-making of any of the above-mentioned tailored garments, except where included within the scope of the Retail Bespoke Tailoring Trade Board; (b) The cleaning of such garments where carried out in association with or in conjunction with the altering, repairing, renovating, or re-making of the garments;

- (3) The lining with fur of any of the abovementioned garments, where carried out in association with or in conjunction with the making of such garments;
- (4) (a) All processes of embroidery or decorative needlework where carried on in association with or in conjunction with the making, altering, repairing, renovating, or re-making of any of the above-mentioned tailored garments other than hand-embroidery or hand-drawn thread work on garments made of linen or cotton, or of mixed linen or cotton;
- (b) The following processes, if done by machine—namely, thread-drawing, thread-clipping, top-sewing, scalloping, nickelling and paring;
- (5) Warehousing, packing, and all other operations incidental to or appertaining to any of the above-mentioned branches of tailoring;

but excluding:-

- (1) Those branches of women's or girls' bespoke tailoring and all operations or processes covered by the Trade Boards (Tailoring) Order, 1919;
 - (2) The making of head-gear;
- (3) The making of rubberised or oilskin garments;
- (4) Warehousing, packing, and other similar operations carried on in shops mainly engaged in the retail distribution of articles of any description that are not made on the premises.

PART V.

Section I.—The above Proposed Minimum Rates of Wages shall be paid clear of all deductions other than deductions under the National Insurance Act, 1911, as amended by any subsequent enactments or deductions authorised by any Act to be made from wages in respect of contributions to any superannuation or other provident fund.

Section II.—The above Proposed Minimum Rates of Wages are without prejudice to workers earning higher rates of wages, or to agreements made, or that may be made, between employers and workers for the payment of wages in excess of these Minimum Rates of Wages.

The Trade Board will consider any Objections to the above Proposal to Vary which may be lodged with them within two months from 21st December 1920. The Minister of Labour has given his consent to the issue of this Notice.

SCHEDULE.

PART I.

PROPOSED PIECE-WORK BASIS TIME-RATE.

For Male Hose-Pipe Weavers employed on Power or Hand Looms, 1s. 5d. per hour.

In the case of Male Hose-Pipe Weavers employed on Power or Hand Looms on Piece-Work, each Piece-Rate paid must be such as would yield, in the circumstances of the case, to an ordinary worker not less than 1s. 5d. per hour.

PART II.

PROPOSED VARIATION OF OVERTIME RATES.

In respect of all time worked in excess of the number of hours declared by the Trade Board, in their Notice dated 30th July 1920, to be the normal number of hours of work in the trade, Male Hose-Pipe Weavers employed on Piece-Work shall receive, in addition to Piece-Rates, each of which would yield, in the circumstances of the case, to an ordinary worker, not less than the Piece-Work Basis Time-Rate specified in Part I. of this Schedule, the Piece-Work Basis Time-Rate, one-half of the Piece-Work Basis Time-Rate, or one-quarter of the Piece-Work Basis Time-Rate, according as the Overtime Rate which would have been payable under the provisons of the said Notice, dated 30th July 1920, if the Worker had been employed on Time-Work were Double Time, Time-and-a-half, or Time-and-a-quarter, respectively.

The preparing, spinning, and weaving (a) of scutched flax; (b) of hemp; (c) of a mixture

mixture of hemp and any other fibre.

Including—

(1) The preparing and spinning of waste reclaimed at any stage; and

(2) All packing, despatching, warehousing, storing, or other operations incidental to or appertaining to any of the above-mentioned work;

But excuding-

(1) The calendering, bleaching, dyeing, or finishing of any of the above-mentioned materials; and

(2) The preparing or spinning of materials required for the making or re-making of (a) rope (including driving rope and banding); (b) cord (including blind and window cord, but excluding silk, worsted, and other fancy cords); (c) core for wire ropes; (d) lines; (e) twine (including binder and trawl twine); (f) lanyards; (g) net and similar articles when such spinning or preparing is carried on in the same factory or workshop as the said making or remaking; and

(3) The making or repair of sacks or bags;

(4) The weaving of carpets, rugs, and mats.
