#### Scottish Office, Whitehall, 29th July 1927.

THE following Addresses were presented to The King on the occasion of the visit of Their Majesties The King and Queen to Scotland, and His Majesty was graciously pleased to reply to the Deputations presenting the Addresses in the terms set forth below in each case :—

#### CORPORATION OF EDINBURGH.

To THE KING'S MOST EXCELLENT MAJESTY.

May it Please Your Majesty,-

We, Your Majesty's loyal and dutiful subjects, the Lord Provost, Magistrates and Council of the City and Royal Burgh of Edinburgh, respectfully approach Your Majesty and gratefully acknowledge the honour which you are doing the City by your presence with us to-day.

The Corporation, in common with other Local Authorities throughout the country, were at the close of the War confronted with the very serious problem of providing adequate housing accommodation for the citizens. This problem has engaged their unremitting attention since the passing of the Act of 1919, with the result that up till this date they have provided, or are in course of providing, a total of 5724 new houses.

While the Corporation have been preoccupied with the provision of new houses, they have

also had before them the cognate question of dealing with the evils which exist in connection with a very large proportion of the existing houses. A few years ago they drew up a schedule of areas in the City where the housing was so unsatisfactory that nothing short of Slum Clearance Schemes would remedy the evils which were found to be existing. In accordance with that policy, the Corporation have resolved to proceed with a Slum Clearance Scheme for one of the most congested areas of the City, viz., St. Leonard's Ward.

In order to make provision for a large proportion of the people who will be displaced by this Scheme, the Corporation recently acquired this beautiful site, which forms part of the Prestonfield Estate, and they propose to erect upon it about 600 houses.

Knowing as we do the deep interest which Your Majesty takes in all matters affecting the welfare of your Scottish subjects, it appeared to the Corporation that it would be fitting that Your Majesty should be associated with the initiation of this scheme. It is a matter of much gratification to us that Her Majesty the Queen is also present on this occasion, and on behalf of the citizens, and on our own behalf, we desire to express to Your Majesties the profound feelings of pride and satisfaction with which we regard Your Majesties' residence in your ancient Palace of Holyrood. We trust that your present visit to the City will be a happy and memorable one.

We would take this opportunity of renewing the assurance of our loyal and devoted attachment to Your Majesty's Person, Throne, and Government.

The Queen and I heartily thank the Lord Provost, Magistrates, Council and Citizens of the City and Royal Burgh of Edinburgh for their warm and loyal welcome. It is always a great pleasure to us to renew our association with this ancient and beautiful City and to make our home at Holyrood.

I have followed with interest the enterprise and initiative which the Town Council have directed towards the improvement of the conditions under which the Citizens live. Ranking prominently amongst their achievements is the work which they have carried on over a period of years towards the solution of the local housing problem, and I have seen with much satisfaction something of the progress already made.

I heartily commend the Corporation's policy of clearing and improving the slum areas of the City; and the Queen and I are very glad to be associated with this scheme at Prestonfield which I am now inaugurating, and which, by providing healthy, and convenient homes in pleasant surroundings, will add materially to the welfare of a large number of my people who are at present denied these blessings.

The scheme has been carefully laid out and designed so as to be worthy of the natural beauties of the site; and I trust that its development will be such as to enable the Corporation in the near future to make substantial progress with the task of clearing and reconstructing one of the congested areas in the City.

Housing—especially of the poorer classes enlists the deep sympathy and warmest interest of the Queen and myself, and I wish every success to the Corporation in this particular undertaking, and health and happiness to the future occupants of the houses to be built here.

#### CORPORATION OF GLASGOW.

To the King's Most Excellent Majesty. May it Please Your Majesty,—

We, the Lord Provost, Magistrates and Councillors of the City and Royal Burgh of Glasgow, desire for ourselves and on behalf of the citizens to offer your Majesty a hearty welcome to our City, along with the expression of our loyal devotion and of our grateful appreciation of the honour you have conferred upon the City in coming to inaugurate the new Kelvin Hall of Industries and to lay a Memorial Stone in connection with the completion of a new Bridge over the River Clyde at Oswald Street.

We regard it as an additional honour that Her Majesty the Queen has been able to ac-

company you. She is beloved by all your Majesty's subjects not only for her personal charm but for her warm sympathy in all that affects the welfare of all classes of the people, and the citizens of Glasgow are proud to extend a cordial welcome to her on this occasion.

The Kelvin Hall, when finally completed, will have cost, including the site, about  $\pounds 250,000$ , and will be a valuable addition to the many public buildings of the City. For many years it was felt that a large and commodious Hall suitable for all kinds of Exhibitions, Trade Fairs, Promenade Concerts and Entertainments was absolutely essential for the City, and that desire has now been realised by the erection and inauguration of this building. Many exhibitions connected with important. Industries, Housing and Health, Shipbuilding and Education, as also Motor Shows, Flower Shows, and other enterprises were successfully held in the temporary building which previously occupied this site. The British Industries Fair held in that building was visited by His Royal Highness the Prince of Wales in March 1921; the Motor Show held there in January 1923 was opened by His Royal Highness the Duke of York, and the Flower Show in September 1924 was opened by Her Royal Highness the Duchess of York. The City was greatly encouraged by these Royal Recognitions, as it is by the presence of Your Majesties to-day.

The Corporation are also deeply sensible of the signal mark of Royal favour conferred upon the City by Your Majesty personally associating yourself with the completion of the new Bridge, and in laying a Memorial Stone to signalise the event. The Bridge has been erected to cope with the ever increasing cross river and harbour and dock traffic, and to relieve the congestion of traffic in the centre of the City, and the results anticipated will, it is confidently hoped, be largely attained by the opening of the Bridge.

In graciously consenting to allow the Bridge to be designated "George the Fifth Bridge" Your Majesty has followed a well established precedent, as the Clyde is already spanned by other Bridges identified with the Royal House, and known respectively as the "Victoria Bridge" and the "Albert Bridge."

Your Majesty's association with the events of to-day is regarded as a renewed expression of your continued interest in this industrial centre and in the efforts made by the Corporation to foster and develop the trade and industries of the City, and to promote the amenities thereof and the social life and well-being of its inhabitants.

Our earnest prayer is that Almighty God may preserve and bless Your Majesties and all the Members of the Royal House.

The Queen and I warmly thank you, my Lord Provost, and the Magistrates, Council and Citizens of the City and Royal Burgh of Glasgow, for the loyal and kindly terms of the Address of Welcome to which we have listened. I am especially touched by your affectionate allusions to the Queen, who with me revisits your City with feelings of pleasure and satisfaction, and we are glad to renew that intimate and happy association so long existing between Glasgow and the Members of Our Family.

We have followed with concern the depression which in recent years has affected many of the important industries of this great City, which in population ranks second in the British Isles, and we hear with profound thankfulness that there is evidence in many quarters of improvement in the prospects of your trade and commerce.

The Corporation of Glasgow are to be congratulated upon their constant endeavours to stimulate and facilitate the manifold enterprises for which the City is famed throughout the world. One of the most interesting of these enterprises is the acquisition by the Corporation for the water-supply of their City of Loch Katrine and its surroundings, extending over a district historically famous, and associated for ever with the genius of one of Scotland's noblest sons, and his immortal romance of "Rob Roy." Glasgow is singularly fortunate in having within easy reach some of the most beautiful scenery in Scotland, and, thanks to the generosity of private donors and to the foresight of the Corporation, much has been done to make this accessible to its people. Those who are thus privileged to enjoy the beauty of these landscapes will, I feel sure, at the same time appreciate the need to preserve their amenities with care and respect.

The primary object of our visit is to open two important additions to your City. The erection of Kelvin Hall supplies the need of a suitable building for the many public meetings essential to your commercial and social life. I rejoice that it should be called after one of the first distinguished men upon whom my Father conferred the then newly created Order It was more than deserved. I share of Merit. with all the Officers and Men of the Navy, and of our splendid Merchant Service, the admiration and gratitude felt by all those brought up to the Sea, for the benefits rendered to mankind by the indefatigable labours of Lord Kelvin in the cause of science in general and of sea-service in particular.

History records that, more than seven centuries ago, a stone bridge was built over the River Clyde. To-day another bridge spans your world-renowned waterway. I am proud that it should bear my name, and trust that, as your Address anticipates, it will materially lessen the congestion of traffic in the centre of your City.

It has become more obvious every day that to minimise the complications and dangers of road traffic is one of the most urgent problems affecting those engaged in commercial pursuits, and in facilitating the hard-earned recreations of the people. By unstinted efforts, combined with economical treatment of this subject, enterprising Corporations and County Authorities throughout the land may contribute largely to the wealth and happiness of all classes.

We are deeply grateful for your kind wishes for Ourselves and Our Family; and we pray that, with God's Blessing, Glasgow and its Citizens may ever enjoy peace, happiness and prosperity.

from Guild Brethren it is now the happy privilege of our Ancient House and Crafts to be able to distribute annually a sum of more than £40,000 in pensions to the aged and needy, in grants towrds the education and training of the young, in bounties to encourage the wise and judicious adoption of orphan children, and in contributions to Charitable and Benevolent Institutions and Schemes in Glasgow.

1. The provisions of the Act shall apply to ships registered in the Colonies mentioned in the Schedule in like manner as they apply to ships registered in the United Kingdom subject to the following modifications and adaptations, that is to say:—

(1) For the expressions "the Board of Trade" and "officers of the Board of Trade" there shall be respectively substituted the expressions "the Officer Administering the Government" and "officers authorised for such purpose by the Officer Administering the Government."

(2) For the words "United Kingdom" in section five of the Act there shall be substituted the name of the Colony.

(3) Sections 2, 3 and 4 of the Act shall not apply to (a) ships registered in the

Straits Settlements or (b) ships registered in Seychelles by the Port Officer for voyages between the Islands shown in Schedule A of the Regulations made by the Governor in Executive Council under Sections 16 and 17 of the Unseaworthy Vessels Ordinance, 1896.

(4) For the purpose of the penalties prescribed in section four of the Act Rupees 10 shall be taken as the equivalent of £1 in the case of Mauritius.

1. Subject as hereinafter provided, the Milk Distributive Trade shall consist of the following operations :-

- (i) the wholesale and retail sale of milk;
- (ii) the sale of other goods by workers mainly employed in the sale specified in paragraph 1 (i) hereof;

(iii) all work incidental to the sale specified in paragraph 1 (i) hereof.

2. Work incidental to the sale specified in paragraph 1 (i) hereof shall include, inter alia :

- (a) collecting, delivering, despatching;
- (b) pasteurising, sterilising, homogenising, humanising, cooling, separating and all work performed in connection with any other processes in the preparation of milk;
- (c) blending, testing and sampling of milk; (d) cleaning
- cleaning of utensils, receptacles, vehicles, premises, plant, machinery; (e) stoking, attending to boiler, plant or machinery, fire lighting, portering
- of coal, or other fuel;
- (f) horse keeping and harness cleaning;
- (g) portering, lift or hoist-operating, timekeeping, storing, stock-keeping, warehousing;
- (h) boxing, parcelling, labelling, weigh-ing, measuring, checking, bottling, packing and unpacking;
- (i) clerical work or canvassing carried on in conjunction with the work specified in paragraph 1 hereof.

3. Nothwithstanding any of the foregoing provisions, the Milk Distributive Trade shall not include any of the following operations :-

(a) the wholesale sale of milk (and operations incidental thereto) from an establishment at which milk products are manufactured and from which unseparated milk is not ordinarily sold at such;
