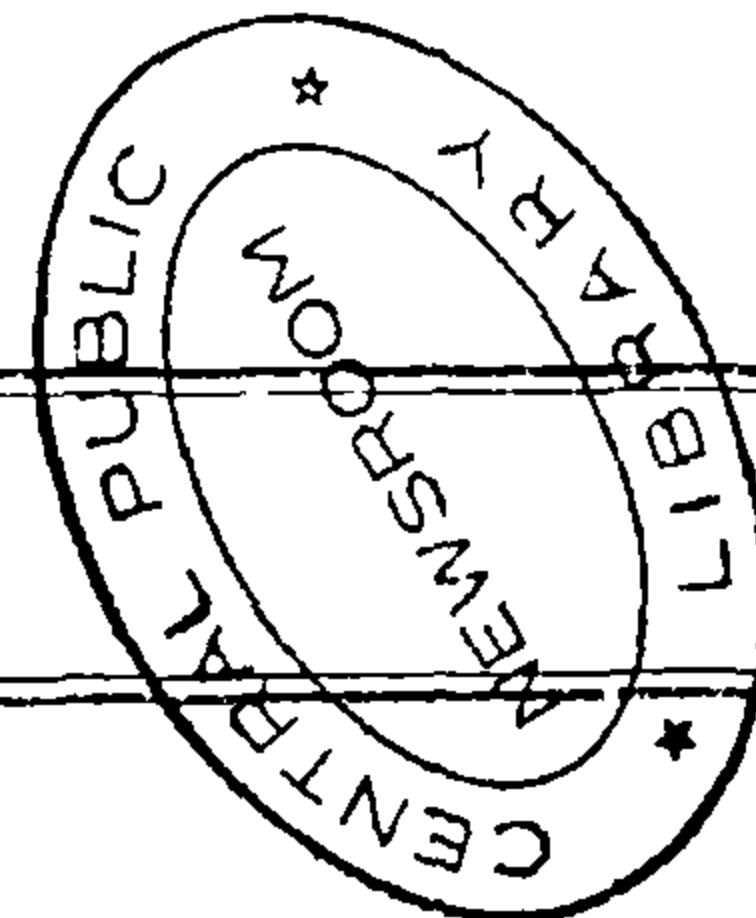

TRUNK ROADS ACT, 1946 and 1936 NORTH OF CUMBERNAULD TO HAGGS DIVERSION

THE Secretary of State gives notice that he has made an Order under sections 1 and 11 of the Trunk Roads Act, 1946, and section 13 of the Trunk Roads Act, 1936, all as read with the Transfer of Functions (Roads, Bridges and Ferries) Order, 1955, the effect of which will be:

- (a) that a diversion which he proposes to construct between North of Cumbernauld and Haggs in the Counties of Dunbarton and Stirling will become a trunk road on the date when the Order comes into operation and the lengths of the trunk road to be superseded thereby will cease to be trunk roads on the sixteenth day of May next after the date on which notice is given by the Secretary of State to the County Councils of Dunbarton and Stirling (who will thereafter become the highway authorities responsible for the said lengths in their respective Counties) that the said diversion is opened for through traffic;
- (b) to provide for the construction by the Secretary of State of a bridge over the navigable waters of the Forth and Clyde canal;
- (c) that the Gretna-Stranraer-Glasgow-Stirling Trunk Road (Cumbernauld to Castlecary Diversion) Order, 1959, and the Gretna-Stranraer-Glasgow-Stirling Trunk Road (Denny By-Pass) Order, 1957, in so far as they authorise the construction of lengths of roads now superseded by the said diversion and the construction of a bridge over the navigable waters of the Forth and Clyde Canal be revoked when this Order is made.

Copies of the Order, the title of which is "The Gretna-Stranraer-Glasgow-Stirling Trunk Road (North of Cumbernauld to Haggs Diversion) Order, 1961," can be purchased, price 3d., through any bookseller or direct from Her Majesty's Stationery Office, 13a Castle Street, Edinburgh 2.

Copies of the Order and of the plan referred to therein have been deposited at the Scottish Home Department, Bankhead Avenue, Sighthill, Edinburgh 11, and at the offices of Dunbarton County Council, County Buildings, Dunbarton, and Stirling County Council, County Buildings, Viewforth, Stirling and may be seen at all reasonable hours.

Any Person aggrieved by the Order and desiring to question the validity thereof or of any provision contained therein on the grounds that it is not within the statutory powers or on the ground that any requirement of the said Acts of 1946, and 1936 or of regulations made thereunder, has not been complied with in relation to the Order, may,

within six weeks of the 21st day of July 1961, apply to the Court of Session for the suspension or quashing of the Order or of any provision contained therein.

FACTORIES ACTS, 1937-1959 WORK IN CONFINED SPACES

THE Minister of Labour hereby gives notice that on 14th July 1961 he made the Breathing Apparatus, Etc. (Report on Examination) Order, 1961. The purpose of the Order is to prescribe the particulars to be contained in the report on an examination of any apparatus, belts or ropes, for the purposes of sub-section (6) of Section 27 of the Factories Act, 1937, as re-enacted by Section 6 of the Factories Act, 1959. Section 27 requires the provision of breathing, reviving and risk apparatus for the protection of persons working in confined spaces in which dangerous fumes are liable to be present. The new Order replaces the Breathing Apparatus, Etc. (Report on Examination) Order, 1949, which contains similar provision. S.I. 1961 No. 1345.
