#### PRICES AND INCOMES ACT 1966

Reference to the National Board for Prices and Incomes WAGES AND CONDITIONS IN THE ELECTRICAL CONTRACTING INDUSTRY

WAGES and conditions in the electrical contracting industry for England, Wales and Northern Ireland are currently determined by a three-year agreement reached on 30th June 1966, the final stage of which was put into effect from 2nd September 1968. Wages and conditions in the electrical contracting industry in Scotland are determined separately.

In pursuance of her powers under Section 2(1) of the Prices and Incomes Act 1966, the First Secretary of State and Secretary of State for Employment and Productivity hereby refers to the National Board for Prices and Incomes for separate examination and report:

- Wages and conditions of employment in the electrical contracting industries in England, Wales and Northern Ireland;
- Wages and conditions in the Electrical Contracting Industry in Scotland;
- Questions related to (1) and (2) above, including the relationship of national settlements in electrical contracting to other pay settlements and in particular to site agreements.

#### Experimental Traffic Order TRUNK ROAD (A.74) IN UDDINGSTON

#### SCHEDULE

- 1. Waiting would be prohibited between the hours of 8 a.m. and 6 p.m. and loading or unloading would be prohibited from 8 a.m. to 9 a.m. and from 4.30 p.m. to 6 p.m. Mondays to Saturdays inclusive on trunk road (route A.74) Main Street in Uddingston as follows:
- (a) On the east side of the road
  - (i) from Caley Brae to 15 yards south of Greenrig Street, and
  - (ii) from 15 yards north of Gardenside Avenue to Old Glasgow Road.
- (b) On the west side of the road
  - (i) from Station Road southwards for 15 yards;
  - (ii) from 15 yards north of Gardenside Street to 15 yards south of Gardenside Avenue;
  - (iii) for 15 yards north and south of Church Street; and
  - (iv) from 45 yards north Bellshill Road southwards to Old Glasgow Road.
- 2. Waiting limited to 30 minutes in any hour between the hours of 8 a.m. and 6 p.m. Mondays to Saturdays inclusive:

- (a) On the west side of the road
  - (i) from 15 yards south of Station Road to 15 yards north of Gardenside Street;
  - (ii) from 15 yards south of Gardenside Avenue to 15 yards north of Church Street; and
  - (iii) from 15 yards south of Church Street to 45 yards north of Bellshill Road.
- (b) On the east side of the road from 15 yards south of Greenrig Street to 15 yards north of Gardenside Avenue.

The order will provide for exceptions to enable a vehicle to wait for as long as necessary for a person to board or alight to enable goods to be loaded or unloaded (except between the hours of 8 a.m. and 9.30 a.m. and 4.30 p.m. and 6 p.m. on the lengths of road specified in Schedule 1 above) and to enable vehicles to be used in connection with maintenance operations and other works. The restrictions will not apply to disabled drivers registered with a Local Authority.
