TENDERS FOR TREASURY BILLS

1. The Lords Commissioners of Her Majesty's Treasury hereby give notice that Tenders will be received at the Chief Cashier's Office, at the Bank of England on Friday, the 18th January 1974, at 1 p.m., for Treasury Bills to be issued under the Treasury Bills Act 1877, and the National Loans Act 1968, to the amount of £60,000,000.

2. The Bills will be in amounts of £5,000, £10,000, £25,000, £50,000, £100,000 or £250,000. They will be dated at the option of the tenderer on any business day from Monday, the 21st January 1974, to Friday, the 25th January 1974, inclusive, and will be due 91 days after that date.

3. The Bills will be issued and paid at the Bank of England.

4. Each Tender must be for an amount not less than £50,000 and must specify the date on which the Bills required are to be dated and the net amount per cent. (being a multiple of one new half-penny) which will be given for the amount applied for. Separate Tenders must be lodged for Bills of different dates.

5. Tenders must be made through a London Banker, Discount House or Broker.

6. Notification will be sent, on the same day as Tenders are received, to the persons whose Tenders are accepted in whole or in part. Payment in full of the amounts due in respect of such accepted Tenders must be made to the Bank of England by means of cash or by draft or cheque drawn on the Bank of England not later than 1.30 p.m. on the day on which the relative Bills are to be dated.

7. Members of the House of Commons are not precluded from tendering for these Bills.

8. Tenders must be made on the printed forms which may be obtained from the Chief Cashier's Office, Bank of England.

9. The Lords Commissioners of Her Majesty's Treasury reserve the right of rejecting any Tenders.

EMERGENCY REGULATIONS 1974

General Authority under Regulation 11 (driver's hours)

THE Secretary of State for the Environment, in exercise of his powers under Regulation 11 of the Emergency Regulations 1974(a) and of all other enabling powers, hereby grants the following authority:—

1. Nothing in subsections 1, (3)(a) and (b), (4)(a) or (5) of section 96 of the Transport Act 1968(b) (which relate to a driver's permitted hours and periods of duty and rest) shall apply to the driver of a goods vehicle (being a vehicle to which Part VI of the said Act of 1968 applies) so long as, in relation to his driving of that vehicle, all the following conditions are complied with:—

- (a) he does not on any working day drive a vehicle or vehicles to which the said Part VI applies for periods amounting in the aggregate for more than 11 hours;
- (b) his work day—
 - (i) except where sub-paragraph (ii) of this condition applies, does not exceed 12 hours,
 - (ii) if during that day he is off duty for a period which is, or periods which taken together are, not less than the time by which his working day exceeds 12 hours, does not exceed 14 hours;
- (c) he has, between two successive working days, an interval for rest which is of not less than 10 hours;
- (d) he is not on duty in any working week for periods amounting in the aggregate to more than 72 hours; and
- (e) he does not, in any working week, drive a vehicle or vehicles to which the said Part VI applies for periods amounting in the aggregate to more than 66 hours.

2. For the purposes of this authority—

- (a) the reference to any provision of section 96 of the said Act of 1968 is a reference to that provision as modified by any order under subsection (12) of that section for the time being in force;

(b) section 103 of the said Act of 1968 shall apply as it applies for the purposes of Part VI of that Act.
