#### THE IMPORTATION OF ANIMALS ORDER 1977

#### (ARTICLE 3 (2))

THE Secretary of State for Scotland, by this licence issued under Article 3 (2) of the Importation of Animals Order 1977, hereby authorises the landing in Great Britain, in accordance with the conditions set out below, of cattle 15 days of age and over originating in The Republic of Ireland at Cairnryan, Stranraer.

This licence is valid until varied or revoked by the Secretary of State for Scotland.

Scotland General Import Licence No 42 dated 1st October 1985 is hereby revoked.

#### **CONDITIONS**

- 1. All landings of cattle shall be in accordance with the provisions of the Importation of Animals Order 1977 and with the following provisions of this licence.
- On landing in Great Britain, the cattle shall immediately be taken to an approved reception centre linked with the airport/port as specified below:

#### Cattle for Breeding or Meat Production

#### FOR OFFICIALLY BRUCELLOSIS FREE CATTLE

- 3.A Each consignment of OBF cattle shall be accompanied by a certificate in accordance with Annex F, Model I of EEC Directive 64/432 (as amended), signed by a veterinary officer appointed by the Government of the Republic of Ireland.
  - B Under Article 7(1)G, of EEC Directive 64/432 (as amended), by way of Derogation from Article 3(3)(e), female animals of lesy than 30 months of age intended for meat production need not be tested for enzootic bovine leukosis. They shall be marked by means of a metal tag with a blue plastic disc, in the left ear.

#### FOR BRUCELLOSIS FREE CATTLE

- 4.A Each consignment of BF cattle shall be accompanied by two certificates signed by a veterinary officer appointed by the Government of the Republic of Ireland:
  - (a) A certificate in accordance with Annex F, Model I of EEC Directive 64/432 (as Amended), and
  - (b) A certificate stating the following:-
    - (i) as far as can be determined and to the best of my knowledge and belief the female cattle to be exported have not been vaccinated against brucellosis;
    - (ii) the cattle were examined by a veterinary officer at the time of loading and showed no erupted permanent incisor teeth; and
    - (iii) a certificate has been received from an approved veterinary surgeon, that the female cattle are not pregnant.
  - B Under Article 7(1)G, of EEC Directive 64/432 (as amended), by way of Derogation from Article 3(3)(e), female animals of less than 30 months of age intended for meat production need not be tested for enzootic bovine leukosis. They shall be marked by means of a metal tag, with a blue plastic disc, in the left ear.

#### Cattle for Slaughter

- (a) Each consignment of cattle shall be accompanied by a certificate in accordance with Annex F, Model II of EEC Directive 64/432 (as amended).
  - (b) For cattle from herds of neither OBF nor BF status, the following condition will apply:-
    - Female animals and bulls must have passed the serum agglutination test for brucellosis (at less than 30 ius) within 30 days of loading.
  - (c) Cattle for slaughter shall be licensed from the reception centre only to a slaughterhouse for immediate slaughter under the terms of a licence issued under Article 11(5) of the Importation of Animals Order 1977.
- Importers of cattle in the category described at paragraphs 5(b) intending to transit Northern Ireland MUST contact the Department of Agriculture for Northern Ireland, Dundonald House, Upper Newtownards Road, Belfast BT4 3SB.

#### General

- 7. Officially brucellosis free (OBF), brucellosis free (BF) cattle and non OBF/BF cattle must be kept separate from each other and must not come into contact with other animals not similarly certified. Failure to observe this requirement will result in all the animals being classified in the lowest status.
- 8. Any person wishing to land animals in Great Britain under the terms of this licence must make arrangements for accommodation of the animals in advance with the occupier of the reception centre to which the animals are to be taken after landing.
- 9. The carrier of imported animals must notify the person in charge of the reception centre of the proposed time of landing, the number of animals and their description.
- 10. After arrival at the reception centre and before release from the reception centre is authorised by a veterinary inspector, all animals not being consigned direct to a slaughterhouse, must be treated to the satisfaction of an officer of the Ministry, with an approved product (for which there is a valid product licence granted under the Medicines Act 1968 permitting its sale and supply for systematic use to kill warble fly) in accordance with the manufacturer's instructions. Treatment shall be at the expense of the owner or person in charge of the animals.

The only exceptions to this requirement shall be for:

- a. Calves under the age of 12 weeks;
- b. Between 1st December and 14th March;
  - \*i. cows producing milk for human consumption;
  - \*ii. dairy cows within 28 days prior to calving;

\* (no approved products are available to treat these categories of cattle between 1st December and 14th March).

In the case of animals at b.i. and ii. above, treatment must be undertaken on the farm between 15th and 31st March. Three days notice of treatment must be given to the local Divisional Veterinary Officer so that he may arrange for the treatment to be supervised. Instruction to this effect will be issued with the movement licence at the reception centre.

11. Animals intended for breeding or meat production originating from brucellosis free herds will be consigned from the reception centre, under a movement licence, direct to a named destination premises, where the animals must be isolated for a period of at least 10 weeks until a brucellosis serum agglutination test has been carried out with negative results.

Also exempted is the continued use of injurious substances in certain categories of case listed in the Schedule to the Regulations; such use will be permitted only if the equipment, plant or fluid containing the injurious substance is already in use on 30th June 1986 and for so long as that equipment, plant or fluid remains servicable.

It is proposed that the regulations will come into force from 30th June 1986.
