## (PARKNEUK ROAD AND RUMBLINGWELL, DUNFERMLINE)

## (PROHIBITION OF WAITING) ORDER 1986

1. THE Fife Regional Council propose to make an Order under Sections 1(1) and (2), 2(1) and (2) and 124 of and paragraph 20(1) of Schedule 9 to the Road Traffic Regulation Act 1984.
2. The effect of the Order will be to prohibit the waiting of vehicles on certain lengths of Parkneuk Road, Dunfermline and Rumblingwell, Dunfermline.
3. Exceptions include waiting for the following purposes:-
  - (a) boarding or alighting from vehicles;
  - (b) the loading or unloading of goods;
  - (c) building or demolition operations;
  - (d) road maintenance, improvement or reconstruction;
  - (e) statutory powers and duties;
  - (f) the supply of gas, water, electricity or telecommunications apparatus, and
  - (g) bus travel.
4. Full details of the proposals are contained in the draft Order which, together with a plan showing the lengths of road which will be affected, and a Statement of the Council's Reasons for wishing to make the Order, may be examined at Fife Regional Headquarters, Fife House, North Street, Glenrothes and at Fife Regional Council Area Office, 34 Viewfield Terrace, Dunfermline, during normal office hours.
