This Order amends the Bovine Spongiform Encephalopathy Compensation Order 1996.

Articles 3(3)(c) and 4(6) are amended to provide for the appointment of a valuer by the President of the Institute of Auctioneers and Appraisers in Scotland where an exposed animal in Scotland is to be slaughtered and the Minister and the animal's owner have not agreed on the Valuation or the appointment of a valuer. Article 4(5)(c) is replaced by a provision which limits its application to herds of 11 or more animals. Paragraph 3 of Schedule 2 is replaced by a new definition of "closed herd" making it clear that the relevant period ends when the first animal is slaughtered.

TECHNICAL ANNEX

At the request of the Secretary of State for Trade and Industry and as agreed by the Pipelines Inspectorate branch of the Health and Safety Executive, Elf Exploration UK PLC presents the following information about the SEAL gas export pipelines:

Pre-commissioning Testing

The pipeline will be tested to the satisfaction of the Pipelines Inspectorate prior to commissioning.

Design Pressure

The maximum pressure in the line will be less than the pressure for which the pipeline has been designed.

Leak Detection

Pressure and flow will be monitored at all times.

In the event of a leak being detected the pipeline pressure will be reduced to control the leak. An aerial and underwater survey will be conducted to find the source of the leak.

Routine surveillance will be carried out along the pipeline route.

Emergency Action

In the event a major break occurs in the pipeline the following emergency action will be taken:

1. All product delivery into the pipeline will be manually or automatically stopped
2. The Pipelines Inspectorate will be notified immediately
3. An underwater survey and aerial survey will be carried out to determine the location of the break
4. Should pollution result from the discharge of the product the emergency pollution control system held in constant readiness by the UK Offshore Operators Association will be mobilised

Recommissioning

In the event of a pipeline break, contingency plans to be agreed with the Pipelines Inspectorate will be carried out for the repairing of the pipeline and proving its integrity before putting it back into service.

On Bottom Stability and Safety

The pipeline, if authorised, will be laid in a manner that will ensure its safety and stability under all foreseeable conditions.

Limits of Deviation

The pipeline will be laid within a boundary of 250 metres on either side of the proposed route.

The effect of the Order will be (1) to prohibit driving on Shiprow, between Union Street and the north kerblin on Exchequer Row, except for any pedal cycle being ridden on what will be a designated cycle track (separate from the existing footway) on that length of road, (2) to prohibit driving on Shiprow, between Market Street and the west kerblin of Shore Brae, except for any pedal cycle being ridden on what will be a designated cycle track (again separate from the footways) on that length of road or any goods vehicle taking access to premises adjacent to that length of road between the hours of midnight and 10.00am or 4.00pm and midnight on any day, or any permit holder taking access to authorised car parking facilities adjacent to that length of road (the permits in question will be issued if the Council is satisfied that the applicant needs access to such car parking facilities at the location) (3) to prohibit driving on the Plain Stanes cul-de-sac, except for goods vehicles taking access to premises adjacent to the cul-de-sac between the hours of midnight and 10.00am and 4.00pm and midnight on any day, (4) to prohibit driving on Shore Brae, between Virginia Street and Shiprow, other than in a northerly direction; on Shiprow, between the west kerblin of Shore Brae and Market Street, other than in a westerly direction; and on Exchequer Row, from the Plain Stanes cul-de-sac to Union Street other than in a northerly direction; except that these one-way requirements shall not apply to the riding of a pedal cycle on the parts of Shore Brae and Shiprow designated as a cycle track by virtue of the proposed order, (5) to prohibit the driving of any vehicle other than a pedal cycle on that part of the length of Shore Brae, between Virginia Street and Shiprow, being the part of that length of road designated as a cycle track, and (6) to prohibit the driving of any vehicle other than a pedal cycle on that part of the length of Shiprow, between the west kerblin of Shore Brae and the north kerblin of Exchequer Row, being the part of that length of road designated as a cycle track by virtue of the proposed order.

The intended arrangements are complicated in their expression but much simpler to assimilate if viewed on a plan. Accordingly, members of the public interested in the matter are encouraged to visit the offices of the Council's Roads Section at St. Nicholas House, Broad Street, Aberdeen, where full details of all the proposals are to be found in maps showing the intended measures, along with an accompanying statement of the Council's reasons for promoting them.
