In accordance with section 12(6A) of the Act the Director hereby gives notice that his reasons for making the modification were to simplify the licence and avoid confusion following the coming into force of the Competition Act 1998 (the "Competition Act") on 1st March 2000. The Competition Act now prohibits anti-competitive agreements and conduct formerly covered by Condition 31. Condition 31.9(a) provided that the condition should cease to apply to any behaviour prohibited by new legislation that:

- '(i) contains a prohibition enforceable by the Director ... of any behaviour prohibited [under Condition 31].
- (ii) gives to third parties in respect of a breach of that prohibition at least the rights they have under section 18 of the [Telecommunications Act 1984] in respect of a breach of a provisional or final order; and
- (iii) permits the imposition on the Licensee of monetary penalties in respect of the breach of that prohibition.'

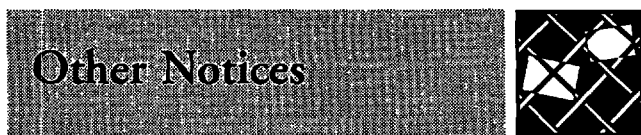

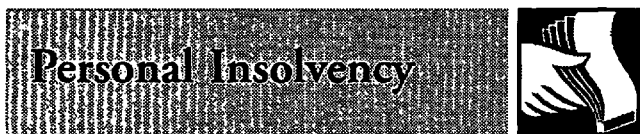
