WESTMINSTER, March 30, 1831.

THIS day, the Lords being met, a message was sent to the Honourable House of Commons by the Gentleman Usher of the Black Rod, acquainting them, that *The Lords, authorized by virtue of a Commission under the Great Seal, signed by his Majesty, for declaring His Royal Assent to several Acts agreed upon by both Houses, do desire the immediate attendance of the Honourable House in the House of Peers to hear the Commission read*; and the Commons being come thither, the said Commission, empowering the Lord Archbishop of Canterbury, the Lord High Chancellor of Great Britain, and several other Lords therein named, to declare and notify the Royal Assent to the said Acts, was read accordingly, and the Royal Assent given to

An Act for granting to His Majesty, until the fifth day of April one thousand eight hundred and thirty-two, certain duties on sugar imported into the United Kingdom, for the service of the year one thousand eight hundred and thirty.

An Act to explain and amend an Act of the sixth year of His late Majesty King George the Fourth, as far as regards the settlement of the poor by the renting and occupation of tenements.

An Act to improve the proceedings in prohibition and on writs of mandamus.

An Act to enable courts of law to order the examination of witnesses upon interrogatories, and otherwise.

An Act for more effectually making and repairing the road from the New-bridge over the water of Almond, on the confines of the counties of Edinburgh and Linlithgow, to Baillicoton, in the county of Lanark, and certain branch roads connected therewith.
