NOTICE is hereby given that His Royal High-ness Prince Arthur will, by command of The Queen, hold a Levee at St James's Palace, on behalf of Her Majesty, on Saturday the 3d of

April next, at two o'clock. It is the Queen's pleasure that Presentations to His Royal Highness at the Levee shall be considered as equivalent to Presentations to Her Majesty.

REGULATIONS

TO BE OBSERVED AT THE QUEEN'S LEVEE TO BE HELD BY HIS ROYAL HIGHNESS PRINCE ARTHUR, ON BEHALF OF HER MAJESTY, AT ST JAMES'S PALACE.

By Her Majesty's Command.

The Noblemen and Gentlemen who propose to attend Her Majesty's Levee, at St James's Palace, are requested to bring with them two large cards, with their names *clearly written* thereon, one to be left with The Queen's Page in attendance in the Corridor, and the other to be delivered to the Lord Chamberlain, who will announce the name to His Royal Highness.

PRESENTATIONS.

Any Nobleman or Gentleman who proposes to be presented, must leave at the Lord Chamber-lain's Office, St James's Palace, *before twelve* o'clock, two clear days before the Levee, a card with his name written thereon, and with the name of the Nobleman or Gentleman by whom he is to be presented. In order to carry out the existing regulation that no presentation can be made at a Levee excepting by a person actually attending that Levee, it is also necessary that a letter from the Nobleman or Gentleman who is to make the presentation, stating it to be his intention to be present, should accompany the presentation card above referred to, which will be submitted to The Queen for Her Majesty's approbation. It is Her Majesty's Command that no presentations shall be made at the Levee except in accordance with the above regulations.

It is particularly requested that in every case the names be very distinctly written upon the acards to be delivered to the Lord Chamberlain, in meant all parts of America not belonging to Spain.

Assent given to An Act to apply certain sums out of the Con-solidated Fund to the service of the years ending the thirty-first day of March one thousand eight hundred and sixty-eight, one thousand eight hundred and sixty nine, and one thousand eight hun dred and seventy.

The Right Honourable the Lords of the Committee of Privy Council for Trade have received, from the Secretary of State for Foreign Affairs, a copy of a Despatch from Her Majesty's Minister at Washington, enclosing a copy of an Act recently passed by the Congress of the United States, for "regulating the duties on imported copper and copper ores."

By this Act the duties hitherto levied on copper imported from foreign countries have been raised to the following rates :---

Cents.

- All copper imported in the form of ores (per pound of fine copper contained therein)
- All regulus of copper, and all black or coarse copper (per pound of fine copper contained therein) . . . 4
- All old copper, fit only for remanufacture, per pound 4
- All copper in plates, bars, ingots, pigs, or other forms not manufactured, or herein enumerated, including sulphate of copper, or blue vitriol, per pound . 5

Provided that the increased duty imposed by this Act shall not apply to any of the articles therein enumerated which shall have been in course of transit to the United States, and actually on shipboard on the 19th January 1869.

The Right Honourable the Lords of the Committee of Privy Council for Trade have received, from the Secretary of State for Foreign Affairs, a copy of a Despatch from Her Majesty's Consul-General at Lima, reporting the expiration of the Treaty of Friendship and Navigation between Peru and Italy.

In consequence of the cessation of this Treaty, Italian ships will be subject to the same fiscal and municipal duties as the other foreign ships trading in the Republic of Peru.
