A PROCLAMATION,

in the room of William Earl of Home, deceafed.

HEREAS by the Advice of Our Privy-Council, We did summon a Parliament, For the Electing a Peer of Scotland to fit in Parliament,

Council, We did summon a Parliament of Great Britain to meet and be held at Westminster the 19th Day of May last past: And whereas We prorogued the faid Parliament to the 2d Day of July next: And whereas by the Advice of Our Privy Council We have thought fit to Order the faid Parliament to be further prorogued to the Third Day of September next ensuing: And whereas William Earl of Home was nominated to be one of the Six teen Peers of Scotland, and as fuch was returned to fit in the House of Peers in the said Parliament: Which faid William Earl of Home was, at the Time of and before the faid Nomination, deceafed, at Gibraltar, whereof the Lords Electors had no Notice at the Time of the faid Nomination: In order therefore to the Electing a Peer of Scotland to supply the Defect of the said void Nomination, and to fill up the Number of Sixteen, according to the Treaty of Union, and the Statutes in that Case made and provided, We do, by the Advice of Our Privy-

T the Court at St. James's, the 25th Day of | Council, issue forth this Our Royal Proclamation, strictly charging and commanding all the Peers of Scotland to affemble and meet at Holy Rood House in Edinburgh, on Wednesday the Twelfth Day of August next ensuing, between the Hours of Twelve and Two in the Asternoon, to nominate and choose another Peer of Scotland to fit and vote in the House of Peers of the faid Parliament of Great Britain, in the room of the faid William Earl of Home, deceased, by open Election and Plurality of Voices of the Peers that shall be then present, and the Proxies for fuch as shall be absent, such Proxies being Peers, and producing a Mandate in Writing, duly figned before Witnesses, and both Constituent and Proxy being qualified according to Law. And the Lord Clerk Register, or such, two of the Principal Clerks of the Session, as shall be appointed by him to officiate in his Name, are hereby respectively required to attend such Meeting, and to administer the Oaths required by Law to be taken there by the faid Peers, and to take their Votes, and immediately after fuch Election made, and duly examined, to certify the Name of the Peer so elected, and sign and attest the same in the Presence of the said Peers, and reurn such Certificate into Our High Court of Chancery of Great Britain. And We strictly Charge and Command, That this Our Royal Proclamation may be published at Our Market Cross at Edinburgh, and in all the County Towns in Scotland, twenty-five Days at least before the Time hereby appointed for the Meeting of the faid Peers to proceed to such Given at Our Court at St. James's the Twenty-fifth Day of June, 1761, in the First Year of Our Reign.
