By the KING, PROCLAMATION,

For Recalling and Probibiting Seamen from ferving Foreign Princes and States; and for granting Rewards for discovering such Seamen as shall conceal themfelves.

GEORGE R. THEREAS We are informed, That great Numbers of Mariners and Sea-faring Men, Our natural-born Subjects, a e in the Service of divers Foreign Princes and States, to the Prejudice of Our Kingdom; We have therefore thought it necessary, by and with the Advice of Our Privy Council, to publish this Our Royal Proclamation; and do hereby strictly charge and command all Masters of Ships, Pilots, Mariners, Seamen, Shipwrights, and other Seafaring Men whatsoever and wheresoever, (being Our natural-born Subjects) who are in the Pay or Service of any Foreign Prince or State, or do ferve in any Foreign Ship or Verel, that forthwith they, and every of them, do (according to their known and bounden Duty and Allegiance) withdraw themselves, depart from, and quit such Foreign Services, and return Home to their Native Countries. And farther. We do hereby strictive prohibit and forbid all Masters of Ships, Pilots, Mariners, Seamen, Shipwrights, and other Seafaring Men whatsoever, (being Our Natural-born Subjects) from entering, and do charge and command them, and every of them, from henceforth, to forbear to enter themselves into the Pay or Service of any Foreign Prince or State, or to serve in any Foreign Ship or Vessel whatsoever, without Our Special Licence first had and obtained in that Behalf; to all which We expect due Obedience, and exact Conformity. And We do hereby publish and declare, That the Offenders to the Contrary shall not only incur Our just Displeasure, but be proceeded against for their Contempt according to the atmost Severities of the Law. And We do hereby declare, That if any such Masters of Ships, Pilots, Mariners, Scamen, Shipwrights, or other Seafaring Men, (being Our Subjects) shall be taken in any Foreign Service by the Turks, Algerines, or any others, they shall not be reclaimed by Us as Subjects of Great Britain. And We do hereby promife and declare, That a Reward of Two Pounds for every Able, and Thirty Shillings for every Ordinary Seaman, shall be paid any Person who shall discover any Seaman or Seamen, who may secrete themselves, that so such Seaman or Seamen shall be taken for Our faid Service by any of Our Sea-Officers employed for Railing Men, on or before the Thirty-first Day of December next; the faid Rewards to be paid for any Seaman or Seamen fo discovered and taken in and about London by the principal Officers and Commissioners of Our Navy; and at the Out Ports by the Naval Officers (where there are any); and where there are no Naval Officers, by the Collectors of Our Customs, immediately upon a Certificate being produced to the faid Principal Officers and Commissioners of Our Navy, Naval Officers, or Collectors respectively, by the Person who may make Discovery of any Seaman or Seamen as alorefaid, certifying his Name,

and the Name or Names and Number of Seamen procured in consequence of his Discovery; the said Certificate to be given by such Officer as may take fuch Seaman or Seamen for Our Service. Given at Our Court at St. James's the Eighth Day of November, One thousand seven hundred and seventy-six, in the Sixteenth Year of Our Reign.

By the KING, A PROCLAMATION,

For encouraging Seamen to enter themselves on Board His Majesty's Ships of War.

GEORGE R.

WHEREAS it is Our Royal Intention to give all due Encouragement to all such Seamen, who shall voluntarily enter them-selves in Our Service; We have thought sit, by and with the Advice of Our Privy Council, to publish this Our Royal Proclamation: And We do hereby promise and declare, That all such Able Scamen, not above the Age of Fifty, nor under the Age of Eighteen Years, fit for Our Service, who shall, on or before the 31st Day of December next, voluntarily enter themselves to serve in Our Royal Navy, either with the Captains or Lieutenants of Our Ships, or the Chief Officers on Board such Tenders as shall be employed for raising Men for the Service of Our Navy, shall receive, as Our Royal Bounty, the Sum of Five Pounds each Man; and all such Ordinary Scamen, fit for Our Service, who shall so enter themselves as afore-said, shall receive the Sum of Two Pounds Ten Shillings each Man, as Our Royal Bounty, in Lieu of all other Bounties mentioned in Our Proclamation dated the 22d Day of March last, and Our Orders in Council of the 1st of May, the 21st of June, and 21st of August folloving; such respective Sums to be paid them by the respective Clerks of the Cheque residing at the Ports or Places where the Ships, into which they shall be entered, shall be, immediately after the Third Muster of such Seamen: And We do declare, that the Qualifications of the Seamen so entering themselves as aforesaid, shall be certified by the Captain, Master, and Boatswain of the Ship or Vessel where they shall enter. And for Prevention of any Abuses by any Persons leaving the Vessels to which they shall belong, and entering themselves on Board any other Ships or Vessels, in order to obtain the said Bounty-Wioney; We do hereby Declare and Command, that fuch Seamen belonging to any of our Ships or Veffels, as shall absent themselves from any of the said Ships or Veffels to which they shall belong, and shall enter them-felves on Board any other of our said Ships or Vessels, in order to obtain the said Bounty, shall not only lose the Wages due to them in the Ships or Vessels they shall leave, but also be severely punished according to their

And His Majesty is hereby further pleased to order, that the said Embargo shall not extend to any Ship or Vessel actually retained or employed in His Majesty's Service, nor to any Ship or Vessel which shall be laden by the especial Order and under the Directions of the Lords Commissioners of His Majesty's Treasury, or the Lords Commissioners of the Admiralty, with any Kind of Provisions for the Use of His Majesty's Fleets or Armies. And the Right Honourable the Lords Commissioners of His Majesty's Treasury, and the Lords Commissioners of the Admiralty, are to give the necessary Directions for carrying the same into Execution, so far as to them shall respectively apper-G. Chet wynd. tain.

AT the Court at St. James's, the 25th Day of October, 1776, PRESENT,

The King's Most Excellent Majesty in Council-Whereas His Majesty was pleased, by His Order in Council of the 26th of January last, to lay an Embargo upon all Ships and Vessels laden or to be laden in the Ports of the Kingdom of Ireland with Provisions of any Kind (except as therein excepted). And whereas His Majesty was pleased, by another Order in Council of the 14th of February following, to declare, That the said Embargo should not extend to Coin

or Grain of any Kind: And whereas it hath been. represented, that the said Embargo hath in many Instances been evaded - It is hereby ordered by His Majesty in Council, that an Embargo be forthwith laid upon all Ships and Vessels laden or to be laden in any of the Ports of the Kingdom of Ireland with Black Cattle and Hogs, Beef, Pork, Butter, and Cheefe, or any Sort of Provisions, except Fish, Corn, or Grain of any Kind, or Pulse; and that the faid Embargo do continue and remain upon such Ships and Vessels till further Order: But it is Majesty's Pleasure, that the said Embargo do not extend to Ships or Vessels bringing Cattle of any Kind, Salted Beef, Pork, Bacon and Butter from Ireland into this Kingdom, pursuant to the Liberty granted for that Purpose by an Act passed in the last Session of Parliament; nor to any Ship or Vessel that shall be employed in carrying Pro-visions to any of His Majesty's West India Islands, or to any of His Majesty's Colonies in North America, (except the Colonies of New Hampshire, Massachusets Bay, Rhode Island, Connecti-cut, New York, New Jersey, Pensylvania, The Three Lower Counties on Delaware, Maryland, Virginia, North Carolina, South Carolina, and Georgia) or to His Majesty's Forts and Settlements on the Coast of Africa, or to the Island of St. Helena; provided that the Owners of such Ships and Vessels do make Oath, on the Entry of such Ships and Vessels, of the due Destination thereof to the Place for which such Ships and Vessels shall be so entered to clear out as aforesaid, and do give Security by Bond to the proper Officers of the Customs. at the Port at which such Ships and Vessels shall enter and clear out, with two other able and fufficient Securities, in treble the Value of the Cargo of such Provisions, for the Performance of the Conditions therein specified; and do thereby engage that such Ships and Vessels shall proceed under Convoy of one of His Majesty's Ships, and shall not defert their Convoy on their Voyage; and likewife to produce, within Twelve Months from the Date of such Bond, from the proper Officer of the Customs at the Port to which such Ships or Vessels shall go, Certificates of their having delivered their Cargoes at the Places for which they shall have been enrered; and no such Bonds or Securities shall be delivered up before the Production of such Certificates. And His Majesty is hereby further pleased to order, That the faid Embargo shall not extend to any Ship or Vessel actually retained or employed in His Majesty's Service, nor to any Ship or Vessel which shall be laden by the especial Order, and under the Directions, of the Lords Commissioners of His Majesty's Treasury, or of the Lords Commisfioners of the Admiralty, with any Kind of Provi-fions for the Use of His Majesty's Fleets and Armies - And His Excellency Earl Harcourt, Lord Lieutenant of His Majesty's Kingdom of Ireland, is to give the necessary Directions for causing the faid Embargo to be strictly observed in that King-G. Chetwynd.
