AT the Court at St. James's, the 5th of November,

PRESENT,

The KING's Nicht Excellent Majesty in Council. THEREAS the Time limited by His Majesty's Order in Council of the 7th of May last, prohibiting the transporting into any Parts out of this Kingdom any Pot-Ash or Pearl-Ash (except as In the said Order is mentioned) will expire upon the 7th Day of this instant November: And whereas it is judged expedient that the faid Prohibition should be continued for some Time longer; His Majesty doth therefore, with the Advice of His Privy Council, hereby order, require, prohibit and command, that no Person or Persons whatsoever do, at any Time during the Space of Six Months from the Date of this Order in Council, export or attempt to export, transport, carry or convey, or lade or lay on Board of any Ship, Vessel or Boat, in order to be exported, etransported, carried or conveyed out of this Kingdom, any Pot-Ash or Pearl Ash, without Leave or Permission being first had and obtained from His Majesty for His Privy Council, upon Pain of incurring the Forfeitures inflicted by an A& passed in the last Session of Parliament, intituled, " An Act for in-66 demnifying all Perfons who have been concerned " in advising or carrying into Execution an Order of the Lords Commissioners of His Majesty's 44 Treasury respecting the Exportation of Pot Ashes " or Pearl-Asses; for preventing Suits in con-" sequence of the same; for authorizing His Ma-31 jesty to prohibit the Exportation or carrying "Coasswife of Pot-Ashes or Pearl-Ashes, and for

" making further Provisions relative thereto." But it is nevertheless His Majesty's Pleasure that nothing herein contained shall extend, or be confirmed to extend, to the Exportation of the faid Articles to Ireland, or to His Majerty's Islands of Guerasey, Jersey, Alderney, Sark or Man, or to His Majesty's Colonies or Plantations in America or the West Indies, or to Newfoundland, or to His Majesty's Forts and Settlements on the Coast of Africa, or to the Island of St. Helena, or to the British Settlements or Factories in the East Indies: provided that, upon the Exportation of the faid Articles to Ireland, or to His Majesty's Islands of Guernfey, Jersey, Alderney, Sark or Man, or to His Majesty's Colonies and Plantations in America or the Well Indies, or to the Island of Newfoundland, or to His Majesty's Forts and Settlements on the Coast of Africa, or to the Island of St. Helena, or to the British Settlements or Factories in the East Indies, the Exporters of the faid Articles do fira make Oath of the true Destination of the same to the Places for which they shall be entered Outwards, before the Entry of the same shall be made, and do give full and sufficient Security, by Bond, to the Satisfaction of the Commissioners of His Majesty's Customs, to carry the faid Articles to the Places for which they are fo entered Outwards, and none other; and fuch Bond shall not be cancelled or delivered up until Proof be made, to the Satisfaction of the faid Commissioners, by the Production, within a Time to be fixed by the faid Commissioners, and specified in the Bond, of a Certificate or Certificates, in such Form and Manner as shell be directed by the

faid Commissioners, shewing that the said Articles have been duly landed at the Places for which they were entered Outwards. And the Right Honorable the Lords Commissioners of His Majesty's Treasury, the Commissioners for Executing the Office of Lord High Admiral of Great Britain, and the Lord Warden of the Cinque Ports, are to give the necessary Directions herein, as to them may respectively appertain.

#### London, November 11.

On Saturday last Thomas Skinner, Esq; Lord Mayor Elect for the Year ensuing, was sworn at Guildhall; when the Chair and other Ensigns of Mayoralty were furrendered to him in the accustomed Manner.

Yesterday the new Lord Mayor, accompanied by the late Lord Mayor, the Aldermen, Recorder and Sheriffs, in their Scarlet Gowns, went in their Coaches to the Water-fide, the Sword and Mace being carried before them, and the City Officers attending; and from thence proceeded in the City Barge, attended by the several Companies in their respective Barges, adorned with Streamers and Pendants, to Westminster; and having walked round the Hall, and solemnly saluted all the Courts, they went to the Exchequer Bar, and the new Lord Mayor did there take the Oaths appointed; and having re-corded Warrants of Attorney in the proper Courts, returned by Water to Black Friars, and from thence in Coaches, with the usual Solemnity, to Guildhall, where a magnificent Entertainment was provided; at which were present several of the Foreign Ministers, the Great Officers of State, divers of the Nobility, Lords of His Majesty's Most Honourable Privy Council, the Judges, and many other Persons of Quality and Distinction.

#### Dublin Cafile, November 5.

Yesterday being the Anniversary of the Birth of the late King William the Third, of Glorious Memory, in the Morning the Flag was displayed on Bedford Tower; at Noon there was a splendid Appearance of the Nobility and other Persons of Dissinction at the Castle, to compliment his Excellency the Lord Lieutenant; after which his Excellency, attended by the Nobility and Gentry, and escorted by a Squadron of Horse, went in Procession round the Statue of King William. On his Excellency's Return to the Castle the Great Guns at the Salute Battery in His Majesty's Park the Phoenix were fired Three Rounds, and answered by Vollies from the Regiments in Garrison, which were drawn up in College Green. And at Night there were Bonsires, Illuminations, and other Demonstrations of Joy.
