AT the Court at St. James's, the 13th of February,

PRESENT

The KING's Most Excellent Majesty in Council. HEREAS by an Act, passed in this present Sellion of Parliament, intituled, " An Act for enabling His Majesty to prohibit the Exporta-" tion and permit the Importation of Corn, and " for allowing the Importation of other Articles of er Provision for a limited Time without Payment of " Duty," it is enacted, That from and after the passing of the said Act, and until the Expiration of Six Weeks from the Commencement of the next Session of Parliament, it shall and may be lawful for His Majesty, His Heirs and Successors, and he and they is and are thereby authorized, with the Advice of His or Their Privy Council, whatever may be the general Average Pilce of Wheat, Rye, Bar ley, Beer or Bigg, Peufe, Reans, Oats or Oatmeel, in England or Scotland respectively, from Time to I ime, when and as often as the same shall be judged expedient, to prohibit generally, for a limited l'inie; the Exportation from England and Scotland respectively of any British or Foreign Wheat, Rye, Barley, Beer or Bigg, Peafe, Beans, Oats, or any Meal or Flour, or Bread, Biscult or Malt made thereof, or any Indian Corn or Maize, or Meal or Flour made thereof, and to permit generally the Importation into England or Scotland respectively of any Foreign Corn or other Articles as aforefaid, in any British Ship or Vessel, or in any other Ship or Vessel be-Imaing to Perfons of any Kingdom or State in Amity with His Majesty, and navigated in any Manner whatever, without Payment of any Duty whatfoever; and also the taking out of Warthouse

for Home Confumption, of any fuch Foreign Corn or other Articles as aforefaid, without Payment of any Duty whatfoever; and in like Manner to recal fuch Prohibition or Permission, either in Part or in the Whole, if Circumstances shall appear so to require, any Thing in an Act, pa.Ed in the 31ft Year of His present Majesty's Reign, insituled, "An Act for regulating the Importation and E.:portation of Corn, and the Payment of the Duty " on Foreign Corn imported, and of the Bounty on " British Corn exported," and ano her Act passed in the 33d Year of His present Majesty's Reign, for amending the aforefaid'Act, or in any other Act, or Part of any Act, to the contrary notwithstanding, subject, nevertheless, to the Provisoes therein mentioned, and herein after contained.

His Majesty thereupon, by and with the Advice of His Privy Council, pursuant to the Powers given by the said Act, passed in this present Session of Parliament, has thought set to order, and it is hereby ordered, that from and after the Date of this present Order, until the 50th Day of September next, no Person or Persons whatseever shall export, or shall load or lay on Board any Ship or other Vessel, with the Intent to export from any Port or Place of this Kingdom, any Wheat, Rye, Barley, Beer or Bigg, Pease, Beans, Oats, Indian Corn or Maize, or any Meal or Flour, or Bread, Biscuit or Masternale thereof.

His Maj sty, nevertheless, by the Advice aforesaid, hath thought sit to order, and it is hereby ordered, that nothing herein contained shall extend, or be construed to extend, to prohibit the Exportation from this Kingdom of any Foreign Corn, Mual or Flour that shall have been imported and warehoused in the

Manner and on the Conditions mentioned in the be-. fore mentioned Act passed in the Thirty-first Year of ! His present Majesty's Reign, and shall not have been taken out of fuch Warehouse for Home Consumption, nor to prevent the carrying Coastwife, or carrying out, or the Exportation of the several Sorts of Corn, or other Articles as aforefaid, from this Kingdom, for any of the Purposes mentioned in the said Two Acts, passed in the Thirty-sirst and Thirty-third Years, of His present Majesty's Reign, or either of them, in like Manner, and in the fame Proportions and Quantities, and from and to the fame Ports and Places, as is allowed by the faid Two Acts passed in the 31st and 33d Years of His present Majesty's Reign, or either of them, at fuch Times as any of the feveral Sorts of Corn, or other Articles as aforefaid, are prohibited to be exported, in consequence of the Provisions contained in the faid Two Acts, subject to the like Securities, Conditions, Regulations and Restrictions, Forseitures and Penalties, as are by the faid Two Acts, or by either of them, in any such Case, required or imposed.

And His Majesty, by and with the Advice aforefaid, hath thought fit further to order, and it is hereby ordered, That from and after the Date of this present Order, until the 30th Day of September next, it shall be lawful to import into any Port or Place of this Kingdom, any Foreign Corn or other Articles as aforefaid, in any British Ship or Vessel, or in any other Ship or Vessel, belonging to Persons of any Kingdom or State in Amity with His Majesty, and navigated in any Manner whatever, without Payment of any Duty whatfoever, and also to take out of Warehouse, for Home Consumption, any such Foreign Corn or other Articles as aforefaid, without Payment of any Duty whatfoever.

And the Right Honorable the Lords Commissioners of His Majesty's Treasury are to give the necessary Directions herein accordingly.
