I BEG you will please to acquaint the Lords Commissioners of the Admiralty, that on the 10th Instant, (Scilly per Account bearing N. E. Distance Lighteen or Twenty Leagues) I fell in with and cap-tured L'Afpic, French National Cutter, of Ten Guns and Fifty-feven Men, and brought her in here. She had been Ten Days from St. Maloes, and had captured the John Sloop, of and from Galway, for Oporto.
