Extract of a Letter from the Earl of St. Vincent, K. B. Admiral of the White, Sc. to Evan Nepean, Efq; dated in Torbay the 27th Ultimo.

I Enclofe, for the Information of the Lords Com-I. millioners of the Admiralty, a Letter which I have received from Captain Sir Richard Strachan, giving an Account of the Boats of His Majelty's Ships and Veffels employed under his Orders hav-ing deftroyed a French Corvette and Two Merchant Veffels.

MY LORD, Captain, at Sea, Nov. 18, 1800. VOUR Lordship will perceive in the Narrative I of my Proceedings, that a Convoy of the Enemy had got through the Teignouse Passage Yelterday, and that I was endeavouring to intercept them from the Morbihan, or Paffage along the Coalt, I had the Mortification in the Morning to perceive that the greater Part had got into the Morbihan; and that the others at the Entrance were only waiting the Tide, protected by the Batteries on each Side, and a Ship Corvette of Twenty Guns, the Commodore of the Convoy. By the skilful Management of the Nile Cutter, the furst Vessel up, under the Command of Lieutenant Arglès, the Corvette was kept from the North Shore ; and foon after, upon the Magicienne getting near her, she ran into Port Navale, where she took the Ground, and her People began to quit her, and her Colours were litrick; the Boats of the Magicienne, under Lieu-tenant Skottowe, and Rodney, attempted to board, but the Corvette fired upon them, having reholfted her Colours, and making Sail, ran farther into the Port : the Magicienne recalled her Boats; but Lientenant Rodney gallantly took a Merchant Veffel from under one of the Batteries as he was returning. As foon as I could get the Boats out I fent them all to be under the Orders of Captain Ogilvy, with Directions for them to be fent under the Orders of the Schoor Officer of this Ship, Lieutenant Hennah, to destroy the Corvette, having under his Orders Lieutenant Clyde of this Ship, and Lieutenant Clark of the Marlborough; and the Boats were manned by the Captain and Marlborough's Men. The Enterprize was conducted with great Ability by Lieutenant Hennah, who, not-

withstanding a heavy Fire from the Shore on all Sides, bravely boarded the Corvette, and having fet Fire to her, the foon after blew up. He speaks in high Terms of Commendation of those under his Orders; and I admire the Spirit that pervaded all the Officers and Men employed upon this Occasion : no Prisoners were taken; and the Conduct of Cap-tain Ogilvy in the Guidance and Management of the Magicienne; by drawing the Fire of the Bat-teries from the Boats, contributed to the Service being effected with very little Lofs.
