Admiralty Office, August 25, 1801. Copy of a Letter from Lord Viscount Nelson, K. B. Vice-Admiral of the Blue, &c. to Evan Nepear, Efq; dated Downs, the 23d Inflant.

SIR,

HErewith I transmit you a Letter which I have received from Captain Rose, giving me an Account of the Boats of the several Vessels under his Orders having burnt a Quantity of Pitch, Far, and Turpentine, destroyed Three Gun Boats, taken Two Launches, and a Flat Boat about Fortyfive Feet long, and Eighteen or Twenty Feet Wide, mounted with One Brass Eight Inch Howitzer; this Boat suik aftern of the Hound. The Business on the Part of our Boats was conducted with much Spirit; and much Praise is due to Lieutenant Agassiz, of the Hound, and Lieutenant L. Vescont, of the Jamaica, for their brave Example on this Occasion.

The Jamaica, at Sea, MY LORD, Angust 21, 1801.

J.Beg Leave to acquaint you, that Yesterday Evening, at Eight o'Clock, being at Anchor off Estaples, I observed a large Fire to the S. S. E., and at the fame Time a very heavy Cannonade. I immediately got under Weigh with the Veffels under my Orders, and ran down to it. About Ten I spoke Captain Sanadine, of the Hound, who informed me that the Fire proceeded from a Cargo of Pitch and Tar, belonging to a Veffel wrecked on the Coaft fome Time ago, which the Boats of the Hound and Mallard had fet Fire to; and that Six Elat Boats had come out of Saint Vallery that Afternoon, which he forced on Shore, and then lay hauled upon the Beach.

I accordingly this Morning fent the Boats of the Jamaica, Gannet, and Hound, together with those of the Gun-Brigs, and endeavour to cut them out, under the Direction of Lieutenant James Agassiz, of the Hound; at the same Time flanding in with the different Vessels, in order to cover the Boats from the Eire of the Military and Five Field Pieces, posted behind the Sand Hills on Shore.

I am happy to acquaint your Lordship that they succeeded in bringing off Three; the others had been previously scuttled, so as to render it impossible to remove them; however the Boats damaged them as much as the Time would admit of.

I cannot fufficiently praise the Gallantry and Zeal of Lieutenant Agassiz, of the Hound, and Lieutenant L. Vescont, of the Jamaica, with the Officers and Mer employed on this Service.

PROCLAMATION FOR PARDONING DESERTERS.

War-Office, August 4, 1801.
WHEREAS it has been represented to the King, that there are at this Time feveral Deserters from the different regular Corps in His Majesty's Land Service, who might be induced to return to their Duty by an Offer of His Majesty's gracious Pardon, and that such an instance of His Royal Clemency would have a due Instance upon their future Behaviour: His Majesty has been graciossily pleased to grant his Free Pardon to all Deferters from his regular Land Forces, who shall furrender themselves, on or before the roth Day, of September next, to the Commanding Officer of any Regiment, or to any of the Superintending Field Officers of the Recruiting Service, whole

Stations are mentioned in the Margin; hereof, or to the Inspector General of the Recruiting Service in the Isle. Winchester.

Such Deserters, if able-bodied Men, and fit for Service, shall be sent Hereford. Bedford. Ipfwich. Maidflone. to the Regiments from which they respectively deserted, or he appointed to such Regiments as His Majesty. Nottingham. may be pleased to command; and, Birmingham. when fo placed, shall not be liable to Shrewfbury. be claimed by any other Comps to which they may formerly have be-Manchester. · longed.

And whereas many of the faid Deferters may have enlifted in other regular Corps, and are now ferving therein, His Majesty is graciously pleased to extend to such Deserters the Benefit of this Pardon; and to direct, that they shall continue to

ferve in the Corps wherein they now are, without being under the Necessity of declaring themselves Deferters, in order to entitle them to the Benefit of this Pardon; and they shall not be liable, at any future Time, to he claimed by the Regiments in which they formerly ferved: But this Claufe is not to extend to Deferters enlifted by the Corps raising Recruits for General Service; which Deferters are only to be entitled to their Pardon on declaring themselves in the Isle of Wight to be such, and being there transferred to some established Regi-

Any Soldier who may defert after these His Majesty's gracious Intentions are made public, shall not be included in the above Pardon, but be proseeded against with the utmost Severity.

TO OFFICERS ON HALF-PAY.

War-Office, August 1, 1801. LL Officers on the Half-Pay of the Land Forces, relident in Great Britain and Ireland, who are not ferving in the Militia, or who do not hold Offices under Government, are hereby required immediately to transmit to the General Officers commanding in the Districts within which they respectively reside, an Account, in Writing, of their Age, palt Services, and prefent Place of Abode, in order that their Services may be called for as Circumstances shall reader it expedient: And fuch as think theinfelves, from Age or Infirmities, unfit for further Service even in this Country, are to accompany their Reports with fufficient Vouchers of their Inability, and the Caufes thereof.

Such Officers on Half-Pay as are ferving in the Militia, or are otherwise employed under Government, (Officers of the Yeomanny and Volunteer Corps excepted, whose Reports are to be made to the Generals commanding in Districts as above mentioned,) are to transmit similar Accounts to the Secretary at War, specifying also the Nature of the

Public Situations which they possels,

The General Officers commanding in Diffricts will make Returns to the Secretary at War of the Names of the Officers who final report themselves in pursuance of the above Notice. And every Officer who shall neglect to make his Report, either to the Commander of a District or to the Secretary at War, according to the Circumstances of his Situation, within One Month from the Date hereof, will be confidered as otherwife provided for, or dead, and his Name will be struck off the Half-Pay List ac-By His Majeffy's Command, C. NEW STAMP DUTIES ON DEEDS. &c.
