JE, taking into Our most ferious Confideration the just and necessary War in which We are engaged, and putting Our Trust in Almighty God, that he will graciously bless our Arms, both by Sea and Land, have refolved, and do, by and with the Advice of Our Privy Council, hereby command, that a publick Day of Faling and Humiliation, be observed throughout those Parts of Our United Kingdom called England and Ireland, on Wednesday the Twenty-fixth Day of February next ensuing, that fo both We and Our People may humble Ourfelves before Almighty God, in order to obtain Pardon of Our Sins, and in the most devout and dolemn Manner fend up Our Prayers and Supplications to the Divine Majesty, for averting those heavy Judgments which Our manifold Provocations have molt. justly deferved; and for imploring his Bleffing and Affillance on our Arms for the Restoration of Peace, and Prosperity to Us and Our Dominions: And We do flrictly charge and command, that the faid publick Fast be reverently and devoutly observed by all our loving Subjects in England and Ireland, as they tender the Favour of Almighty God, and would avoid his Wrath and Indignation; and upon Pain of such Punishment as We may justly instict on all such as contemn and neglect the Performance of fo religious and necessary a Duty: And for the better and more orderly folemnizing the same, We have given Directions to the Most Reverend the Archbishops, and the Right Reverend the Bishops of England and Ireland to compose a Form of of England and Ireland, to compose a Form of Prayer suitable to this Occasion, to be used in all Churches, Chapels, and Places of publick Worship, and to take Care that the same be timely dispersed throughout their respective Dioceses.

E, taking into Our most serious Consideration VV the just and necessary War in which We are engaged, and putting Our Trust in Almighty Cod, that he will graciously bless Our Arms both by Sea and Land, have refulved, and do, by and with the Advice of Our Privy Council, hereby command, that a publick Day of Fasting and Humiliation be observed throughout that Part of Our Kingdom of Great Britain called Scotland, on Thursday the Twenty-seventh Day of February next ensuing, that so both We, and Our People may humble Ourselves before Almighty God, in Order to obtain Pardon of Our Sins, and in the most devout and solemn Manner fend up Our Prayers and Supplications to the Divine Majesty for averting those heavy Judgments which Our manifold Provocations have most justly deserved, and for imploring His Blessing and Assistance on Our Arms, for the Restoration of Peace and Prosperity to Us and Our Dominions; and We do strictly charge and command, that the faid publick Fast he reverently and devoutly observed by all Our loving Subjects in Scotland, as they tender the Favour of Almighty God, and would avoid His Wrath and Indignation; and upon Pain of such Pouisimment as We may justly instict on all such as contemn and neglect the Performance of so religious and necessary a Duty.—Our Will is, therefore, and We charge, that this Our Proclamation seen, Ye forthwith proceed to the Market Cross of Edinburgh, and all other Places needful, and there, in Our Name and Authority, make Publication in Our Name and Authority, make Publication hereof, that none pretend Ignorance; and Our Will and Pleasure is, that Our Solicitor do cause printed Copies hereof to be sent to the Sheriffs of the several Shires, Stewarts of Stewartries, and Bailiffs of Regalities; and their Clerks, whom We ordain to see the same published; and We do appoint them to send Copies hereof to the several Parish Churches within their Bounds; and that upon the Lord's Day immediately preceding the Day above mentioned, the same may be published

and read from the Pulpits immediately after Divine fuch Seaman or Seamen respectively, who might conceal him or themselves, so that such Seaman or

PRESENT,

The KING's Most Excellent Majesty in Council.

HEREAS His Majesty was graciously pleased, by His Royal Proclamation, bearing Date the Sixteenth Day of May One thousand eight hundred and three, to promife and declare, that the Bounties of Five Pounds for every able Seaman, and Two Pounds Ten Shillings for every ordinary Seaman fit for His Majelly's Service should be paid, in the Manner thereby directed, to every fuch able and ordinary Scaman, not above the Age of Fitty nor under the Age of Twenty Years, who should on or before the Thirtieth Day of June then following, enter themselves to serve in His Majesty's Royal Navy, either with the Captains, or Lieutenants of His Majesty's Ships, or Vessels, or Officers employed on Shore for raifing Men for the Service of the Royal Navy: And whereas His Majesty was also graciously pleased by his said Proclamation to declare, that all able bodied Landmon not above the Age of Thirtyfive, nor under the Age of Twenty Years, who should fo enter themselves as aforesaid, thould receive the Sum of Thirty Shillings each Man, as His Majesty's Royal Bounty: And whereas His Majesty was also gracioufly pleafed, by His Royal Proclamation bearing Date the Seventh Day of March One thousand eight hundred and three, to promife and declare, that a Reward of Twenty Shillings for every able and ordinary Seaman, fit to serve on board His Majesty's Ships, should be paid to any Person who should discover any Seaman or Seamen who might conceal him, or themselves, so that such Seaman or Seamen should be taken for His Majesty's Service by any of His Majesty's Sea Officers employed for raising Men, on or before the Thirtieth Day of April then next : And whereas the Time limited by the faid Proclamation for Payment of the faid Bounties and Reward hath, by Order in Council, been prolonged and extended to the Thirty first Day of December last: And whereas His Majesty was graciously pleased by His Royal Proclamation bearing Date the Seventh Day of November lalt, to promife and declare that all able bodied Landmen for entering themselves to serve in His Majelly's Royal Navy, on or before the said Thirty first of December last should be entitled to receive the faid Bounty of Thirty Shillings each Man, upon Proof being exhibited that such able-bodied Landmen were not above the Age of Thirty-five, nor under the Age of Eighteen Years; and that a Reward of Three Pounds for every able Seaman and Fifty Shillings for every ordinary Seaman fit to serve on board His Majesty's Ships should be paid in the Manner directed hy His Majesty's Royal Proclamation, bearing Date the Sixth Day of February One thousand eight hundred and five, to any Person who should discover

conceal him or themselves, so that such Seaman or Seamen might be taken for His Majesty's Service by any of His Majesty's Sea Officers employed for railing Men on or before the Jaid Thirty-first Day of December last: And whereas by the said aboverecited Proclamation, bearing Date the Seventh Day of November Taft, His Majesty was further pleased to promise and declare, that a Reward of Four Guineas for every able Seaman, Three Guineas for every ordinary Seaman, and Two Guineas and a Half for every Landman should be paid to any Person or Persons who might, on or before the said Thirty-first Day of December last, inclusive, procure the voluntary Service of, and convey fuch able Seaman or Landman fit for His Majesty's Service, on board any of His Majesty's Ships or Vessels. or to any of His Majefty's Sea Officers employed in raifing Men, together with an Allowance at the Rate of One Penny per Mile for each able Seaman, ordinary Seaman, and Landman, for every Mile they might respectively travel to the nearest of His Majelly's Ships of War, or nearest Place of Residence of any of His Majesty's Sea Officers employed in raifing Men, (provided such Man should be su for His Majesty's Service, and there should not be Reason to suppose, that he was an Apprentice,) the faid Rewards and travelling Allowance, to be paid in the Manner directed by the faid Proclamation: And whereas the Time limited for Payment of the faid Bounties, Rewards and travelling Allowance, has expired; and it is expedient that the Payment thereof fince the Thirty first of December last should be confirmed and approved, and that fuch Payment should be still further continued for some Time longer, His Majesty, with the Advice of His Privy Council, doth therefore order, and it is hereby accordingly ordered, that the Payment of the faid Bounties, Rewards and travelling Allowance made fince the Thirty-first Day of December last, be confirmed, and approved; and that the like Payment be further made and continued from the Date hereof until the Thirty-first Day of December next inclusive, whereof all Persons concerned are to take Notice and govern W. Fawkener. themselves accordingly.

The KING's Most Excellent Majesty in Council, IN HEPEAS the Time limited by His Majesty's Order in Council of the Twentieth Day of June One thousand eight hundred and five, prohibiting the transporting into any Parts out of this Kingdom of any Pig-Iron, Bar Iron, Hemp, Pitch, Tar, Rosin, Turpentine, Anchors, Cables, Cordage, Masts, Yards, Bowsprits, Oars, Oakum, Oker, Sheet-Copper, or other Naval Stores, expired upon the Eleventh Day of this instant January: And whereas it is judged expedient for His Majesty's Service, and the Sasety of this Kingdom, that the faid Prohibition should be continued for some Time longer, His Majesty doth therefore, with the Advice of His Privy Council, hereby order, require, prohibit, and command, that no Person or Persons whosoever do at any Time, for the Space

of Six Months, from the said-Eleventh Day of this instant January, presume to transport into any Farts out of this Kingdom any Pig-Iron, Bar-Iron, Hemp, Pitch, Tar, Rofin, Turpentine, An-chors, Cables, Cordage, Mails, Yards, Bowsprits, Oars, Oakum, Oker, Sheet Copper, or other Naval Stores, or do ship of lade any Pig-Iron, Bar-Iron, Hemp, Pitch, Tar, Rosin, Turpentine, Anchors, Cables, Cordage, Masts, Yards, Bowsprits, Oars, Oakum, Oker, Sheet Copper, or other Naval Stores, on board any Ship or Vessel, in order to transporting the sume into any Parts beyond the Seas, without Leave or Permission first being had and obtained from His Majeffy or His Privy Council, upon Pain of incurring the Forfeitures inflicted by an Act passed in the Thirty-third Year of His Majesty's Reign, intiruled " An Act to enable His Majelty " to reflrain the Exportation of Naval Stores, and " more effectually to prevent the Exportation of " Salt-Petre, Arms, and Ammunition, when pro-" hibited by Proclamation or Order in Council:" But it is nevertheless His Majelty's Pleasure, that nothing herein contained shall extend, or be conthrued to extend, to any of His Majelly's Ships of War, or any other Ships or Veffels or Boats in the Service of His Majelly, or employed or freighted by His Majelly's Board of Ordnance, or by the Commissioners of His Majesty's Navy; nor to prevent any Ship or Vessel from taking or having on board fuch Quantities of Naval Stores as may be necelfary for the Use of such Ship or Vessel during the Course of her intended Voyage, or by Licence from the Lord High Admiral of Great Britain, or the Commissioners of the Admiralty for the Time being; nor to the Exportation of the said several Articles to Ireland, or to His Majesty's Yards or Garrisons, or to His Majesty's Colonies or Planta-tions in America or the West Indies, or to Newfoundland, or to His Majesty's Forts and Settlements on the Coast of Africa, or to the Island of St. Helena, or to the British Settlements or Factories in the East Indies: Provided that upon the Exportation of any of the faid Articles for the Purposes of Trade to Ireland, or to His Majesty's Yards and Garrisons, or to His Majesty's Colonics and Plantations in America or the West Indies, or to the Island of Newfoundland, or to His Ma jesty's Forts and Settlements on the Coast of Africa, or to the Island of St. Helena, or to the British Settlements or Factories in the East Indies, the Exporters of fuch Articles do first make Oath of the true Defination of the same to the Places for which they shall be entered outwards, before the Entry of the fame shall be made, and do give full and sufficient Security, by Bond, to the Satisfaction of the Commissioners of His Majesty's Customs, to carry the faid Articles to the Places for which they are to entered Outwards, and for the Purpofes specified, and none other; and such Bond shall not be cancelled or delivered up until Proof be made to the Satisfaction of the faid Commissioners, by the Production, within a Time to be fixed by the said Commissioners, and specified in the Bond, of a Certificate or Certificates, in such Form and Manner as shall be directed by the said Commishoners, shewing that the faid Articles have been all duly landed at the Places for which they were en-tered Outwards: And the Right Honorable the Lords Commissioners of His Majesty's Treasury,

the Commissioners for executing the Office of Lord High Admiral of Great Britain, and the Lord Warden of the Cinque Ports; are to give the necessary Directions herein as to them may respectively appertain.

HEREAS it has been represented to His Majesty at this Board, that the Infectious Disorder which some Time since raged within the States of Pennsylvania and New York, within the United States of America, has totally ceased; His Majesty, taking the same into Consideration, and being desirous to remove all Restraint upon Trade so far as may be consistent with the Safety of His Subjects, is pleased, by and with the Advice of His Privy Council, to order, as it is hereby ordered, that the Quarantine laid by His Order in Council of the Seventh Day of November last, upon all Ships, Persons, Goods, and Merchandizes which had arrived, or which should thereafter arrive in any of the Ports of this Kingdom, or the Isles of Guernfey, Jersey, Alderney, Sark, or Man, from any of the Ports in the States of Pennsylvaniaor New York, be taken off; and that all fuch Ships and Veffels be permitted to discharge their respective Ladings without unpacking, opening, and airing, and without performing Quarantine, as freely as they might have done in case such Order of the Seventh Day. of November last, had not been made, any Thing in the faid Order contained to the contrary notwithstanding; provided such Ships and Vessels shall have failed from the Ports in the States of Pennsylvania or New York, subsequent to the Third Day of November last, and that none of the Crew of other Persons on board shall have died, or been sick with the faid Fever, during the Course of the Voyage: And the Right Honorable the Lords Commissioners of His Majesty's Treasury, the Commissioners for executing the Office of Lord High Admiral of Great Britain, the Lord Warden of the Cinque Ports, the Lieutenant-General, and the Reft of the Principal Officers of the Ordnance, His Ma. jesty's Secretary at War, and the Governors or Commanders in Chief for the Time being of the said respective Isles of Guernsey, Jersey, Alderney, Sark, and Man, are to give the necessary Directions herein, as to them may respectively appertain. HAVE the Honor to acquaint you, for the Information of the Commander in Chief, that outstanding close in with the high Land, near Folk-stone, Yesterday Morning about Two o'Clock, (being hazy,) a Lugger was observed hovering about with an Intent (as I have been fince informed,) to board, but on finding her Miltake, and His Majesty's Brig bearing up, made all sail; she was captured after a Chace of Seven Hours, during which they have most of their Gun Carriages, Stores, and Provisions overboard. She proves to be the Impromptú French Privateer, of Boulogne, (last from Calvis,) commanded by Jaques Sauvage, with a Complement of Fifty Men, Fitteen Guns, Two only of which were mounted when captured; and she is a remarkable fine Veffel; and I am informed, the belt Sailer from that Port; might have been a great Annoyance to the Trade. Last Week she captured Two Brigs, the Mary of Pool, laden with Coals, and the Caroline of Yarmouth, laden with Barley.
