THIS Day, about Twelve o'Clock, departed this Life, at Windfor, after a long and painful Illness, Her Royal Highness the Princess Amelia, His Majesty's youngest Daughter, to the great Grief of all the Royal Family.

AT the Council Chamber Whitehall, the 4th of October 1810.

PRESENT, The Lords of His Majesty's Most Honourable Privy Council.

HEREAS by an Act passed in the Forty-fifth Year of His Majesty's Reign, intituled "An Act for making further Provision for the effectual Performance of Quarantine;" it is among other Things enacted, that it shall and may be lawful for the Lords and others of His Majesty's Privy Council, or any Three or more of them, to make fuch Order as they shall see necessary and expedient, upon any unforeseen Emergency, or in any parti-cular Case or Cases with respect to any Ship or Ships, Vessel or Vessels arriving, and having any infectious Disease or Distemper on board, or on board of which any infectious Difease or Distemper may have appeared in the Course of the last Voyage, or arriving under any other alarming or suspicious Circumstances, as to Infection; although fuch Ship or Ships, Vessel or Vessels shall not have come from any Place or Places from which His Majesty, His Heirs or Successors, by and with the Advice of His or Their Privy Council, may have adjudged and declared it probable that the Plague or any fuch infectious Disease or Distemper may be brought; and also with respect to the Persons, Goods, Wares, and Merchandize on board the fame; and all fuch Orders so made by the Lords or others of the Privy Council, or any Three or more of them as aforesaid, shall be as good, valid, and effectual to all Intents and Purpoles (as well with respect to the Commander, Maiter, or other Person having the Charge of any fuch Ship or Vessel, and all other Persons on board the same, as with respect to any other Persons having any Intercourse or Communication with them, and to the Penalties, Forseitures, and Punishments to which they may respectively become liable, as any Order or Orders made by His Majetty, His Heits or Successors, by and with the Advice of His or Their Privy Council concerning Quarantine, and the Prevention of Insection as aforesaid, and notified by Proclamation, or published in the London Gazette.

And whereas Advices have been received that the Yellow Fever has raged with great Malignity at the Havannah, and has proved fatal in many Instances, and that several trading Vessels from thence have been detained in the Quarantine Ground in the River Delaware, within the United States of America, being in a fickly Condition, or having lost some of their Passengers or Crew on their Passege thither: It is hereby ordered in Council, that all Ships and Vessels coming directly or circuitously from, or having touched at the Havannah, or any other Port in the Island of Cuba, or having received any Person or Persons, Goods, Wares, or Merchandize, Packets, Baggage, Wearing Apparel, Books, Letters, or any other Articles whatever, from out of any fuch Ship or Vessel, shall, on their Arrival on the Coasts of this Kingdom, or of the Isles of Guernsey, Jersey, Alderney, Sark, and Man, come to Anchor at fuch Place or Places as have been or shall be appointed by the Commissioners of His Majesty's Cultoms, within or without the Port to which fuch Ships or Vessele shall be bound, in order that the State of Health of the Crew and Perfons on board may be duly examined into and afcertained, prior to fuch Ships and Veffels being permitted to enter the Port of their Dellination; and that in the meantime no Intercourse with any other Ship or Vessel, or Boat, or with the Shore, shall be permitted, nor any of the Crew or Persons on board such Ships or Vessels be fuffered to come or be brought on Shore.

And the Right Honourable the Lords Commissioners of His Majelly's Treasury, the Commissioners for executing the Office of Lord High Admiral of Great Britain, the Lord Warden of the Cinque Ports, the Master General and the rest of the Principal Officers of the Ordnance, His Majesty's Secretary at War, and the Governors and Commanders in Chief for the Time being of the said Isles of Guernsey, Jersey, Alderney, Sark, and Man, are to give the necessary Directions herein, as to them may respectively appertain. SIR.

HAVE great Pleasure in acquainting their Lord-ships of the Capture of the Loup Garon French Privateer, of Sixteen Guns and One Hundred Men, by His Majetty's Sloop Orettes, of equal Force. This Capture does very great Credit to the Captain, Officers, and Men of the Orelles, from the prompt and neat Manner in which it has been effected, without any Loss to His Majelly's Service; and confirms the good Opinion I have long fince enter-tained of Captain Lapenotiere as an Officer, whilst ferving under my Command at different Times.

1 enclose Captain Lapenotiere's Letter respecting the Capture of the Loup Garou, which no doubt would have done much Mischief to our Trade.

IN the Execution of your Orders I this Morning at Daylight, (in Latitude 48' 30' North, Longitude 8' 56' West,) fell in with a Brig, which, from her Manœuvre, I supposed to be a French Cruizer; I made Sail in Chace, and had the Satisfaction of bringing her to close Action in less than an Hour, owing to one of our Shot carrying away her Main Haulyards; she kept up a smart Fire for about Half an Hour, when she struck to His Majesty's Sloop under my Command, and proves to be the Loup Garou French Privateer, of Sixteen Guns, commanded by Charles Laurent Faures, with a Complement of One Hundred Men, belongs to Nantz, but latt from Brett, out Two Days, and has made no Capture; she is a remarkable fine Vessel, One Year Old, coppered and copper fattened, well found in every Thing, is victualled for Two Months, and, I think, fit for His Majesty's Service.

I cannot say too much in Praise of Mr. Charles Squarey, my First Lieutenant, with the Officers and Men under my Command, for their very steady good Conduct during the short Contest, which was fuch as will ever give me the greatest Considence in them should Fortune throw me in the Way of an Enemy superior to the present one. I am happy to add we sultained no Loss in killed or wounded; our Sails and Rigging are a little damaged; the Enemy had Four Men wounded, Two of them dangeroully.
