captured the American sloop of war Wasp, of twenty guns, Captain Jacob Jones, and retaken His Majesty's brig Frolic, Captain Whinyates, which she had captured, after an action of fifty minutes. I have thought it my duty to collect the Frolic's convoy, and to see them in safety to Ber-

The conduct of Captain Whinyates, who I regret to say is wounded, and of his crew appears to have been so decidedly gallant, that I have been induced to continue him in command of the Frolic, until your pleasure is known.

Extract of a Letter from Captain Broke of His Majesty's Ship the Shannon, addressed to Admiral Sir John Borlase Warren, and transmitted by the Admiral to John Wilson Croker, Esq.

> His Majesty's Ship Shannon, at Sea, 31st October 1812.

HAVE the satisfaction of informing you, that the squadron under my orders this day captured the Thorn American privateer brig, of eighteen guns, long nine-pounders, and one hundred and forty men, quite a new vessel, upon her first cruise; she was three weeks out from Marblehead.
