We have also had the satisfaction of returning a quantity of church plate, bells, &c., which was seized, and ready to be carried away by the French, from Curzola and Augusta.

VICE-ADMIRAL Sir Edward Pellew has transmitted to John Wilson Croker, Esq. a letter from the Honourable Captain Cadogan, of his Majesty's ship the Havannali, to Rear-Admiral Fremantle, giving an account of the destruction, on the 7th of February, of an enemy's convoy of twenty-five sail, four of them gun-boats, by the boats of the Havannah, under Lieutenant Lumley, on the coast of Manfredonia. A battery of seven guns was destroyed by the marines, and two of the vessels brought out, the rest scuttled and left full of water. The convoy came from Venice, and the vessels were laden with ordnance stores. This service was performed without the loss of a man. ...

The latter, addressed to Rear-Admiral Fre-mantle, stating the capture, by the Cerberus, of La Veloce French gun-boat, carrying one eighteenpounder, and twenty-two men, bound to Otranto, for money for the troops at Corfu; and also that of a large trabaccolo, brought out by the boats of the Cerberus, under Lieutenant Delafosse, from under a battery near Brindisi.
