WHEREAS by an Act, passed in the fifty-third year of His Majesty's reign, cap. 155, it is enacted, that it shall not be lawful for any private person or persons to import any goods, wares, or merchandise, from any port or place within the limits of the East India Company's charter, except only into such ports of the United Kingdom of Great Britain and Ireland as shall be provided with warehouses, together with wet docks or basins, or such other securities as shall, in the judgment of the Lord High Treasurer, or of the Lords Commissioners of the Treasury for the time being, or any three or more of them, in Great Britain and Ireland respectively, be fit and proper for the deposit and safe custody of all such goods, wares, and merchandise, as well as for the collection of all duties payable thereon, and shall have been duly declared so to be, by the Order of His Majesty in Council, in Great Britain, or by the Order of the Lord Lieutenant in Council, in Ireland: and whereas the port of Hull has in Ireland: and whereas the port of Hull has been deemed by the Lords Commissioners of His Majesty's Treasury in Great Britain to be fit and proper for the deposit and safe custody of all such goods, wares, and merchandise, as well as for the collection of all duties payable thereon; His Royal Highness the Prince Regent, in the name and on the behalf of His Majesty, and by and with the advice of His Majesty's Privy Council, is there-upon pleased to declare, and it is hereby declared. upon pleased to declare, and it is hereby declared, that the port of Hull is a port fit and proper

7HEREAS the time limited by the Order of His Royal Highness the Prince Regent in Council of the twenty-third day of July last, for prohibiting the exportation out of this kingdom, or carrying coastwise, gunpowder or salt petre, or any sort of arms or ammunition, has ex-pired; and whereas it is judged expedient for His Majesty's service, and the safety of this kingdom, that the said prohibition should be con-tinued for some time longer; His Royal Highness, in the name and on the behalf of His Majesty, and by and with the advice of His Majesty's Privy Council, doth, therefore, hereby order, require, Council, doth, therefore, hereby order, require, prohibit, and command, that no person or persons whatsoever (except the Master-General of the Ordnance for His Majesty's service) do, at any time during the space of six months (to com-mence from the date of this Order), presume to transport into any parts out of this kingdom, or carry coastwise, any gunpowder or salt petre, or any sort of arms or ammunition, or ship or lade any gunpowder or salt petre, or any sort of arms or ammunition, on board any ship or vessel, in order to transporting the same into any parts beyond the seas, or carrying the same coastwise, without leave or permission in that be-half first obtained from His Majesty, or His Privy Council, upon pain of incurring and suffering the respective forfeitures and penalties inflicted by an Act, passed in the twenty-ninth year of His late Majesty's reign, intituled " An Act to empower
