THEREAS the time limited by the Orders of His Royal Highness the Prince Regent in Council of the twenty-eighth May and the twelfth July last, for prohibiting the exportation of gunpowder, arms, or ammunition, to the places therein specified, will expire on the thirtieth day of this instant November; and whereas it is expedient, that the said prohibition should be continued for some time longer; His Royal Highness the Prince Regent, in the name and on the behalf of His Majesty, and by and with the advice of His Majesty's Privy Council, doth hereby order, require, prohibit, and command, that no person or persons whatsoever (except the Master-General of the Ordnance for His Majesty's service) do, at any time during the space of six months (to commence from the thirtieth day of this instant November), presume to transport any gunpowder or salt-petre, or any sort of arms or ammunition, to any port or place within the dominions of the King of Spain, or to any port or place on the Coast of Africa, or In the West Indies, or on any part of the Continent | Admiral of Great Britain, the Lord Warden of

of America (except to a port or place, or ports or places in His Majesty's territories or possessionson the Continent of North America, or in the territories of the United States of America), or ship or lade any gunpowder or salt-petre, or any sort of arms or ammunition, on board any ship or vessel, in order to transporting the same into any such ports or places within the dominions of the King of Spain, or into any such ports or places on the Coast of Africa, or in the West Indies, or on the Continent of America (except as above excepted), without leave or permission in that behalf first obtained from His Majesty, or His Privy Council, upon pain of incurring and suffering the respective forfeitures and penalties inflicted by an Act, passed in the twenty-ninth year of His late Majesty's reign, intituled "An Act to empower. " His Majesty to prohibit the exportation of salt-" petre, and to enforce the law for empowering " His Majesty to prohibit the exportation of gun-" powder, or any sort of arms or ammunition, " and also to empower His Majesty to restrain " the carrying coastwise of salt-petre, gunpowder, " or any sort of arms or ammunition;" and alsoby an Act, passed in the thirty-third year of His Majesty's reign, cap. 2, intituled " An Act to " enable His Majesty to restrain the exportation " of naval stores, and more effectually to prevent " the exportation of salt-petre, arms, and ammu-" nition, when prohibited by Proclamation or " Order in Council:"
