WE, your Majesty's most dutiful and loyal subjects, the Inhabitant Householders and rate payers of the parish of St. John of Wapping, offer our grateful thanks for your Majesty's fatherly attention to the welfare of your people in dissolving the late Parliament, which had declared itself hostile to your Majesty's wishes, and to the best interests of the nation; we beg also to congratulate your Majesty's Coronation. THE Corporation for preserving and improving the port of Dublin, &c. give notice, that a Light-house is now building on the North Point of Tory Island, situate off the N.W. coast of Ireland, county Donegal, from which a fixed bright light will be exhibited on the evening of the 1st of August 1832, and continue thenceforth to be lit from sunset to sun-rise.
