REGULATIONS TO BE OBSERVED AT THE QUEEN'S DRAWING-ROOM, AT ST. JAMES'S-PALACE.

The Ladies, who purpose attending Her Majesty's Drawing-Room, are requested to bring with them two cards, with their names *legibly* written thereon, one to be left with the Queen's Page in Attendance in the Presence-chamber, and the other to be delivered to the Lord Chamberlain, who will announce the name to Her Majesty.

And those Ladies, who are to be presented, are hereby informed, it is absolutely necessary that their names, together with the names of the Ladies who are to present them, should be sent in to the Lord Chamberlain's-Office, before twelve o'clock on Tuesday the 17th of March, in order that they may be submitted for the Queen's approbation; it being Her Majesty's command, that no presentation shall take place unless the name of the Lady presenting, together with that of the Lady to be presented, shall appear on the card to be

delivered to the Lord Chamberlain, corresponding with the names sent in to the Lord Chamberlain's-Office.

It is particularly requested, that in every case written cards only be delivered.

Board of Green Cloth, St. James's-Palace, March 13, 1846.

NOTICE is hereby given, that the carriages coming to Her Majesty's Drawing-Room, on Thursday the 19th of March, are to fall into the line at the top of St. James's-street, come down the left hand side, and enter at the iron gate nearest to the Palace, set down at the Arcade, return by the iron gate nearest to Marlboroughhouse, and pass through Pall-mall into St. James's-square, by George-street. When called, they are to pass from St. James's-square, by Charles-street, into Regent-street, Jermyn-street, come down St. James's-street as before, take up, and go away through Pall-mall.

No hackney carriages will be permitted to come within the gates.

For all persons having the privilege of the entrée, tickets will be delivered at the Board of Green Cloth, on Tuesday next, between the

hours of eleven and three o'clock; their carriages are to enter the gate at Constitution-hill, proceed down St. James's-park, through Stable-yard, into the Ambassadors'-court, set down, and go out into Cleveland-row. The carriages of the Ambassadors, Foreign Ministers, Cabinet Ministers, and Great Officers of State may afterwards wait in the Ambassadors'-court, and those of all other persons having the *ertrée* may wait in Stable yard or St. James's-park till called; they are then to take up in the same order as they had set down, and pass away up the left hand side of St. James's-street.

No carriage will be admitted with company a second time with the same ticket, to prevent which, it must be produced at Constitution-hill-gate, and Stable-yard-gate also, where a corner of it will be torn off by the Marshalmen in attendance; and no person can be allowed the privilege of the *entrée* by any other approach to the Palace than the gates last mentioned.

HEREAS the Ecclesiastical Commissioners for England have, in pursuance of an Act, passed in the session of Parliament held in the sixth and seventh years of Her Majesty's reign, intituled "An Act to make better provision for the spiritual "care of populous parishes," duly prepared and laid before Her Majesty in Council a scheme, bearing date the fourth day of February, in the year one thousand eight hundred and forty-six, in the words following, that is to say:

"We, the Ecclesiastical Commissioners for England, in pursuance of an Act, passed in the session of Parliament held in the sixth and seventh years of your Majesty's reign, intituled "An Act "to make better provision for the spiritual care of "populous parishes," have prepared, and now humbly lay before your Majesty in Council, the following scheme, for constituting a separate district for spiritual purposes out of the parish of Manchester, in the county of Lancaster, and in the diocese of Chester.

"Whereas it is by the said Act cnacted, that if at any time it shall be made to appear to us, that it would promote the interests of religion, that any part or parts of any parish or parishes, chapelry or chapelries, district or districts, of great extent, and containing a large population, and wherein, or in parts whereof, the provision for public worship and for pastoral superintendence is insufficient for the spiritual wants of the inhabitants thereof, or any extra-parochial place or places, or any part or parts thereof, should be constituted a separate district for spiritual purposes, it shall be lawful, by the authority in the same Act provided (that is to say, by a scheme prepared by us, and an Order issued by your Majesty in Council, ratifying such scheme), with the consent of the bishop of the diocese, under his hand and seal, to set out by metes and bounds, and constitute a separate district accordingly, such district not then containing within its limits any consecrated church or chapel in use for the purposes of divine worship, and to fix and declare the name of such district; and it is by the same Act provided, that the draft of any scheme for constituting any such district shall be delivered or transmitted to the incumbent and to the patron or patrons of the church or chapel of any parish, chapelry, or district, out of which it is recommended that any such district, or any part thereof, should be taken, in order that such incumbent, patron or patrons, may have an opportunity of offering or making to us, or to such bishop, any observations or objections upon or to the constituting of such district; and that such scheme shall not be laid before your Majesty in Council until after the expiration of one calendar month next after such copy shall have been so delivered or transmitted, unless such incumbent and patron or patrons shall, in the meantime, consent to the same; and it is by the same Act also provided, that in every such scheme for constituting any such district we shall recommend to your Majesty in Council that the minister of such district, when duly licensed according to the same Act, shall be permanently endowed, under the provisions of the same Act, to an amount of not less than the annual value of one hundred pounds; and also, if such endowment be of less than the annual value of one handred and fifty pounds, that the same shall be increased to such last mentioned amount at the least, so soon as such district shall have become a new parish as thereinafter provided:

"And whereas the said parish of Manchester is of great extent, and contains a large population, and the provision for public worship and for pastoral superintendence therein is insufficient for the spiritual wants of the inhabitants thereof; and it has been made to appear to us, that it would promote the interests of religion, that the particular part of such parish hereinafter mentioned and described, such part not at present containing within its limits any consecrated church or chapel in use for the purposes of divine worship, should be constituted a separate district in manner hereinafter set forth:

"Now, therefore, we humbly recommend and propose, with the consent of the Right Reverend John Bird Bishop of Chester, in testimony whereof he has signed and sealed this scheme, that all that part of the said parish of Manchester, described in the schedule hereunto annexed,—all which part, together with the boundaries thereof, is delineated and set forth in the map or plan hereunto also annexed,—shall be constituted a separate district for spiritual purposes accordingly; and that the same shall be named, "The District of Christ Church, Denton."

" And we further recommend and propose, that there shall be paid by us, in each and every year, to the minister for the time being of the district so recommended to be constituted, when duly licensed according to the said Act, the sum of one hundred pounds; and upon any building within such district, being duly licensed by the bishop of the diocese for the performance of divine service, according to the same Act, there shall be paid by us, in like manner, to such minister, the further sum of thirty pounds, making in the whole the sum of one hundred and thirty pounds; and that so soon as any church or chapel within such district shall have been duly approved by us, and consecrated as the church or chapel of such district, for the use and service of the minister and inhabitants thereof, and such district shall have thereupon become, according to the provisions of the same Act, a new parish for ecclesiastical purposes, there shall be paid by us, in each and every year, to the perpetual curate for the time being of such new parish, the sum of one hundred and fifty pounds; and that the said sum of one hundred pounds, one hundred and thirty pounds, or one hundred and fifty pounds, as the case may be, shall be paid by equal half-yearly payments on the first day of May and the first day of November in each and every year; and that the first such payment, or a proportionate part thereof, shall be made on the first day of May or of November next after the day of the date of the licence of such minister or of such building, or of the consecration of such church or chapel as aforesaid, as the case may be; and that in case a vacancy in the ministry or perpetual curacy of such district or new parish shall happen on any other day than the first day of May or the first day of November, the amount payable shall be duly apportioned between and paid to the minister or the perpetual curate making the vacancy, or his personal representative or representatives, and the minister or the perpetual curate succeeding to such district or new parish.

"And we further recommend and propose, that nothing herein contained shall prevent us from recommending and proposing any other measures relating to the matters aforesaid, or any of them, in accordance with the provisions of the said Act, or of any other Act of Parliament.

" SCHEDULE.

" The district of CHRIST CHURCH, DENTON, being-

"All those parts of the townships of Denton and Houghton, in the parish of Manchester, in the county of Lancaster, and in the diocese of Chester, situate on the northern side of an imaginary line extending towards the north east, from the western boundary of the said township of Denton, along the middle of Denton-brook as far as Windmill-lane, and thence along the middle of such lane as far as Windmill-house, and thence eastward, in a straight direction, to the centre of the bridge, called 'Broomstair-bridge,' over the river Tame."

And whereas the draft of the said scheme has been transmitted to the incumbents and to the patrons of the church of the parish, and to the incumbent and patron of the church or chapel of the chapelry, out of which it is intended that the district therein recommended to be constituted shall be taken, pursuant to the provisions of the said Act; and whereas one calendar month has expired since such draft was so transmitted:

And whereas the said scheme has been approved by Her Majesty in Council; now, therefore, Her Majesty, by and with the advice of Her said Council, is pleased hereby to ratify the said scheme, and to order and direct that the same, and every part thereof, shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette, pursuant to the said Act; and Her Majesty, by and with the like advice, is pleased hereby to direct, that this Order be forthwith registered by the Registrar of the diocese of Chester:

"We, the Ecclesiastical Commissioners for England, in pursuance of an Act, passed in the session of Parliament held in the sixth and seventh years of your Majesty's reign, intituled "An Act to make better provision for the spiritual-"care of populous parishes," have prepared, and now humbly lay before your Majesty in Council, the following scheme, for constituting a separate district for spiritual purposes out of the parish of Whalley, in the county of Lancaster; and in the diocese of Chester.

"Whereas it is by the said Act enacted, that if at any time it shall be made to appear to us, that it would promote the interests of religion, that any part or parts of any parish or parishes, chapelry or chapelries, district or districts, of great extent, and containing a large population, and wherein, or in parts whereof, the provision for public worship

the spiritual wants of the inhabitants thereof, or any extra-parochial place or places, or any part or parts thereof, should be constituted a separate district for spiritual purposes, it shall be lawful, by the authority in the same Act provided (that is to say, by a scheme prepared by us, and an Order issued by your Majesty in Council, ratifying such scheme), with the consent of the bishop of the diocese, under his hand and seal, to set out by metes and bounds, and constitute a separate district accordingly, such district not then containing within its limits any consecrated church or chapel in use for the purposes of divine worship, and to fix and declare the name of such district; and it is by the same Act provided, that the draft of any scheme for constituting any such district shall be delivered or transmitted to the incumbent and to the patron or patrons of the church or chapel of any parish, chapelry, or district, out of which it is recommended that any such district, or any part thereof, should be taken, in order that such incumbent, patron or patrons, may have an opportunity of offering or making to us, or to such bishop, any observations or objections upon or to the constituting of such district; and that such scheme shall not be laid before your Majesty in Council until after the expiration of one calendar month next after such copy shall have been so delivered or transmitted, unless such incumbent and patron or patrons shall, in the meantime, consent to the same; and it is by the same Act also provided, that inevery such scheme for constituting any such district we shall recommend to your Majesty in Council, that the minister of such district, when duly licensed according to the same Act, shall be permanently endowed, under the provisions of the same Act, to an amount of not less than the annual value of one hundred pounds; and also, if such endowment be of less than the annual value of one hundred and fifty pounds, that the same shallbe increased to such last-mentioned amount at the least, so soon as such district shall have become a new parish as thereinafter provided:

" And whereas the said parish of Whalley is of great extent, and contains a large population, and the provision for public worship and for pastoral superintendence therein is insufficient for the spiritual wants of the inhabitants thereof; and it has been made to appear to us, that it and for pastoral superintendence is insufficient for would promote the interests of religion, that the particular part of such parish hereinafter mentioned and described, such part not at present containing within its limits any consecrated church or chapel in use for the purposes of divine worship, should be constituted a separate district in manner hereinafter set forth:

"And we further recommend and propose, that there shall be paid by us, in each and every year, to the minister for the time being of the district so recommended to be constituted, when duly licensed according to the said Act, the sum of one hundred pounds; and upon any building within such district, being duly licensed by the bishop of the diocese for the performance of divine service, according to the same Act, there shall be paid by us, in like manner, to such minister, the further sum of thirty pounds, making in the whole the sum of one hundred and thirty pounds; and that so soon as any church or chapel within such district shall have been duly approved by us, and consecrated as the church or chapel of such district, for the use and service of the minister and inhabitants thereof, and such district shall have thereupon become, according to the provisions of the same Act, a new parish for ecclesiastical purposes, there shall be paid by us, in each and every year, to the perpetual curate for the time being of such new parish, the sum of one hundred and fifty pounds; and that the said sum of one hundred pounds, one hundred and thirty pounds, or one hundred and fifty pounds, as the case may be, shall be paid, by equal half-yearly payments, on the first day of May and the first day of November in each and every year; and that the first such payment, or a proportionate part thereof, shall be made on the first day of May or of November next after the day of the date of the ticence of such minister or of such building, or of the consecration of such church or chapel as aforesaid, as the case may be; and that in case a vacancy in the ministry or perpetual curacy of such district or new parish shall happen on any other day than the first day of May or the first day of November, the amount payable shall be duly apportioned between and paid to the minister or the perpetual curate making the vacancy, or his personal representative or representatives, and the minister or the perpetual curate succeeding to such district or new parish.

"And we further recommend and propose, that nothing herein contained shall prevent us from recommending and proposing any other measures relating to the matters aforesaid, or any of them, in accordance with the provisions of the said Act, or of any other Act of Parliament.

" SCHEDULE.

" The district of Lumb, being-

"All those parts of the townships of New Church, Higher Booths, and Lower Booths, in the parish of Whalley, in the county of Lancaster, and in the diocese of Chester, comprised within and bounded by an imaginary line, commencing at a point (marked a on the map or plan hereunto annexed) where a certain stream, called 'Shaw Clough,' falls into Whitewell-brook, and thence extending eastward along such stream and towards the north east, along the boundary between Wolfenden Booth and Bacup Booth, and, towards the north west, along the boundary between Wolfenden Booth aforesaid and the township of Cliviger, and the boundary between the Gambleside division of Higher Booths aforesaid and the said township of Cliviger, as far as the middle of the turnpike road from New Church to Burnley, and thence, towards the south west, along the middle of such road, to a point (marked b as aforesaid) opposite to the middle of a certain occupation road near Windybank, and thence westward along the middle of such occupation road, as far as the middle of the old highway to Burnley, and thence, towards the south west, in a straight direction, to the western. end of certain farm buildings (marked c as aforesaid) called 'Chamber Height Barn,' and thence,. also towards the south west, and in a straight. direction, to the western end of certain other farm.

buildings (marked d as aforesaid) called 'Higher Bank Top,' and thence, towards the south east, in a straight direction, to a point (marked e as aforesaid) where a certain streamlet, flowing near Rock Barn, falls into Whitewell-brook aforesaid, and thence southward, along the western bank of the said brook, to the point where the said imaginary line commenced."

And whereas the said scheme has been approved by Her Majesty in Council; now, therefore, Her Majesty, by and with the advice of Her said Council, is pleased hereby to ratify the said scheme, and to order and direct that the same, and every part thereof, shall be effectual in law immediately from and after the time when this: Order shall have been duly published in the London Gazette, pursuant to the said Act; and Her Majesty, by and with the like advice, is pleased hereby to direct, that this Order be forthwith registered by the Registrar of the diocese of Chester.

there shall be paid by us, in each and every year, to the minister for the time being of each of the districts so recommended to be constituted. when duly licensed according to the said Act, the sum of one hundred pounds; and upon any building within either of such districts, being duly licensed by the bishop of the diocese for the performance of divine service, according to the same Act, there shall be paid by us, in like manner, to the minister thereof for the time being the further sum of thirty pounds, making in the whole the sum of one hundred and thirty pounds; and that so soon as any church or chapel within either of such districts shall have been duly approved by us, and consecrated as the church or chapel of such district, for the use and service of the minister and inhabitants thereof, and such district shall have thereupon become, according to the provisions of the same Act, a new parish for ecclesiastical purposes, there shall be paid by us in each and every year, to the perpetual curate for the time being of such new parish, the sum of one hundred and fifty pounds; and that the said sums of one hundred pounds, one hundred and thirty pounds, or one hundred and fifty pounds, as the case may be, shall be paid, by equal halfyearly payments, on the first day of May and the first day of November in each and every year; and that the first such payment, or a proportionate part thereof, shall be made on the first day of May or of November next after the day of the date of the licence of such minister or of such building, or of the consecration of such church or chapel as aforesaid, as the case may be; and that in the a vacancy in the ministry or perpetual curacy of either of such districts or new parishes shall happen on any other day than the first day of May or the first day of November, the amount payable shall be duly apportioned between and pail to the minister or the perpetual curate making the vacancy, or his personal representative or representatives, and the minister or the perpetual curate succeeding to such district or new parish.

"And we further recommend and propose, that nothing herein contained shall prevent us from recommending and proposing any other measures relating to the matters aforesaid, or any of them, in accordance with the provisions of the said Actor of any other Act of Parliament.

" SCHEDULE.

"No. 1.—The district of SAINT STEPHEN, WILLENHALL, being—

" All that part of the township of Willenhall, in the parish of Wolverhampton, and in the county of Stafford and diocese of Lichfield, situate on the western side of an imaginary line -commencing at a point (marked α on the map or plan hereunto annexed, and numbered 1.) on the northern boundary of the said township at the junction of Noose-lane with the highway from Wednesfield to the town of Willenhall, and thence extending southward along the middle of such highway to a point (marked b as aforesaid) at the northern end of a certain footpath, through lands belonging to the representatives of the late Peter Baker, of Birmingham, leading from such road to another highway from Little London to the town of Willenhall aforesaid, and thence along the middle of such footpath to its junction with such last-mentioned highway, and thence along the middle of the same highway to a point (marked c as aforesaid) opposite to the middle of Lichfieldstreet, in the said town of Willenhall, and thence first eastward along the middle of such street across. Union-street to a point (marked d as afaresaid) opposite to the middle of Cross-street, and thence westward along the middle of such lastmentioned street, through the market-place in the said town of Willenhall, as far as the middle of Wolverhampton-street, and thence southward along the middle of such last-mentioned street, and of the street or road called Mobs-bank, and of a certain lane leading from the Waterglade to the turnpike road from Bilston to Walsall, across the said turnpike road, and along the middle of a certain occupation road, and of a certain narrow enclosure, to the boundary of Darlaston parish (the lands on the east of the said occupation road and enclosure being the property of Mr. G. " No. 2.—The district of the Holy Trinity, Willenhall, being—

"All that part of the township of Willenhall, situate on the eastern side of that part of the imaginary line forming the eastern boundary of the said district of Saint Stephen, Willenhall, which extends southward from the northern boundary of the said township of Willenhall to a

And whereas the draft of the said scheme has been transmitted to the incumbent and to the patron of the church of the parish, and to the incumbent and patrons of the church or chapel of the chapelry, out of which it is intended that the districts therein recommended to be constituted shall be taken, pursuant to the provisions of the said Act; and whereas one calendar month has expired since such draft was so transmitted, and no objections have been made thereto:

And whereas the said scheme has been approved by Her Majesty in Council; now, therefore, Her Majesty, by and with the advice of Her said Council, is pleased hereby to ratify the said scheme, and to order and direct that the same, and every part thereof, shall be effectual in law immediately from and after the time when this

Order shall have been duly published in the London Gazette, pursuant to the said Act; and Her Majesty, by and with the like advice, is pleased hereby to direct, that this Order be forthwith registered by the Registrar of the diocese of Lichfield.

HEREAS the Ecclesiastical Commissioners for England have, in pursuance of an Act, passed in the session of Parliament held in the sixth and seventh years of Her Majesty's reign, intituled "An Act to make better provision for "the spiritual care of populous parishes," duly prepared and laid before Her Majesty in Council a scheme, bearing date the fourth day of February, in the year one thousand eight hundred and forty-six, in the words following, that is to say:

"We, the Ecclesiastical Commissioners for England, in pursuance of an Act, passed in the session of Parliament held in the sixth and seventh years of your Majesty's reign, intituled "An Act" to make better provision for the spiritual care of populous parishes," have prepared, and now humbly lay before your Majesty in Council, the following scheme, for constituting a separate district for spiritual purposes out of the parish of Saint Margaret, in the borough of Lynn Regis, in the county of Norfolk, and in the diocese of Norwich.

"Whereas it is by the said Act enacted, that if at any time it shall be made to appear to us, that it would promote the interests of religion, that any part or parts of any parish or parishes, chapelry or chapelries, district or districts, of great extent, and containing a large population, and wherein, or in parts whereof, the provision for public worship and for pastoral superintendence is insufficient for the spiritual wants of the inhabitants thereof, or any extra-parochial place or places, or any part or parts thereof, should be constituted a separate district for spiritual purposes, it shall be lawful, by the authority in the same Act provided (that is to

say, by a scheme prepared by us, and an Order issued by your Majesty in Council, ratifying such scheme), with the consent of the bishop of the diocese, under his hand and seal, to set out by metes and bounds, and constitute a separate district accordingly, such district not then containing within its limits any consecrated church or chapel in use for the purposes of divine worship, and to fix and declare the name of such district; and it is by the same Act provided, that the draft of any scheme for constituting any such district shall be delivered or transmitted to the incumbent and to the patron or patrons of the church or chapel of any parish, chapelry, or district, out of which it is recommended that any such district, or any part thereof, should be taken, in order that such incumbent, patron or patrons, may have an opportunity of offering or making to us, or to such bishop, any observations or objections upon or to the constituting of such district; and that such scheme shall not be laid before your Majesty in Council until after the expiration of one calendar month next after such copy shall have been so delivered or transmitted, unless such incumbent and patron or patrons shall, in the mean time, consent to the same; and it is by the same Act also provided, that in every such scheme for constituting any such district we shall recommend to your Majesty in Council that the minister of such district, when duly licensed according to the same Act, shall be permanently endowed, under the provisions of the same Act, to an amount of not less than the annual value of one hundred pounds; and also, if such endowment be of less than the annual value of one hundred and fifty pounds, that the same shall be increased to such last-mentioned amount at the least, so soon as such district shall have become a new parish as thereinafter provided:

"And whereas the said parish of Saint Margaret is of great extent, and contains a large population, and the provision for public worship and for pastoral superintendence therein is insufficient for the spiritual wants of the inhabitants thereof; and it has been made to appear to us, that it would promote the interests of religion, that the particular part of such parish hereinafter mentioned and described, such part not at present containing within its limits any consecrated church or chapel in use for the purposes of divine worship, should be constituted a separate district in manner hereinafter set forth:

Now, therefore, we humbly recommend and propose, with the consent of the Right Reverend Edward Bishop of Norwich, in testimony whereof he has signed and sealed this scheme, that all that part of the said parish of Saint Margaret, described in the schedule hereunto annexed,—all which part, together with the boundaries thereof, is delineated and set forth in the map or plan hereunto also annexed,—shall be constituted a separate district for spiritual purposes accordingly; and that the same shall be named, "The District of Saint John, Lynn."

" And we further recommend and propose, that there shall be paid by us, in each and every year, to the minister for the time being of the district so recommended to be constituted, when duly licensed according to the said Act, the sum of one hundred pounds; and upon any building within such district, being duly licensed by the bishop of the diocese for the performance of divine service, according to the same Act, there shall be paid by us, in like manner, to such minister, the further sum of thirty pounds, making in the whole the sum of one hundred and thirty pounds; and that so soon as any church or chapel within such district shall have been duly approved by us, and consecrated as the church or chapel of such district, for the use and service of the minister and inhabitants thereof, and such district shall have thereupon become, according to the provisions of the same Act, a new parish for ecclesiastical purposes, there shall be paid by us, in each and every year, to the perpetual curate for the time being of such new parish, the sum of one hundred and fifty pounds; and that the said sum of one hundred pounds, one hundred and thirty pounds, or one hundred and fifty pounds, as the case may be, shall be paid by equal halfyearly payments on the first day of May and the first day of November in each and every year; and that the first such payment, or a proportionate part thereof, shall be made on the first day of May or of November next after the day of the date of the licence of such minister or of such building, or of the consecration of such church or chapel as aforesaid, as the case may be; and that in case a vacancy in the ministry or perpetual curacy of such district or new parish shall happen on any other day than the first day of May or the first day of November, the amount

payable shall be duly apportioned between and paid to the minister or the perpetual curate making the vacancy, or his personal representative or representatives, and the minister or the perpetual curate succeeding to such district or new parish.

" And whereas it is by the said Act further enacted, that it shall be lawful, by the authority aforesaid, at any time to assign the right of patronage of any such district or new parish as aforesaid, and the nomination of the minister or perpetual curate thereof respectively, either in perpetuity, or for one or more nomination or nominations, to any ecclesiastical corporation aggregate or sole, or to either of the universities of Oxford, Cambridge, or Durham, or to any college therein respectively, or to any person or persons, or the nominee or nominees of such person or persons or body respectively, upon condition of such corporation, university, college, person or persons contributing to the permanent endowment of such minister or perpetual curate, or towards providing a church or chapel for the use of the inhabitants of such district or new parish, in such proportion, and in such manner, as shall be approved by the like authority:

" And whereas certain persons have contributed certain sums of money towards providing a church or chapel within the said district of Saint John, Lynn, herein recommended to be constituted, and a church or chapel is now in course of erection, by the aid of such monies, within the said district; and it has been agreed by such persons that such church or chapel, when completed according to certain plans and a specification which have been submitted to us, shall be offered for approval by us, and for consecration, as the church or chapel of the said district, for the use and service of the minister and inhabitants thereof, and we have satisfied ourselves that the said church or chapel, when so completed, will be fit to be so approved and consecrated:

"And whereas also a sum of two hundred and seventy-six pounds twelve shillings has been deposited with us, upon trust, to be applied in such manner as shall appear to us to be expedient, as a permanent fund, towards the repairs and maintenance of the fabric of such church:

" And whereas the principal contributors towards the said church or chapel have, by an nated to us the Bishop of Norwich for the time being, as the patron in perpetuity of the said district:

"We, therefore, further recommend and propose, that the right of patronage of the said district, and, so soon as the same shall have become a new parish as aforesaid, the right of patronage thereof, and the nomination of the minister or perpetual curate of such district or new parish, as the case may be, shall be assigned to, and absolutely vested in, the said Edward Bishop of Norwich, and his successors, bishops of Norwich for ever.

"And we further recommend and propose, that nothing herein contained shall prevent us from recommending and proposing any other measures relating to the matters aforesaid, or any of them, in accordance with the provisions of the said Act, or of any other Act of Parliament.

" SCHEDULE.

" The district of SAINT JOHN, LYNN, being-

" All that part of the parish of Saint Margaret, in the borough of Lynn Regis, in the county of Norfolk, and in the diocese of Norwich, situate on the north eastern side of an imaginary line commencing at a point (marked a on the map or plan hereunto annexed) in the middle of the London-road, where the southern boundary of the said parish crosses such road, and thence extending northward, along the middle of such road, to a point opposite to the middle of Saint Jamesstreet, and thence westward, along the middle of such last-mentioned street, to a point opposite to the middle of Tower-street, and thence northward, along the middle of such last-mentioned street, across a certain open space called 'The Plain,' and along the middle of Broad-street, as far as the middle of Norfolk-street; and on the southern side of an imaginary line extending eastward, from Broad-street aforesaid, along the middle of Norfolk-street aforesaid, and of Littleport-street, as far as the boundary of the said parish of Saint Margaret."

HEREAS by an Act, passed in the seventh year of the reign of His late Majesty King William the Fourth, intituled "An Act for "rendering more easy the taking the poll at "county elections," it is enacted, that it shall be lawful for His Majesty, by and with the advice of His Privy Council, from time to time, on petition from the justices of any county, riding, parts, or division, in England or Wales, in quarter sessions assembled, representing that the number of polling places for such county, riding, parts, or division of the county within which such place or places is or are situate, to declare that any place or places mentioned in the said petition shall be a polling place or polling places for that county, riding, parts, or division, and that the justices of the peace for such county, riding, parts, or division, in quarter sessions or some special sessions assembled, as mentioned in the Act, passed in the third year of the reign of His said late Majesty, intituled " An Act to settle and determine the divisions of counties, and the limits of cities " and boroughs, in England and Wales, in so far as respects the election of Members to serve in " Parliament," shall, conformably to the said last-mentioned Act, divide such county, riding, parts, or division into convenient polling districts, and assign one of such districts to each polling place:

And whereas the justices of the peace for the county of Dorset, in general quarter sessions assembled, at Dorchester, in and for the said county, on Tuesday the sixth day of January, in the year one thousand eight hundred and forty six. did resolve, that a humble petition should be, and such petition has been, duly presented to Her Majesty, representing that the number of polling places for the said county is insufficient, and, therefore, praying that the town of Sturminster Newton Castle, situate within the said county, may be a polling place for the said county:

Now, therefore, Her Majesty, having taken the said petition into consideration, doth, pursuant to the said Act of the seventh year of His late Majesty's reign, by and with the advice of Her Privy Council, declare, order, and direct, that the said place named in the said petition, namely, the town of Sturminster Newton Castle, shall be a polling place for the said county of Dorset; and, further, that the justices of the peace for the said county of Dorset, assembled in general quarter sessions or some special sessions, as mentioned in the said Act of the third year of His said late Majesty's reign, shall, conformably to the said last-mentioned Act, divide the said county into convenient polling districts, and assign one of such districts to each polling place.
