HEREAS by an Act, passed in the session of Parliament held in the first year of Her Majesty's reign, intituled "An Act to amend an " Act for the regulation of municipal corporations " in England and Wales," it is, amongst other things, enacted, that if the inhabitant householders of any town or borough in England or Wales shall petition Her Majesty to grant to them a charter of incorporation, it shall be lawful for Her Majesty by any such charter if she shall think fit, by the advice of Her Privy Council, to grant the same, to extend to the inhabitants of any such town or borough within the district to

T the Court at Buckingham-Palace, the | be set forth in such charter, all the powers and provisions of the Act of the fifth and sixth William the Fourth, chapter seventy-six, for regulating corporations, whether such town or borough be or be not a corporate town or borough, or be not named in either of the schedules to the said Act; provided, nevertheless, that notice of every such petition, and of the time when it shall please Her Majesty to order that the same may be taken into consideration by Her Privy Council, shall be published in the London Gazette one month at least before such petition shall be so considered:

> And whereas the inhabitant householders of the township of Wolverhampton, in the county of Stafford, have presented a petition to Her Majesty in Council, praying that a charter of incorporation may be granted to such part of the borough of Wolverhampton as is comprised in the township of Wolverhampton; and the inhabitant householders of the borough of Halifax, in the west riding of the county of York, have presented a petition to Her Majesty in Council, praying that a charter of incorporation may be granted to the said borough; Her Majesty was this day pleased to order, and it is hereby ordered, that the said petitions be taken into consideration by a Committee of the Lords of Her Majesty's Most Honourable Privy Council, on Thursday the twenty-second day of July next.

The QUEEN's Most Excellent Majesty in Council.

THEREAS the Ecclesiastical Commissioners for England have, in pursuance of an Act, passed in the session of Parliament held in the sixth and seventh years of the reign of His late Majesty King William the Fourth, intituled " An Act for carrying into effect the reports of "the Commissioners appointed to consider the " state of the Established Church in England and " Wales, with reference to ecclesiastical duties " and revenues, so far as they relate to episcopal " dioceses, revenues, and patronage," duly prepared and laid before Her Majesty in Council a scheme, bearing date the tenth day of June, in the year one thousand eight hundred and fortyseven, in the words following, that is to say:

"We, the Ecclesiastical Commissioners for England, in pursuance of an Act, passed in the session of Parliament held in the sixth and seventh years of the reign of His late Majesty King William the Fourth, intituled "An Act for " carrying into effect the reports of the Com-" missioners appointed to consider the state of the " Established Church in England and Wales, " with reference to ecclesiastical duties and " revenues, so far as they relate to episcopal " dioceses, revenues, and patronage," have prepared, and now humbly lay before your Majesty in Council, the following scheme, relating to the revenues of the see of Gloucester and Bristol, and for abolishing peculiars in the diocese of Gloucester and Bristol.

" Whereas it was by the said Act enacted, that in order to provide for the augmentation of the incomes of the smaller bishopricks, such fixed annual sums should be paid to us out of the revenues of the larger sees respectively as should, upon due inquiry and consideration, be determined on, so as to leave as an average annual income to the archbishops and bishops therein named the respective sums therein mentioned, and that, out of the fund thus accruing, fixed annual payments should be made by us, in such instances and to such amount as should be in like manner determined on, so that the average annual incomes of the other bishops, respectively, should not be to us for the purposes of the same Act:

less than four thousand pounds, nor more than five thousand pounds; and that, at the expiration of every seven years, reckoning from the first day of January one thousand eight hundred and thirty-seven, a new return of the revenues of all the bishopricks should be made to the Commissioners, and that thereupon the scale of episcopal payments and receipts should be revised, so as to preserve as nearly as might be to each bishop an amount of income equivalent to that which should have been determined in the first instance to be suitable to the circumstances of his bishoprick, and that such revised scale should take effect, as to each see respectively, upon the then next avoidance thereof; and that if, in determining the mode of regulating the episcopal incomes, either in the first instance or on any future revision of them, it should be deemed expedient to make the alteration required in any case by the subtraction or addition of any real estates, such real estates should be transferred accordingly:

" And whereas, soon after the passing of the said Act, we proceeded to consider the circumstances of the said see of Gloucester and Bristol, and came to a determination that the average annual income of five thousand pounds would be suitable to the circumstances thereof; and having also considered the information then before us respecting the actual average annual income of the said see, we did not find ourselves prepared to make any recommendation respecting the revenues thereof:

"And whereas, in pursuance of the further provision of the said Act, we did, at the expiration of the first seven years, reckoning from the first day of January, in the year one thousand eight hundred and thirty-seven, obtain a new return of the revenues of the said see; and it appears upon such return, that in order to preserve as nearly as may be to the future bishops thereof the amount of income aforesaid, the following arrangement should be made respecting such revenues:

" And whereas the lands, tithes, tenements and hereditaments, described in the schedule hereunto annexed, forming part of the estates of the said see, were, in the year one thousand eight hundred and seventeen, demised by a certain lease for lives, which is still subsisting, and it appears to us to be expedient that the same should be subtracted from the said see, and transferred

"We, therefore, humbly recommend and propose, that from and after the next avoidance of the said see of Gloucester and Bristol, the bishop succeeding thereto and his successors shall pay or cause to be paid to our credit, into the Bank of England, to an account intituled, "Account with the Ecclesiastical Commissioners for England," by equal half-yearly payments, the fixed annual sum of seven hundred pounds; the first payment to be made at the end of six calendar months from the day of the avoidance of the said see, whether the same shall happen by death, translation or otherwise; and that whenever a vacancy of the said see shall thereafter happen on any other day than the half-yearly day of payment so calculated as aforesaid, then the next half-yearly payment shall be duly apportioned and paid between and by the bishop making the vacancy, or his representatives, and the bishop succeeding to the said see.

"And we further recommend and propose, that, immediately upon and from such next avoidance, the said lands, tithes, tenements and hereditaments, so described in the said schedule, shall, without any assurance in the law other than this scheme, and any duly gazetted Order of your Majesty in Council ratifying the same, become and be subtracted and dissevered from the said see, and transferred to and absolutely vested in us for the purposes of the same Act.

"And whereas it was by the same Act enacted, that it should be competent to us to propose, in any scheme prepared and laid before your Majesty in Council under the provisions thereof, that all parishes, churches or chapelries locally situate in any diocese, but subject to any peculiar jurisdiction other than the jurisdiction of the bishop of the diocese in which the same were locally situate, should be only subject to the jurisdiction of the bishop of the diocese in which the same were locally situate:

"We, therefore, further recommend and propose, that, upon and after the twenty-first day next after the day upon which any Order of your Majesty in Council ratifying this scheme shall be published in the London Gazette, all parishes and places, locally situate within the limits of the said diocese of Gloucester and Bristol, and of the several archdeaconries thereof, and all churches and chapels, and the whole clergy and others, your Majesty's subjects, locally situate within the limits of such parishes and

places respectively, shall, notwithstanding any peculiar or other ecclesiastical jurisdiction, or exemption from jurisdiction, which any of such parishes, places, churches, chapels or clergy may now possess or be subject to, or claim to possess or be subject to, be respectively under and subject only to the jurisdiction and authority of the bishop of the said diocese, and the archdeacons of the several archdeaconries of such diocese, within the limits of which they shall respectively be so locally situate; except that the cathedral churches of and within the same diocese shall respectively remain and be subject to the jurisdiction and visitation, if any, to which they are now by law respectively subject, and to noneother; and we further recommend and propose, that, with the like exceptions, all and each of such parishes, places, churches and chapels so possessing or being subject to, or claiming to possess or be subject to, any such peculiar jurisdiction or exemption from jurisdiction, and all other parishes, places, churches and chapels, locally situate within. the said diocese, shall severally and respectively: be included in and form part of the said diocese and of the archdeaconries and rural deanries respectively within the limits of which they shall be so locally situate.

"And we further recommend and propose, that nothing herein contained shall prevent us from recommending and proposing any other measure relating to the matters aforesaid, in conformity with the provisions of the said Act, or of any other Act of Parliament.

" SCHEDULE.

"All that the estate and manor of Horfield, in the county of Gloucester, and also the parsonages and vicarages of Horfield and Filton, in the same county, and all glebe lands, tithes and portions of tithes, messuages, tenements and hereditaments, and all and singular the rights, members and appurtenances to them or either of them belonging, as the same are demised by a certain indenture of lease, bearing date the fourth day of February, in the year one thousand eight hundred and seventeen, to George Lempriere, as therein described, or intended so to be (except any advowson or right of patronage or presentation)."

fore, Her Majesty, by and with the advice of Her said Council, is pleased hereby to ratify the said scheme, and to order and direct that the same, and every part thereof, shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette, pursuant to the said Act; and Her Majesty, by and with the like advice, is pleased hereby to direct, that this Order be forthwith registered by the Registrars of the two several registries of the diocese of Gloucester and Bristol, at Bristol and Gloucester.
