THEREAS the Ecclesiastical Commissioners for England have, in pursuance of an Act, passed in the session of Parliament held in the third and fourth years of Her Majesty's reign, intituled "An Act to carry into effect, with "certain modifications, the fourth report of the "Commissioners of Ecclesiastical Duties and "Revenues," and of an Act, passed in the session of Parliament held in the fourth and fifth years of Her Majesty's reign, intituled "An " Act to explain and amend two several Acts " relating to the Ecclesiastical Commissioners " for England," and of an Act, passed in the session of Parliament held in the sixth and seventh years of Her Majesty's reign, intituled " An Act " for regulating the cathedral churches of Wales," duly prepared and laid before Her Majesty in Council a scheme, bearing date the tenth day of August, in the year one thousand eight hundred and forty-eight, in the words and figures following, that is to say:

"We, the Ecclesiastial Commissioners for England, in pursuance of an Act, passed in the session of Parliament held in the third and fourth "to carry into effect, with certain modifications. "the fourth report of the Commissioners of " Ecclesiastical Duties and Revenues," and of an Act, passed in the session of Parliament held in the fourth and fifth years of your Majesty's reign, intituled "An Act to explain and amend "two several Acts relating to the Ecclesiastical "Commissioners for England," and of an Act, passed in the session of Parliament held in the sixth and seventh years of your Majesty's reign, intituled "An Act for regulating the cathedral "churches of Wales," have prepared, and now humbly lay before your Majesty in Council, the following scheme, for making additional provision for the cure of souls in certain parishes where such assistance is most required.

"Whereas, under the authority of the said recited Acts, we have from time to time prepared and laid before your Majesty in Council certain schemes, in which we have recommended and proposed, that certain grants should be made in augmentation of the incomes of certain benefices and churches in certain classes, and subject to certain limitations therein mentioned, which schemes have been ratified by Orders of your Majesty in Council, and such Orders have been duly gazetted:

" And whereas on the sixth day of August in the year one thousand eight hundred and fortyyears of your Majesty's reign, intituled "An Act | four we found it necessary to suspend, until further notice, our recommendations of further grants, with certain specified exceptions; and the several benefices and churches described in the schedules hereunto annexed either fall within such exceptions, or the incumbents thereof had previously received specific promises from us that we would recommend the grants in the said schedules respectively proposed, in consequence of their coming within some or one of such classes as aforesaid:

"And whereas the benefices described in the schedule hereunto annexed marked C, fall within the third class, in the said Orders mentioned, and are situate within the places set opposite to the names thereof respectively in the fifth column of the same schedule; and we are in possession of certain tithes or lands arising or situate in such places respectively or of the proceeds thereof; and after due inquiry and consideration we satisfied ourselves, that the same benefices are fit and proper to be forthwith augmented, by the respective annual amounts stated in the last column of the same schedule:

oxfow sliev s first benefit "We, therefore, humbly recommend and propose, that there shall be paid by his, in each and every year, to the incumbent for the time being of each of the benefices and churches so described in the said schedule marked C., the fixed annual sum set opposite to the name of such benefice or church in the last column of the said schedule on the first day of May and the first day of November in each year; and that the first such halfyearly payment shall in each case be made on the first day of November next, except in the case of the perpetual curacy of Hurst, the incumbent whereof shall on such last-mentioned day receive three such half-yearly payments, and except also in the cases of the perpetual curacy of Saint Paul, Finsbury, in the parish of Saint Luke, Old-street, in the county of Middlesex, the incumbent whereof shall on such last-mentioned day receive two such half-yearly payments:

"Provided that, in the case of the perpetual curacy of Hurst, the payment shall be made only on the production to us, or to our treasurer and secretary, on or before the first day of November, and first day of May respectively in this and every succeeding year, of a certificate under the hand of the bishop of the diocese that a curate licensed

by such bishop has been duly employed at Twyford, in the said parish of Hurst.

" And whereas we have satisfied ourselves that the several benefices contained in the schedule hereuntomannexed marked Eggsfall withing the second of such classes, except the perpetual curacies of Little Eaton and Middleton, which fall within the third class afforesaid, we therefore recommend and propose, that, in order to provide fit houses of residence for the incumbents of all the benefices contained in the last-mentioned schedule, we shall be at liberty to pay to such persons and at such times as shall appear to us from time to time to be expedient, such a sum or sums of money, in the case of each such benefice, as shall be required for providing a fit house of residence for the incumbent thereof; provided that, except in the cases of the two last-named benefices, the total amount so paid by us, in addition to the amount of the benefaction, shall not exceed such last mentioned amount when the benefice is in public patronage, or two thirds of such last-mentioned amount when the benefice is in private patronage.

And we further recommend and propose, that nothing herein contained shall prevent the further augmentation of any of such benefices or churches, if it shall be deemed fit, when there shall be sufficient means for that purpose; and that if it shall appear to us to be expedient, at any future time that instead of the annual sum then in course of payment by us to the incumbent of any benefice, or instead of any part of such annual sum, any land, tithe or other hereditament should be conveyed to such benefice in fee, nothing herein or in any other scheme contained shall prevent us from recommending and proposing such a substitution provided that, except in the case of Saint James, Curtain-road, nin the parish of Shoreditch, in the county of Middlesex, no such change shall take effect before the then next vacancy of the benefice affected thereby, without the written consent of the then existing incumbent. a Charles a West Comment 2 20

THEREAS the Ecclesiastical Commissioners for England have, in pursuance of an Act passed in the session of Parliament held in the sixth and seventh years of the reign of His late Majesty King William the Fourth, intituled "An Act for carrying into effect the reports of "the Commissioners appointed to consider the " state of the Established Church in England and "Wales, with reference to ecclesiastical duties " and revenues, so far as they relate to episcopal "dioceses, revenues and patronage," another Act, passed in the session of Parliament held in the fifth and sixth years of Her Majesty's reign, intituled "An Act to alter and amend "the law relating to ecclesiastical houses of "residence," duly prepared and laid before Her Majesty in Council a scheme, bearing date the tenth day of August, in the year one thousand eight hundred and forty-eight, in the words following, that is to say:

"We, the Ecclesiastical Commissioners for England, in pursuance of an Act, passed in the session of Parliament held in the sixth and seventh years of the reign of His late Majesty King William the Fourth, intituled "An Act for "carrying into effect the reports of the Commissioners appointed to consider the state of the "Established Church in England and Wales,"

"with reference to ecclesiastical duties and re"venues, so far as they relate to episcopal
"dioceses, revenues and patronage," and of
another Act, passed in the session of Parliament
held in the fifth and sixth years of your Majesty's
reign, intituled "An Act to alter and amend the
"law relating to ecclesiastical houses of re"sidence," have prepared, and now humbly lay
before your Majesty in Council, the following
scheme, for improving the house of residence
belonging to the see of Hereford.

"Whereas it is by the first recited Act enacted, that for the purpose of providing the bishop of any diocese with a more suitable residence than that which at the time of the passing of the same Act belonged to his see, sanction be given where it may be necessary for the borrowing by any bishop of a sum, not exceeding two years income of his see, upon such terms as shall appear to be proper; and that the Governors of the Bounty of Queen Anne be empowered to lend money upon mortgage to such bishop:

"And whereas it is by the said secondly-recited Act enacted, that whenever it shall appear to be expedient to add to, alter or improve any episcopal house of residence, it shall be lawful, by the authority provided in the first recited Act, with the consent under the hand and episcopal seal of the bishop, to make such arrangements as may by such authority be deemed most expedient for adding to, altering or improving any episcopal house of residence; and that so much of the said first recited Act, as relates to the providing of any bishop with a more suitable and convenient residence, shall be extended so as to include and apply to the purposes of the said secondly-recited Act:

And whereas it appears to be expedient, with the consent of the Right Reverend Rean Dickson Bishop of Hereford, in testimony whereof he hath hereunto set his hand and episcopal seal, to effect certain improvements in and about the episcopal house of residence belonging to the see of Hereford, by rebuilding the stables and out-buildings attached thereto; and that towards this purpose the sum of eight hundred pounds, being less than the amount limited by the said first recited Act, should be provided by the said bishop's borrowing the same by way of mortgage on the

security of all or any part of the lands, tenements and hereditaments of and belonging to his see, according to the provision for that purpose contained in the said first recited Act:

"And whereas it has been agreed between us and the said Rean Dickson Bishop of Hereford, that the said improvement shall be made and completed, according to specifications and plans to be approved by us and to the satisfaction of an architect to be named by us, and within a time to be limited in a contract to be made for that purpose; and that all costs, charges and expenses in and about the completion thereof and incidental thereto, and to effecting the said mortgage, over and above the sum of eight hundred pounds, shall be defrayed by the said Renn Dickson Bishop of Hereford, his executors or administrators:

"Now, therefore, we humbly recommend and propose, with the consent aforesaid, that the said Renn Dickson Bishop of Hereford be authorized to borrow from the Governors of the Bounty of Queen Anne, and that the said Governors be empowered to lend, under the provisions of the said hereinbeforerecited Acts, the sum of eight hundred pounds, and, as a security for the same, that the said Renn Dickson Bishop of Hereford do mortgage all or any part of the lands, tenements and hereditaments of and belonging to his said see to the said Governors, by deed, for the term of thirty-five years, or until the said sum of eight hundred pounds, with the interest for the same, and all costs and charges which may attend the recovery thereof, shall be fully paid and satisfied; and that such principal sum shall, be repaid with interest in manner following, that is to say, from and after the expiration of the first year of the said term. computed from the day of the date of the mortgage. in which year no part cof the said principal sum shall be repayable; the said Renn Dickson Bishop of Hereford, or his successors, shall yearly and every year pay to the said Governors, their successors or assigns, one equal thirtieth part of the said principal sum until the whole thereof shall be penaid; and shall, at the end of the first and each succeeding year, pay interest at the rate of three pounds and ten shillings per centum per annum on the said principal sum, or on so much thereof as shall from time to time remain unpaid, and if and when it shall happen, that the principal and

interest, directed to be paid as hereinbefore mentioned, shall be in arrear and unpaid for the space of forty days after the same shall have become due, it shall and may be lawful for the said Governors, their successors or assigns, to recover the same, and the costs and charges attending the recovery thereof, by distress and sale, in such manner as rents may be recovered by landlords or lessors from their tenants by the laws in being at the time of such distress and sale, and such mortgage shall be in the form and to the effect to be approved by us, and shall bind as well the said Renn Dickson Bishop of Hereford as every succeeding bishop of the same see, until the principal and interest, costs and charges shall be paid off and discharged.

"And we further recommend and propose, that the said sum of eight hundred pounds shall be paid to us to be applied to the purposes aforesaid; and that the receipt of our treasurer for the time being, indorsed on the said mortgage deed, shall be a good and sufficient discharge to the said Governors and their successors for the same, who shall not be bound or required to see to the application thereof; and that upon the receipt of the said sum of eight hundred pounds, and upon an agreement, in writing, to the effect hereinbefore mentioned, with such conditions and covenants as may appear necessary for fully carrying into effect the arrangement aforesaid, being executed by the said Renn Dickson Bishop of Hereford and by us, and also upon a contract or contracts, in writing, for so rebuilding the said stables and out-buildings as aforesaid, containing all usual and proper covenants, conditions, stipulations and agreements, together with a bond or bonds in such form and penalty as shall appear to us to be fit and proper, being duly executed by the person or persons employed to complete such improvement, there shall be applied and paid by us to such persons at such times and in such manner as in and by the said agreement and any such contract shall be provided, the whole or any part or parts of such sum in or towards completing the rebuilding of the said stables and out-buildings.

"And we further recommend and propose, that the said agreement shall contain a covenant on the part of the said Renn Dickson Bishop of Hereford, for assuring and keeping assured such house of residence from loss or damage by fire, during the progress of the improvement aforesaid, in one of the public offices of assurance in London or Westminster, to be approved by us, in the sum of six thousand seven hundred pounds in the whole.

" And we further recommend and propose, that, on or before the day upon which the policy of assurance last effected under such agreement shall expire, the said Renn Dickson Bishop of Hereford, or his successors, shall, at his or their own personal charge and expense, in like manner assure such house and premises from like loss and damage; and that he and every future Bishop of Hereford shall, from time to time, so assure and keep assured the said house and premises in the same sum; and shall, within fourteen days after any premium for such assurance shall have become due and payable, deliver and hand over to us the receipt for such premium; and that, in case of any loss or damage by fire to the said house and premises, any and every sum of money receivable under such policy of assurance shall be paid to and deposited with us by the said Renn Dickson Bishop of Hereford, and his successors bishops of Hereford, in trust, to be applied, and the same, together with any interest and accumulations thereon, shall be applied by us towards the rebuilding or repairing and reinstating of the said house and premises, or of such part or parts thereof as may have so suffered loss or damage. in such manner as shall appear to us, with the concurrence of the Bishop of Hereford for the time being, to be fit and proper.

"And we further recommend and propose, that nothing herein contained shall prevent us from recommending and proposing any further or other measures relating to the matters aforesaid, in conformity with the provisions of the said Acts, or either of them, or of any other Act of Parliament."

And whereas the said scheme has been approved by Her Majesty in Council; now, therefore, Her Majesty, by and with the advice of Her said Council, is pleased hereby to ratify the said scheme, and to order and direct that the same, and every part thereof, shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London

contiguous parts of the said parishes of Stowe and Colwich, small portions of each of which parishes are isolated from the remainder of the parishes to which they belong; and that such proposed consolidated chapelry should be called or named, "The Consolidated Chapelry of Hixon," with boundaries as hereinafter mentioned:

"And your Majesty's said Commissioners beg leave further to represent, that it has been mutually agreed between Maria Frances Mould, of the Ashbourn-road, in the town and county of Derby, widow, as the patron of the parish church of the said parish of Stowe, and the Right Reverend John Lord Bishop of Lichfield, as the patron in right of his see of the parish church of the said parish of Colwich (with the approbation of your Majesty's said Commissioners, and with the consent of the said John Lord Bishop of Lichfield as such Bishop), that the right of presentation and appointment of an incumbent or perpetual curate

to serve the said church at, and proposed consolidated chapelry of, Hixon, should be vested in, and belong to, and, whenever occasion may require, be exercised by the said John Lord Bishop of Lichfield, and by his successors bishops of Lichfield for ever; that the consents of the said John Lord Bishop of Lichfield as the Bishop of the diocese, and also as such patron of the said parish church of Colwich as aforesaid, and the said Maria Frances Mould, as such patron of the said parish church of Stowe as aforesaid, have been severally obtained to the formation of the said proposed consolidated chapelry of Hixon, as required by the Act and section hereinbefore mentioned; in testimony whereof, the said John Lord Bishop of Lichfield and the said Maria Frances Mould have signed and scaled this representation :

"Your said Majesty's Commissioners, therefore, humbly pray, that your Majesty will be graciously pleased to take the premises into your royal consideration, and to make such order in respect thereto as to your Majesty in your royal wisdom shall seem meet."

Her Majesty, having taken the said representation, together with the map or plan thereunto annexed, into consideration, was pleased, by and with the advice of Her Privy Council, to approve thereof, and to order, as it is hereby ordered, that the proposed formation into one consolidated chapelry be accordingly made; and the agreement, in respect of the right of presentation and appointment of an incumbent or perpetual curate to serve the said church and proposed consolidated chapelry, be carried into effect, agreeably to the provisions of the said Acts; and Her Majesty, by and with the like advice, is pleased hereby to direct, that this Order be forthwith registered by the Registrar of the diocese of Lichfield.
