PROCLAMATION.

THE Royal Administration of Marine announces, for the information and guidance of mariners, that a lens apparatus of the 4th degree, with a fixed light, and giving out sharp flashes at short intervals (à feu fixé, varié par des éclats et par courtes éclipses), was put up on the Northern Lighthouse at Koster, instead of the blue light which was there before, and that the lighting of the same began on the evening of the 23rd of June last. According to the trial ordered to be made to obtain information respecting the extent and power of the light of this lighthouse, compared with the lens-light of the 3rd degree, with a fixed light, which is placed beside it, the flashing light was visible at a distance of 3 geographical miles, and the flashes, which only lasted 7 seconds, gave out as much power as the light of the fixed lighthouse.
