It is hereby notified that the Right Honourable the Earl of Clarendon, Her Majesty's Principal Secretary of State for Foreign Affairs, has received from the Lords Commissioners of the Admiralty a copy of a Despatch, dated Her Majesty's Ship "Edinburgh," Kiel, December 8, from Rear Admiral Chads, commanding Her Majesty's Naval Forces in the Baltick, informing their Lordships that the blockade of the Russian ports undermentioned had been raised from that date, " Libau, Windau, Riga, and Bernau, and "all Russian ports, roads, havens and creeks, "from latitude 55° 53' N., longitude 21° (1' 3" E., "to Cape Dager Ort, in latitude 58° 55' N., lon-"gitude 22° 0' 5" E., the ports of Hapsal, "Warmso Islands, Port Baltick, Revel, and all "Russian ports, roads, havens, and creeks, from "Cape Dager Ort to Eckholm Light, situated in "latitude 59° 43' N., and longitude 25° 48' E."

"The ports of Helsingfors and Sweaborg, and "all Russian ports, roads, havens, and creeks to "the westward of Helsingfors as far as Hango "Head (inclusive), in latitude 59° 48' N., longi-"tude 22° 53' E.; the ports of Aro and Abo, and "lastly, the whole of the ports, roads, havens, and creeks, eastward of Helsingfors, on the Finland "Shore and Eckholm Light on the coast of "Esthonia, to Cronstadt and St. Petersburgh, both "inclusive."

delineated on the map or plan hereunto annexed

and thereon coloured pink.

"Your Majesty's said Commissioners beg leave further to represent, that it also appears to them to be expedient that banns of marriage should be published, and that marriages, baptisms, churchings, and burials, should be solemnized or performed in the said church of Saint Paul, at Woodford Bridge aforesaid, and that the fees to arise therefrom should be paid and belong to the minister or incumbent of such church for the time being.

"That the consent of the Right Honourable and Right Reverend Charles James, Bishop of the said diocese, has been obtained thereto, as required by the Acts and sections hereinbefore mentioned, in testimony whereof he has signed and sealed this

V. Provisional Orders.

Sheffield and Chapel-en-le-Frith Roads.

WHEREAS the Trustees of the Sheffield and Chapel-en-le-Frith Turnpike Roads, acting under the powers of the Local Act of the 6th of George the Fourth, cap. 144, have made application to Her Majesty's Principal Secretary of State for the Home Department, pursuant to the Act of the session holden in the 14th and 15th years of the reign of Her present Majesty, cap. 38, for a Provisional Order upon the terms following;

To reduce the rate of interest on the mortgage debt charged or secured on the tolls or revenues of the said roads from the sum of five pounds per centum, per annum, to the sum of four pounds per centum, per annum, and to extinguish the whole of the arrears of interest due upon the said debt.

And whereas the said application is dated the fourth day of December, one thousand eight hundred and fifty-four, and is signed by three of the said trustees, who therein certify that the persons entitled to two-thirds of the money charged or secured on the tolls of the said roads, and remaining unpaid, have signified their consents in writing under their hands to the said application.

And whereas it appears desirable to Her Majesty's Principal Secretary of State for the Home Department that the aforesaid application should be granted upon the terms herein set forth.

Now, therefore, in pursuance of the power and authority of the said Act of the 14th and 15th of Victoria, cap. 38, given to me as one of Her Majesty's Principal Secretaries of State, I do by this Provisional Order under my hand declare, subject to the confirmation hereof by Parliament, that from the thirty-first day of December, one thousand eight hundred and fifty-four, the rate of interest shall be reduced from five pounds to four pounds per centum, per annum, upon the bonded or mortgage debt of twenty-three thousand one hundred and eighty-three pounds, charged or secured upon the tolls or revenues of the said roads, and that the whole of the arrears of interest due and remaining unpaid upon the said debt, at that date, shall be extinguished.
