A<sup>T</sup> the Court at Buckingham Palace, the 16th day of July, 1857,

#### PRESENT,

The QUEEN's Most Excellent Majesty in Council.

WHEREAS by the "Merchant Shipping Act Amendment Act, 1855," it is enacted, that in any case in which any lighthouse had been or should be thereafter erected or placed on or near the coasts of any British possession, by or with the consent of the legislative autkority of such possession, Her Majesty might, by Order in Council, fix such dues in respect thereof, to be paid by the owner or master of every ship which passes the same or derives benefit therefrom, as Her Majesty might deem reasonable.

And whereas a lighthouse has, by and with the consent of the legislative authority of the colony of Newfoundland, been erected on Cape Race, in the said colony, and a light is already exhibited therein.

And whereas the several classes of ships following, that is to say ;

All ships, whether sailing ships or steam ships, navigating from any port or ports in the British colonies in North America, to any port or ports in the United Kingdom;

All ships, whether sailing ships or steam ships, navigating from any port or ports in the United Kingdom, to any port or ports in the British colonies in North America;

All ships, whether sailing ships or steam ships, bound from any port or ports in the British colonies in North America upon any transatlantic voyage;

All ships, whether sailing ships or steam ships, arriving in any port or ports in the British colonies in North America, after any transatlantic voyage;

All ships, whether sailing ships or steam ships, arriving at any port or ports in the United Kingdom, from New York or any port in the United States, north of New York;

All steam ships leaving any port or ports in the United Kingdom for New York, or any port in the United States, north of New York;

Will pass the said lighthouse, and will derive benefit therefrom.

Now, therefore, Her Majesty in exercise of the powers vested in Her by the said recited Act, by and with the advice of Her Privy Council, is pleased to direct, that, from and after the date of this present Order, the dues in respect of the said lighthouse upon Cape Race, to be paid for every such ship as aforesaid, except ships belonging to Her Majesty, Her heirs, and successors, shall be one sixteenth of a penny per ton, of the burthen of every such ship, for every such voyage as aforesaid;

But no such dues as aforesaid, shall be levied in any colony, unless and until the legislative authority in such colony has, either by address to the Crown, or by an Act or Ordinance duly passed, signified its opinion that the same ought to be levied in such colony.

W HEREAS the Ecclesiastical Commissioners for Eugland have, in pursuance of an Act of the sixth and seventh years of Her Majesty, chapter thirty-seven, sections six and eight, duly prepared and laid before Her Majesty in Council a scheme, bearing date the eighteenth day of June, in the year one thousand eight hundred and fiftyseven, in the words following ; that is to say :

"We, the Ecclesiastical Commissioners for England, in pursuance of an Act of the sixth and seventh years of your Majesty, chapter thirtyseven, sections six and eight, have prepared, and now humbly lay before your Majesty in Council, the following scheme for authorizing the sale of certain property formerly belonging to the Prebend of Beckingham, in the collegiate church of Southwell, and now vested in us.

"And whereas all the lands, tenements, hereditaments, and endowments, formerly belonging to the said prebend (except any right of ecclesiastical patronage), became vested in us, by virtue of an Order of your Majesty in Council, bearing date the first day of May, in the year one thousand eight hundred and forty-nine, and duly published in the London Gazette on the eighth day of the same month of May, subject to any legally subsisting lease or leases thereof.

"And whereas application has been made to us for the purchase of all our estate and interest in certain portions of the said lands, tenements, and hereditaments; and after due consideration, it appears to us to be expedient that we should by empowered to dispose of our interest therein, or in any part or parts thereof, in such manner as shall appear to us to be advisable : "We, therefore, humbly recommend and pro-

"We, therefore, humbly recommend and propose, that we may be authorized and empowered, by instrument or instruments in writing duly executed according to law, from time to time to sell or dispose of, and duly to convey, according to the pro visions of the said Act, all or any of the said lands, tenements, hereditaments, or endowments heretofore belonging to the said prebend of Beckingham, and so vested in us as aforesaid, with their appurtenances, and all our estate, right, title, and interest therein, or in any part or parts thereof, unto and to the use of any person or persons desirous or willing to purchase the same, and his or their heirs, executors, administrators, or assigns, or otherwise as he or they shall direct or appoint, and for such consideration as shall upon due calculation and inquiry appear to us to be just and reasonable.

"And we further recommend and propose, that nothing herein contained shall prevent us from recommencing and proposing any other measures relating to the matters aforesaid, or any of them, in accordance with the provisions of the said Act, or of any other Act of Parliament."

And whereas the said scheme has been approved by Her Majesty in Council; now, therefore, Her Majesty, by and with the advice of Her said Council, is pleased hereby to ratify the said scheme, and to order and direct that the same and every part thereof shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette pursuant to the said Act; and Her Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the diocese of Lincoln.

W HEREAS the Ecclesiastical Commissioners for England have, in pursuance of an Act of the eleventh and twelfth years of Her Majesty, chapter thirty-seven, section three, and of the Act of the nineteenth and twentieth years of Her Majesty, chapter fifty-five, section one, duly prepared and laid before Her Majesty in Council a representation bearing date the twenty-cight day of May, in the year one thousand eight hundred and fifty-seven, in the words and figures following that is to say:

"We, the Ecclesiastical Commissioners for England, in pursuance of the Act of the eleventh and twelfth years of your Majesty, chapter thirty-seven, section three, and of the Act of the nineteenth and twentieth years of your Majesty, chapter filty-five, section-one, have prepared and now hunbly lay before your Majesty in Council, the following representation with respect to an alteration of the boundaries of the district chapelry called 'The Trinity District,' in the county of Kent, and diocese of Canterbury.

"Whereas by the authority of an Order of your Majesty in Council, hearing date the first day of April, one thousand eight hundred and forty-one, and duly published in the London Gazette, on the fourth day of the following month of June, the said Trinity District was duly assigned out of the parish of Saint Mary the Virgin, Dover, in the said county and diocese.

"And whereas it has been made to appear to us that it would be expedient that the boundaries of such district should be altered by adding thereto a portion of the adjacent parish of Saint James, Dover, in the said county and diocese as hereinafter mentioned.

"Now, therefore, with the consent of the Right Honourable and Most Reverend John Bird, Archbishop of Canterbury (who is patron in right of his see of the said district chapelry, called Trinity District, and of the said parish of Saint James, Dover), and of the Reverend William Edward Light, Incumbent of the said parish of Saint James, Dover, and of the Reverend Lewis Borrett White, Incumbent of Trinity District aforesaid, in testimony whereof they have respectively signed and sealed these presents, we beg leave to represent that it appears to us to be expedient that the boundaries of the said district chapelry, called Trinity District, shall hereafter be altered by the addition to such district chapelry, of all that part of the said parish of Saint James, Dover, which is situated to the south, west, and south-west, of an imaginary line, commencing at a point on the sea shore, opposite to the middle of the roadway or passage between the premises, known as Marsh's Baths, and the house, numbered 1, in Waterloocrescent, and thence proceeding along the middle of such roadway or passage and of the roadway leading thence to the street, called the New Bridge, and also along the middle of such last-mentioned street, until it crosses the boundary between the said parish of Saint James, and the parish of Saint Mary, Dover, as the same is more particu-larly delineated on the map or plan hereunto annexed.

"And we humbly pray that your Majesty will be graciously pleased to take the premises into your royal consideration, and to make such Order in respect thereto as to your Majesty in your royal wisdom shall seem meet."

Her Majesty having taken the said representation, together with the map or plan thereunto annexed, into consideration, was pleased, by and with the advice of Her Privy Council, to approve thereof, and to order, as it is hereby ordered, that the proposed addition and alteration be accordingly made and effected agreeably to the provisions of the said Acts, and Her Majesty is further pleased, by and with the like advice, to direct that this Order be forthwith registered by the Registrar of the diocese of Canterbury.

WHEREAS by an Act, passed in the session of Parliament, held in the eighteenth and nineteenth years of Her Majesty's reign, initialed "An Act further to amend the "laws concerning the burial of the dead in "England" it is, amongst other things, enacted that it shall be lawful for Her Majesty, by and with the advice of Her Privy Council, from time to time, to postpone the time appointed by any Order in Council for the discontinuance of burials, or otherwise to vary any Order in Council made under any of the Acts recited in the said Act, or under the said Act (whether the time thereby appointed for the discontinuance of burials thereunder, or other operation of such Order, shall or shall not have arrived), as to Her Majesty, with such advice as aforesaid, may seem fit;

And whereas certain Orders in Council have been made, directing the discontinuance of burials in the churchyards and burial-grounds hereinafter mentioned from the time mentioned in such Orders respectively; and whereas it seems fit to Her Majesty, by and with the advice of Her Privy Council, that the time for discontinuing burials in the said churchyards and burial-grounds be postponed;

Now, therefore, Her Majesty, by and with the advice aforesaid, is pleased to order, and it is hereby ordered, that the time for the discontinuance of burials in such churchyards and burialgrounds be postponed as follows, viz.:

- In the churchyard of BALDOCK, Herts, from the first of July instant to the first of January, one thousand eight hundred and fifty-eight;
- In All Saints' Churchyard, in Christ Churchyard, and in Holy Trinity Churchyard, and in the burial-grounds of the Ebenezer and Mares Green Independent Chapels, and of the Wesleyan Chapel, all in WEST BROM-WICH, from the first of July instant to the first of January, one thousand eight hundred and fifty-eight;
- In the churchyard of CHEPSTOW from the first of July to the first of October, one thousand eight hundred and fifty-seven ;
- In the churchyard of EGHAM, Surrey, from the first of July to the first of October, one thousand eight hundred and fifty-seven ;
- In such parts of the churchyard, and of the Bethesda and Saron (Independent), the Bethania and Salem (Baptist), and the Hermon (Calvinistic Methodist), Chapelyards, as are not free from water and remains, in LLANGYNWYD, Glamorganshire, from the first of July to the first of September, one thousand eight hundred and fifty-seven;
- In All Saints' Churchyard, and in the burialgrounds of the General Baptist Chapel, Woodgate, of the Roman Catholic Chapel, of the Baptist Chapel, Sparrow Hill, and of the Independent Chapel, all in LOUGHBOROUGH, from the first of July to the first of September, one thousand eight hundred and fiftyseven;
- In the new parish burial-ground, and in Bechen Grove Chapel Burial-ground, in the parish of WATFORD, Herts, from the first of July to the first of November, one thousand eight hundred and fifty-seven;
- In Saint Giles's Churchyard, WILLENHALL, from the first of July to the first of October, one thousand eight hundred and fifty-seven;

And whereas by an Order in Council of the sixth of May last (varying a former Order), interments were directed to be discontinued in the Roman Catholic Burial-ground, FAILSWORTH, Manchester, from and after the first of this instant July, unless the ground were effectually drained to the depth of seven feet at the least, and it seems fit that the said Order be varied; now, therefore, Her Majesty, by and with the advice of Her Privy Council, is pleased to order, and it is hereby ordered, that interments in the said burialground be discontinued from and after the first of October, one thousand eight hundred and fiftyseven, unless the ground be effectually drained, as above mentioned.

W HEREAS the Right Honourable Sir George Grey, Bart., one of Her Majesty's Principal Secretaries of State, after giving to the Incumbents and Vestry Clerks of the undermentioned parishes, ten days' previous notice of his intention to make such representations, has, under the provisions of an Act, passed in the session of Parliament held in the fifteenth and sixteenth years of Her Majesty's reign, initialed "An Act to amend "the laws concerning the burial of the dead in "the metropolis," made two representations, stating, that for the protection of the public health, burials should, be forthwith discontinued in such parishes as follows, viz. :

- TOOTING, SURREY. Forthwith beneath the parish church of Tooting Graveney, Surrey, and in the vaults under the porch (provided nevertheless that the Reverend R. W. Greaves may, at his decease, be interred in the vault under the said porch, in which his late wife has been buried); that in the family vaults and brick graves in the churchyard each coffin be separately entombed in brick or stone work properly cemented, and that in no grave shall any interment take place without a covering of earth four feet thick at the least, measuring from the upper surface of the coffin to the ordinary level of the ground.
- WOOLWICH.—Forthwith in the *Roman Čatholic* Chapel and Burial-ground, situated in the parish of Woolwich.
- SAINT ANDREW, HOLBORN.—Forthwith wholly underneath the parish church of Saint Andrew, Holborn, and underneath Holy Trinity Church, Gray's-inn-lane, and in the burial-ground of the same belonging to the parish of Saint Andrew, Holborn.
- SAINT MARY, NEWINGTON.—Forthwith in the vaults and catacombs underneath Saint Peter's Church, Walworth, in the parish of Saint Mary, Newington, and also in the churchyard, with the exception of vaults and brick graves in existence prior to the first of July, one thousand eight hundred and fiftytwo, and which can be opened without disturbing soil that has been already buried in, in which each body shall be embedded in powdered charcoal, four inches thick, and be separately entombed in brick or stone work properly cemented, and in which the only bodies interred shall be those of the husband, wife, parents, unmarried children and brothers and sisters of persons already buried therein.
- and sisters of persons already buried therein. CAMBERWELL.—In the burial-ground of the hamlet of *Dukwich*, in the parish of Camberwell, except so far as they are compatible with the following regulations. That in family vaults and brick graves each coffin be separately entombed in brick or stone work properly cemented, that in family earthen graves a layer of one foot and six inches of earth be left between each coffin, and that no new grave be opened except in ground which has never hitherto been buried in.
- SAINT ALPHAGE, GREENWICH.—Forthwith in the parish churchyard of Saint Alphage, Greenwich, except in vaults and brick graves, which were in existence prior to July first, one thousand eight hundred and fifty-two, and which can be opened without disturbing ground that has been already buried in, and

in which each coffin shall be embedded in a layer of powdered charcoal, four inches thick, and be separately entombed in brick or st me work properly cemented, and that the only bodies interred be those of the husband, wife, parents, unmarried children, and brothers and sisters of persons already buried therein.

Now, therefore, Her Majesty in Council is pleased hereby to give notice of such representations, and to order that the same be taken into consideration by a Committee of the Lords of Her Majesty's Most Honourable Privy Council, on the thirty-first day of August next:

And Her Majesty is further pleased to direct that this Order be forthwith published in the London Gazette; and that copies thereof be affixed on the doors of the churches or chapels of the said parishes, or on some conspicuous places within the part or parts of the metropolis affected by such representation, one calendar month at the least before the said thirty-first day of August next.

WHEREAS the Right Honourable Sir George Grey, Bart., one of Her Majesty's Principal Secretaries of State, after giving to the Incumbents and the Churchwardens of the parishes hereinafter mentioned, ten days' previous notice of his intention to make such representations, has, under the provisions of an Act, passed in the session of Parliament, held in the sixteenth and seventeenth years of Her Majesty's reign, intituled "An Act to amend the laws con-" cerning the burial of the dead in England " beyond the limits of the metropolis, and and " to amend the Act concerning the burial of " the dead in the metropolis," made two representations stating that, for the protection of the public health, no new burial-ground should be opened in any of the undermentioned parishes without the previous approval of one of Her Ma-jesty's Principal Secretaries of State, and that burials should be discontinued therein, with the following modifications;

- BRISTOL, ST. PHILIP AND ST. JACOB.—Forthwith wholly in the burial-ground of Thrisslestreet Baptist Chapel, in the parish of Saint Philip and Saint Jacob, Bristol.
- CHETWYND, SALOP.—Wholly in the parish church and in the churchyard, except in that part of it which is west of the church, and so far as is compatible with the observance of the regulations for new burial grounds.
- ROCHDALE AND HALIFAX.—On and after the first October, one thousand eight hundred and fifty-seven, in the Old Churchyard of Todmorden (except in walled graves existing on the twelfth of June, one thousand eight hundred and fifty-seven, in which each coffin shall be imbedded in charcoal, and separately entombed in an airtight manner); and in the Independent and Independent Inghamite Burial-grounds, all in the town of Todmorden, and parish of Rochdale, and in the Unitarian and Quakers Burial-grounds in Todmorden, and parish of Halifax, except so far as is compatible with the observance of the regulations for new burial grounds.

Now, therefore, Her Majesty in Council is pleased hereby to give notice of such representations, and to order that the same be taken into consideration by a Committee of the Lords of Her Majesty's Most Honourable Privy Council, on the thirty-first day of August next;

And Her Majesty is further pleased to direct that this Order be forthwith published in the London Gazette; and that copies thereof be affixed on the doors of the churches or chapels of, or on some conspicuous places within, the parishes affected by such representation, one month before the said thirty-first day of August.
