IT is hereby notified, that Mr. Buchanan, Her Majesty's Envoy Extraordinary and Minister Plenipotentiary at Madrid, received from Senor Calderon Collantes, the Secretary for Foreign Affairs of Her Catholic Majesty The Queen of Spain, on the 30th ultimo, a Note, of which the following is a translation:—

I HAVE the honour to forward to you herewith a copy of this day's Gazette, which contains the official Notification of the Blockade of the Ports of Tangier, Tetuan, and Larache, on the Coast of Morocco:

I request you to have the goodness to acquaint your Government with this Notification, for the information of the subjects of Her Majesty the Queen of Great Britain.

The following is a Translation of the Official Notification contained in the number of the Madrid Gazette, forwarded by Senor Collantes to Mr. Buchanan, with the above translated Note.

(Translation.)

Department of the Ministry of State.

Notification of Blockade of the Ports of Tangier, Tetuan, and Larache.

Notice is hereby given, that according to communications addressed to the Minister of State by the Minister of Marine, with reference to the Commander-in-Chief of the Spanish Naval Forces destined to operate on the Coast of Africa, on the 28th of the present month of October, the ports and anchorages of Tangier, Tetuan, and Larache, on the coasts of Morocco, were in a state of effective Blockade by the competent number of vessels of the Royal Navy. Correspondence relating to Spanish Occupation at Tangier, or on Coast of Morocco.

No. 1.

Lord J. Russell to Mr. Buchanan.

SIR, Foreign-Office, September 22, 1859.

VITH reference to the preparations making in Spain with a view to hostilities in Morocco, I wish you to observe to the President of the Council and to the Minister of Foreign Affairs, that the differences between the Governments of Spain and Morocco appear to have arisen from outrages committed by Moors in the vicinity of Ceuta, but that those outrages appear to have been provoked by the excitements and defiances of the Governor of Ceuta; that a wild and untamed race seem to have become ungovernable, and to have made hostile attacks against the Spanish garrison of Ceuta.

That if the Spanish Government only seek redress for wrongs, and vindication of their honour, Her Majesty's Government will not interpose any obstacle to their obtaining such reparation. But if the outrages of the wild Moorish tribes are to be made a ground for conquest, and especially on the coast, Her Majesty's Government are bound to look to the security of the fortress of

Gibraltar.

You are therefore instructed to ask for a declaration in writing, that if the Spanish troops should in the course of hostilities occupy Tangier, that occupation will be temporary, and will not extend beyond the ratification of a Treaty of Peace between Spain and Morocco. For an occupation till an indemnity is paid might become a permanent occupation, and such permanent occupation Her Majest,'s Government consider inconsistent with the safety of Gibraltar.

Her Majesty's Government are sincerely desirous of maintaining with Spain the most amicable relations, but they are bound to provide for the

safety of Her Majesty's possessions. I am &c.,

Mr. Buchanan to Lord J. Russell,—(Received October 12.)

My Lord, Madrid, October 7, 1859.

HAVING made M. Calderon Collantes acquainted with the contents of your Lordship's

despatch of the 22nd ultimo, instructing me to ask the Spanish Government for a declaration in writing, that if, in the event of war between Spain and Morocco, Tangier should be occupied by Spanish troops, they will be withdrawn immediately after the ratification of a Treaty of Peace, it was agreed between us that I should address to his Excellency the note of which I inclose a copy herewith for your Lordship's information; and I received this day from him an answer, of which a copy and translation are inclosed, and which I I trust may prove satisfactory to Her Majesty's Government.

Mr. Buchanan to Señor Collantes.

Madrid, September 27, 1859.

DURING the discussions which took place last winter between Spain and Morocco, respecting the claims of Spanish subjects upon the Sultan's Government and the zone round Melilla, I did not fail to report to my Government the frequent assurances which I received from your Excellency, that the only object, at that time, of Her Catholic Majesty's Government was to secure due protection to Her Majesty's fortress, and to Her Majesty's subjects residing in or trading with Morocco, and that they had no intention whatever of making the questions at issue a pretext for territorial aggrandisement in Africa.

These assurances were entirely confirmed by the event, and I have been happy to learn from the declaration contained in your Excellency's note of the 26th instant, and from the verbal explanations which you have afforded me, on repeated occasions since the new difficulty which has arisen with the Government of Morocco, that no change has taken place in the policy of the Spanish Government, and that they seek for no conquests in Africa, but only propose to obtain reparation for offences which have been offered to them by the Moors of Ceuta, and securities from the Government of the Sultan for that fortress, and Her Catholic Majesty's other possessions in Africa, which will effectually prevent a repetition of the conflicts which have taken place, and maintain hereafter the relations of Spain with the Moroccan Empire on a satisfactory and honourable footing.

The reports of my conversations with your Excellency will thus have already acquainted the Government of the Queen my Sovereign with the sentiments of moderation and justice which animate Her Catholic Majesty's Government; but it would, notwithstanding, be a satisfaction to them, considering the interest which they take in the Empire of Morocco, and the importance which they attach to the commerce of Tangier with Her Majesty's possessions in the Mediterranean, to learn from your Excellency that the great preparations at present making, with a view to military operations in Africa, have not arisen from any change in the views of Her Catholic Majesty's Government, and do not indicate any intentions on their part to make conquests in Morocco, or to occupy permanently any portion of the Sultan's territory.

Feeling assured that your Excellency will readily comply with the wish which I have the honour to express to you on this subject, I avail, &c.

Muy Señor Mio,

HE recebido la nota que VS. se ha servido

dirigirme en 27 del mes proximo pasado.

El Gobierno de la Reina mi Señora, al adoptar las disposiciones necesarias para alcanzar, si fuere menester por la fuerza de las armas, la justa reparacion pedido al Gobierno Marroqui, sigue sus constantes propositos respecto á aquel pais: propositos que VS. conoce por las manifestaciones verbales que espontaneamente le hice el año pasado con motivo de la cuestion de Melilla, confirmadas en mis notas posteriores a VS., y en la circular que he dirigido en 24 de Setiembre á los Representantes de Su Magestad en las Cortes de Europa, y de cuyo contenido habrá dado noticia el Señor Don Xavier de Isturitz al Señor Principal Secretario de Estado para los Negocios Estrangeros de Su Majestad Británica.

El Gabinete de Madrid, como VS. sabe, no ceda en esta cuestion al impulso de un deseo preexistente de engrandecimiento territorial; le mueve tan solo el deber sagrado de defender su

dignidad y el honor da la nacion.

Aun conserva esperanzas de que se termine pacificamente el conflicto suscitado por las agresiones inmotivadas de que ha sido objeto la plaza de Ceuta; pero si sus deseos conciliadores no fuesen realizados, procurará por otros medios alcanzar el castigo de los agresores, la satisfaccion debida, y la celebracion de acuerdos encaminados á dar garantias materiales y eficaces para evitar la

repeticion de tales desmanes.

Estos son los objetos á que habian de dirigirse las operaciones militares, si comenzasen. En tal concepto, fácil es comprender, conocidas las intenciones del Gobierno de la Reina mi Señora, que cualquier menoscabo que, por causa de la guerra, pudiera sufrir el activo comercio que sostiene la Gran Bretaña, con Tanger, habria de ser tansitorio, puesto que una vez ratificado el Tratado de Paz que haya de poner termino á las hostilidades entre España y Marruecos, y resueltas favorablemente, por lo tanto de un modo definitivo, las cuestiones hoy existentes, el Gobierno Español, cumpliendo con sus propositos, non mantendria la ocupacion de aquella plaza, dado caso que se viera en la necesidad de establecerse en ella para asegurar el buen exito de sus operaciones.

Palace, October 6, 1859. . I HAVE received the note which you had the

goodness to address to me on the 27th of the month

The Government of the Queen my Sovereign, while adopting the measures necessary to obtain, if requisite by force of arms, the just reparation which they have demanded from the Moroccan Government, continue in their invariable intentions with regard to that country-intentions of which you are cognizant by means of the verbal statements which I spontaneously made to you last year with reference to the question of Melilla, and which have been confirmed by my subsequent notes to you, and by the circular which I addressed, on the 24th of September, to Her Majesty's Representatives at the Courts of Europe, with the contents of which Don Xavier de Isturiz will have acquainted Her Britannic Majesty's Principal Secretary of State for Foreign Affairs.

The Cabinet of Madrid, as you are aware, do not yield in this question to the impulse of a pre-existing desire for territorial aggrandizement, but are influenced alone by the sacred duty of defending their dignity and the honour of the nation.

They still preserve hopes that the conflict which has arisen from the unprovoked aggressions of which the fortress of Melilla has been the object, may terminate peacefully; but if their conciliatory desires should not be realized, they will endeavour to obtain, by other means, the punishment of the aggressors, the satisfaction which is due, and the conclusion of agreements which may tend to give efficacious material guarantees for preventing the repetition of similar outrages.

It is to these objects that military operations, should they commence, would be directed. In this point of view it is easy to understand, knowing the intentions of the Government of the Queen my Sovereign, that whatever diminution the active commerce which Great Britain maintains with Tangier might suffer in consequence of war, would be of a transitory character; since, when once the Treaty of Peace which should put an end to the hostilities between Spain and Morocco should be ratified, and the questions now existing should be settled favourably, and therefore definitively, the Spanish Government, in the fulfilment of their intentions, would not continue in the occupation of that fortress, on the supposition that they should have found themselves obliged to establish themselves there, in order to secure the favourable issue of their operations.

Lord J. Russell to Mr. Buchanan.

SIE, Foreign-Office, October 15, 1859. HER Majesty's Government have had under their consideration the note addressed to you by Señor Collantes on the 6th of October, of which a copy was inclosed in your despatch of the following day, in reply to the demand for explanations which you were instructed by my despatch of the 22nd of September to require of him respecting the intentions of the Spanish Government in the event of the occupation of Tangier by the Spanish forces.

You were instructed to apply to the Spanish Government for a declaration, in writing, that if the Spanish troops should, in the course of hostilities, occupy Tangier, that occupation would be temporary, and would not extend beyond the ratification of a Treaty of Peace between Spain and Morocco; and in your note to Señor Collantes of the 27th of September you said that it would be a satisfaction to Her Majesty's Government to learn that the military preparations of the Spanish Government did not indicate any intentions on their part to make conquests in Morocco, or to occupy permanently any portion of the Sultan's territory.

Señor Collantes, in his reply of the 6th of October, states that when once the Treaty of Peace which should put an end to the hostilities between Spain and Morocco should be ratified, the questions now existing being settled favourably, and therefore definitively, the Spanish Government, in fulfilment of their intentions, would not continue in the occupation of that fortress (Tangier), in the supposition that they should have found themselves obliged to establish themselves

there in order to secure the favourable issue of their operations.

You will state to M. Collantes that Her Majesty's Government accept with pleasure this assurance, as conveying the declaration which, by my despatch of the 22nd of September, you were instructed to ask for.

You will further state to his Excellency that Her Majesty's Government earnestly desire that there may be no change of possession on the Moorish coast of the straits. The importance they attach to this object cannot be over atel; and it would be impossible for them, or indeed for any other maritime power, to see with indifference the permanent occupation by Spain of such a position on that coast as would enable her to impede the passage of the straits to ships frequenting the Mediterranean for commercial or any other purposes.

You will read this despatch to Señor Collantes, and furnish his Excellency with a copy of it.

Mr. Buchanan to Lord J. Russell—(Received October 29.)

MY LORD, Madrid, October 24, 1859. WITH reference to your Lordship's telegrams of the 19th and 20th instant, on the subject of the alleged intention of Spain to obtain a cession from Morocco of several miles of territory on the coast of the Straits of Gibraltar, I have the honour to inclose herewith the copy of a note which I addressed to M. Calderon Collantes on the 21st instant, expressing the objections which Her Majesty's Government would entertain to the occupation by Spain of the coast west of Ceuta; and requesting his Excellency to name the points on that coast which would be included in the rayon of the fortress, if the views of Her Catholic Majesty's Government are carried into

I have also the honour to inclose the copy and translation of an answer which I have received from his Excellency, declaring distinctly that Her Catholic Majesty's Government have no intention to occupy any point on the said coast, which would give Spain a superiority that would be dangerous to the navigation of the straits.

Mr. Buchanan to Señor Collantes.

Madrid, October 21, 1859.

THE Government of the Queen my Sovereign have reason to believe, from the reports of Her Majesty's Charge d'Affaires at Tangier, and from the late declarations of Her Catholic Majesty's Government in the Cortes, that Her Catholic Majesty is about to declare war to the Emperor of Morocco, in consequence of the Moorish Government having declined a demand on the part of her Government that certain territory lying between the fortress of Ceuta and the mountainous ridge, or Sierra of Bullones, should be ceded to Spain.

From my verbal communications to your Excellency on this subject, you are already aware that the Government of the Queen my Sovereign

entertain apprehensions that the cession to Spain of the territory in question cannot take place without seriously compromising the freedom of the navigation of the Straits of Gibraltar; and it is, therefore, my duty, in execution of instructions which I have received from Her Majesty's Principal Secretary of State for Foreign Affairs, to inquire how far Her Catholic Majesty's Government propose that the rayon of Ceuta should be extended, and more particularly to request that your Excellency will have the goodness to name the points on the coast which, in the event of the views of Her Catholic Majesty's Government being carried into effect, would be included within the territory of Spain.

In addressing these inquiries to your Excellency, I am further to request that I may receive answers to them at your Excellency's earliest convenience.

Señor Collantes to Mr. Buchanan.

Palacio, 21 de Octubre de 1859.

Muy Señor mio,

HE recibido la nota que con fecha de hoy se ha servido VS. dirigirme, y me he enterado con especial atencion de su contenido.

En el estado en que hoy se halla la cuestion de Marruecos, por la inconcebible resistencia del Gobierno del Sultan a satisfacer las justas demandas de la España, es muy dificil, sino imposible, para el Gabinete de Madrid determinar, ni aun aproximadamente, la naturaleza de las garantias que podrá verse en la necesidad de pedir para afianzar los resultados de las hostilidades proximas á comenzarse.

VS. no puede desconocer, ni ocultarse tampoco á la ilustracion de su Gobierno, que cuando dos naciones apelan, para resolver sus diferencias, á la fuerza de las armas, al romperse las negociaciones diplomaticas que se siguieron sin resultado, se declaran nulas, y se tienen por no hechas las proposiciones anteriores, reservandose ambas partes el derecho de renovarlas 6 de presentar otras diferentes, segun conviene á sus intereses, y corresponde al éxito de las operaciones militares. Apesar de esto, el Gobierno de la Reina mi Señora, que tantas y tan señaladas pruebas ha dado de su espiritu conciliador y recto en los varios incidentes de la cuestion con Marruecos, no cambiará el proposito que desde su origen habia formado, de no ocupar en el Estrecho punto alguno cuya posicion pueda proporcionar á España una superioridad peligrosa para la navegacion. En esta materia sus ideas han sido siempre tan desinteresadas y leales que no puede creer que se haya concebido duda alguna acerca de ellas.

Sin embargo el Gobierno de Su Magestad, en cuyo nombre he hado á VS. repetidamente las esplicaciones necesarias para disipar todo genero de dudas, si tal vez se habian concebido respecto á sus propositos, no quiere omitir la manifestacion consignada, seguro de que el Gobierno de Su Magestad Británica, al pedirlo, no tiene otro objeto que él de poner á salvo los intereses de la Gran Bretaña, y de ningun modo intervenir en la contienda proxima a empeñarse entre dos pueblos independientes.

STR, I HAVE received the note which you have had the goodness to address to me, dated this day, and I have informed myself of its contents with particular attention.

In the present state of the question of Morocco, owing to the inconceivable resistance of the Sultan's Government to satisfying the just demands of Spain, it is very difficult, if not impossible, for the Cabinet of Madrid to determine, even approximately, the nature of the guarantees which they may find themselves under the necessity of asking, in order to assure the results of the hosilities which are on the point of commencing

You cannot be unaware, nor can your enlightened Government either be ignorant, that when two nations appeal for the settlement of their differences to force of arms, on the diplomatic relations, which have been pursued without effect being broken off, former proposals are declared null, and considered as if they had not been made, while both parties reserve to themselves the right of renewing them, or of presenting others of a different kind, according as it may suit their interests, and correspond to the results of the military operations.

Notwithstanding this, the Government of the Queen my Sovereign, who have given so many and such marked proofs of their conciliatory and upright spirit in the different incidents which have sprung from the question with Morocco, will not vary the intentions which they had formed from the beginning of that question, not to occupy any point on the Straits whose position could afford to Spain a superiority dangerous to the navigation. In this matter their ideas have been always so disinterested and loyal that they cannot believe that any doubt can have been conceived with regard to them.

Nevertheless, Her Majesty's Government, in whose name I have repeatedly offered to you the explanations necessary for dissipating every species of doubt, if by chance it had been conceived with respect to their intentions, do not wish to omit the statement made above, feeling sure that Her Britannic Majesty's Government, in asking for it, have no other object than to secure the safety of the interests of Great Britain, and not in any manner to interfere in the contest which is about to be engaged in between two independent nations.

No. 1.

Extract of a Letter from Major-General Sir Hugh Rose, G.C.B., dated May 14, 1859.

Para. 16.—I have already praised the excellent conduct of the B. Company Madras Sappers and Miners, which formed part of my force; but I now beg leave to request most respectfully his Lordship, the Commander-in-Chief in India, to have the goodness to convey, to his Excellency the Commander-in-Chief of the Madras Army, the high sense which I entertain of the excellent service which they performed under my orders; they lived on the very best terms with their Eng-

lish comrades; no work was too dangerous, or too difficult, for the gallantry and the devotion of this company, which has been twenty years on foreign service. On account of the great length of hard service which the company had gone through, it was to return to Madras from Calpee; but, on Gwalior falling into the hands of the rebels, the company again took the field with the utmost alacrity, and again earned not only my sincere approbation, but that also of the Central India Field Force, by its unvarying gallantry and Captain Brown deserves to be specially mentioned, for having led this distinguished company at the escalade of Jhansi, and for having commanded it from the 5th July, 1857, when its commander, Lieutenant-Colonel Boileau, was appointed to the staff, till the close of the operations against Jhansi, when he fell sick. Lieutenant Gordon then took the command of the company, and I beg to mention him specially for the satisfactory manner in which he performed this duty. The Subadar of the company has a full right to be specially mentioned for his admirable conduct throughout the campaign.

GENERAL ORDER.

Fort William, August 19, 1859. No. 1178.

HIS Excellency the Governor-General in Council is pleased to direct the publication of the following report from Lieutenant Roome, of the 10th Bombay Native Infantry, commanding the Field Detachments at Basoda, of a spirited and successful action against the rebel forces, under Adil Mahomed Khan, near Goonapoora, on the 23rd June, 1859.

Brigadier-General Sir R. Napier, K.C.B., to the Chief of the Staff.

Sir, Morar, July 14, 1859.

I HAVE the honour to forward, for the information of the Right Honourable the Commanderin-Chief, a report, received through Lieutenant-Colonel Boyle, commanding at Seronge, of a second successful attack upon the rebels, under Adil Mahomed Khun, by that gallant and enterprising officer Lieutenant Roome, 10th Bombay Native Infantry. I entirely concur in the favourable terms in which Colonel Boyle mentions Lieutenant Roome and the officers and men under his command.

Lieutenant-Colonel W. Boyle to the Assistant Adjutant General, Gwalior Division.

Sir, Camp near Seronge, July 1, 1859.

I HAVE the honour to forward, for submission to Brigadier-General Sir R. Napier, commanding the division, a Report from Lieutenant Roome, (10th Bombay Regiment of Native Infantry), commanding the Field Detachments at Basoda, of a successful encounter with rebel forces under Adil Mahomed Khan, near Goonapoora, on the 23rd ultimo.

2. The operations described in Lieutenant Roome's Report appear to me highly creditable to him and to the force under him; and I wish to express to the Brigadier-General my sense of Lieutenant Roome's praiseworthy exertions, zeal, and intelligence, on the particular service on which he is employed.

3. It affords me much pleasure to point out to the Brigadier-General the warm terms in which the services of Lieutenant Blair, of Mayne's Herse, and of his detachment also, are mentioned on this occasion by Lieutenant Roome, and the good spirit shown by all the officers and men of the force, and I hope for the good offices of Sir R. Napier on behalf of Ressaldar Indur Sing. of Mayne's Horse (wounded in the engagement), who is specially mentioned.

Lieutenant Ford Roome, to the Staff Officer Deopoor.

Camp, Garrispore, June 24, 1859. I HAVE the honour to request you will forward, through Colonel Boyle, commanding Brigade at Deopoor, to General Napier, commanding Gwalior Division, this my Report of a successful attack on Adil Mahomed, on the hills near Goona-I left this place yesterday morning at l A.M., with a force as per margin,* and proceeded by a jungle track over several ranges of hills, till I arrived at their encampment; this I found burnt to the ground and deserted, but in the bushes we took two prisoners, who told us that Adil Mahomed was encamped on the hills with 2000 men, of whom 80 were mutinied Cavalry Sowars, and 700 Teelingas, or mutinied regular Sepoys, and the remainder Budmashes and Villaities. I ought to say that we had heard from a woman we met on the road, that the Patell of Goonapoora had advised her to leave, as it was the intention of the rebels to have a fight with the English force coming to attack them. Taking all this into consideration, and also the smallness of my force. I advanced to the attack of their camp with the greatest caution. I threw out a portion of my infantry as skirmishers, keeping the remainder as a support. In this order we reached the enemy's position, but found that, at the eleventh hour, their courage had failed them, and they had retreated. Perceiving from the freshness of their tracks, that they had only lately left, I sent on Lieutenant Blair with the cavalry in pursuit, and followed myself with the infantry to support him, should the enemy make a stand as I expected.

Lieutenant Blair, after a gallop of about a mile through thick jungle, came upon a large body of the enemy, which he at once charged. They were regular sepoys and sowars mounted on horses and ponies, and, though many of them made a desperate resistance, yet the detachment of Mayne's Horse, under Lieutenant Blair's able leadership, managed to cut up a great number of them. The infantry were not altogether idle, for the skirmishers put up, in one of the nullahs, a few rebels who had escaped the cavalry, and shot or bayoneted them altogether. I am of opinion that at least 100 were sabred by the cavalry, who, with their gallant young officer, did their work admirably. Lieutenant Blair speaks highly of the behaviour of the

whole of his men, on this occasion, more especially of the Sikh troops, which happened to be in front. He also begs to recommend to the special notice of General Napier, Ressaldar Indur Sing (whose name I had much pleasure in once before bringing to his favourable notice, and who was yesterday wounded on the wrist); also Sowar Rum Sing, who received a sword cut on the right shoulder; as also Sowar Bheekum Sing, who cut down the sepoy, who wounded the Ressaldar, and in doing so received a cut through the boot.

On our return, as the column approached the village of Goonapoora, some rebels who were hid in the houses, fired out and shot a Duffadar of the Camel Corps. I at once formed the infantry into three storming parties, under the respective leaderships of Lieutenants Harris, Newport, and myself. We lost no time in attacking. Lieutenant Harris's and my party stormed the village, and Lieutenant Newport's a hill at the back of it. We drove the rebels out of the village, and towards Lieutenant Newport's party; but, owing to the admirable cover they had, and the denseness of the jungle, they escaped with the loss of about ten of their number. We then returned to the village of Goonapoora, which we found full of grain and other supplies, sufficient for a year's consumption, of which we took away as much as we could, destroyed the remainder, and burnt the village. I should beg to draw the General's attention to the admirable behaviour of the men of all arms composing the force, who, because of the baggage not being able to follow us on account of the badness of the roads, had to remain the whole day and night in the rain, wet, hungry, and fatigued, bearing every privation with the utmost cheerful-My thanks are specially due to Seei Sooba Ram Rao, for the correctness of his information, and the great trouble he took to obtain it, and his indefatigable zeal in procuring supplies for the force. I may also add that, as usual, he kept in front with the skirmishers. I ought to say that I sent I ought to say that I sent a copy of the terms offered, to Adil Mahomed, and that he ordered my messengers to be beheaded; they managed, however, to escape, with the loss of their horses, and returned to me late on the night of the 22nd. In fact, I set out for the attack in less than two hours after their return. I enclose a casualty list.
