would consist of demands and pretensions put forward by some and resisted by others; and, there being no supreme authority in such an assembly to enforce the decisions of the majority, the Congress would probably separate, leaving many of its members on worse terms with each other than they had been when they met. But if this would be the probable result, it follows that no decrease of armaments is likely to be effected by the proposed Congress. M. Drouyn de L'Huys refers to a proposal made by Lord Clarendon in one of the last sittings of the Congress of Paris. But Her Mejesty's Government understand that proposal to have reference to a dispute between two Powers to be referred to the good offices of a friendly Power, but in no way to the assembling of a General Congress.

Not being able, therefore, to discern the likelihood of those beneficial consequences which the Emperor of the French promised himself when proposing a Congress, Her Majesty's Government, following their own strong convictions, after mature deliberation, feel themselves unable to accept

His Imperial Majesty's invitation.
