WHEREAS it appears to me, the Right Honourable Sir George Gray, Baronet, one of Her Majesty's Principal Secretaries of State, that the use of locomotives, unless restricted as hereinafter mentioned on or along the Redcross and Stumpcross turnpike roads, in the county of Cambridge, is dangerous and inconvenient to the public:

I do hereby, by virtue of the provisions of the "Locomotive Act, 1861," by this order under my hand, prohibit the use of any kind of locomotive whatever propelled by steam or any other than animal power on the above roads, except between the hours of twelve o'clock at night and six o'clock in the morning.
