Alguada Reef Light.

WITH reference to the Notice to Mariners No. 27, dated from this office the 12th day of June, 1865, giving the particulars of a light established on the Alguada Reef, the following further details have been received from the Government of India:-

The light is a revolving white light, attaining its greatest brilliancy every minute. It is 144 feet above the level of high water, and in clear weather is visible, from the poop of a large vessel, at a distance of 20 miles.

The illuminating apparatus is dioptric or by lenses, of the first order.

uninfluenced by the wind, set across the reef, and with much strength between it and the Phaeton shoal. Vessels, therefore, should not stand nearer than 20 fathoms water on the north-west side, as it shoals suddenly, especially towards the southwest part of the rocks. On the southern and eastern sides 15 fathoms will be a safe depth to approach.

There is a good channel north of Alguada Reef, between it and the Phaeton shoal; but the navigation must always be attended with some risk to those unacquainted with it, there being no plain marks that can be given as a safe and sure guide through. Should, however, circumstances compel a vessel to go through the northern channel, it will be well to borrow on the Alguada Reef, passing about half a mile distant from the north-eastern visible rock, but not in a less depth than 11 fathoms. Should it be high water the breakers will show the rocks.

On the eastern side of the reef, vessels may know they are clear of danger by keeping the high land of Heingyee or Negrais Island well open eastward of Diamond Island.

Cape Negrais bears from the lighthouse, N. W.; the Pagoda on Pagoda Point, N. 3 E.; Porian Point, N.E. by E.; and the centre of Diamond Island, N.N.E.
