WHEREAS by an Order bearing date the VV twenty-ninth day of January last, reciting certain provisions of the Act passed in the session of the eleventh and twelfth years of Her present Majesty's reign, chapter one hundred and seven, intituled "An Act to prevent, until the first day " of September, one thousand eight hundred and " fifty, and to the end of the then session of Par-" liament, the spreading of contagious or infectious " disorders among sheep, cattle, and other animals," and the appearance and prevalence of the Cattle Plague in some parts of England, and the regulations contained in a certain Order of the Lords of the Council, bearing date the twenty-fourth day of March, one thousand eight hundred and sixtysix, relating to cattle brought by sea from any place out of the United Kingdom into any town or place in England, and the existence of a certain market held for the sale of cattle in the parish of Saint Mary, Islington, in the county of Middlesex, which had been licensed by the Lords of the said Council for the sale of cattle for immediate slaughter, the Lords of the said Council did order that, from and after the date thereof, cattle brought by sea from any place out of the United Kingdom to and landed in the Southampton Docks, in the port of Southampton, in the town and county of that name, might be removed by railway to such market for the purpose of being sold therein for immediate slaughter, subject to certain regulations in the said Order set forth:

And whereas it is expedient that the said Order should be rescinded:

Now, therefore, the Lords of the said Council do hereby order that from and after the thirtieth day of September, one thousand eight hundred and sixty-seven, the said Order shall be rescinded, land, and the existence of a certain market held

provided that nothing herein contained shall affect any Act depending upon the said Order commenced and not now concluded or the prosecution or punishment of any offence against the said Order not yet punished :

And they do further order that this Order shall be published by the Local Authority of the said town and county of Southampton by advertisement in some newspaper circulating in the said town, and by affixing a copy thereof at some conspicuous place in the said docks, and at the principal railway station adjoining thereto.
