It is particularly requested, that in every case the names be *very distinctly written* upon the cards to be delivered to the Lord Chamberlain, in order that there may be no difficulty in announcing them to His Royal Highness.

The Queen, taking into Her Royal consideration that upon the decease of Beaumont, Baron Hotham, in the Peerage of that part of the United Kingdom called Ireland, unmarried, on the twelfth day of December last, the title and dignity of Baron Hotham devolved upon his nephew Charles, now Baron Hotham, as the eldest surviving son and heir of George Frederick Hotham, commonly called the Honourable George Frederick Hotham, Rear-Admiral in the Navy, deceased, the next brother of the said Beaumont, late Baron Hotham, and that according to the ordinary rules of honour the brother and sister of the said Charles, now Baron Hotham, cannot enjoy that place and precedence which would have been due to them in case their said late father had survived the said

Beaumont, late Baron Hotham, and had thereby succeeded to the title and dignity of Baron Hotham, Her Majesty has been graciously pleased to ordain and declare that John Hotham, Esquire, and Susan Frances Hotham, Spinter, brother and sister of the said Charles, now Baron Hotham, shall henceforth have, hold, and enjoy the same title, place, pre-eminence, and precedence as if their late father the said George Frederick Hotham had survived his brother the said Beaumont, late Baron Hotham, and had thereby succeeded to the said title and dignity of Baron Hotham:

And to command that the said Royal order and declaration be registered in Her Majesty's College of Arms.
