WHEREAS by Section 23 of the Public Health Act, 1872, that the Local Government Board are empowered, on the application of the authority of any Rural Sanitary District, by Order, to be published in the London Gazette, or in such other manner as they may direct, to invest such authority with all or any of the powers, rights, duties, capacities, liabilities, and obligations of an Urban Sanitary Authority; and that such investment may be made, either unconditionally or subject to any conditions to be specified by the Board as to the time, portion of district, or manner during, at, and in which, such powers, rights, duties, capacities, liabilities, and obligations are to be exercised and attach:

And whereas the Guardians of the Poor of the Prestwich Union, in the county of Lancaster, being the Rural Sanitary Authority for that Union, have applied to the Local Government Board to issue an Order investing them, as such Sanitary Authority, with certain of the powers, rights, duties, capacities, liabilities, and obligations of an Urban Sanitary Authority:
